

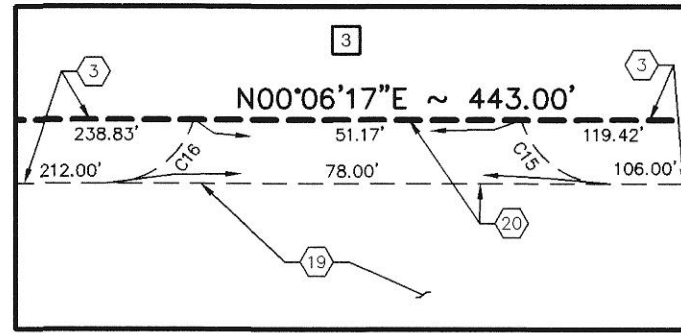
LOCATION MAP

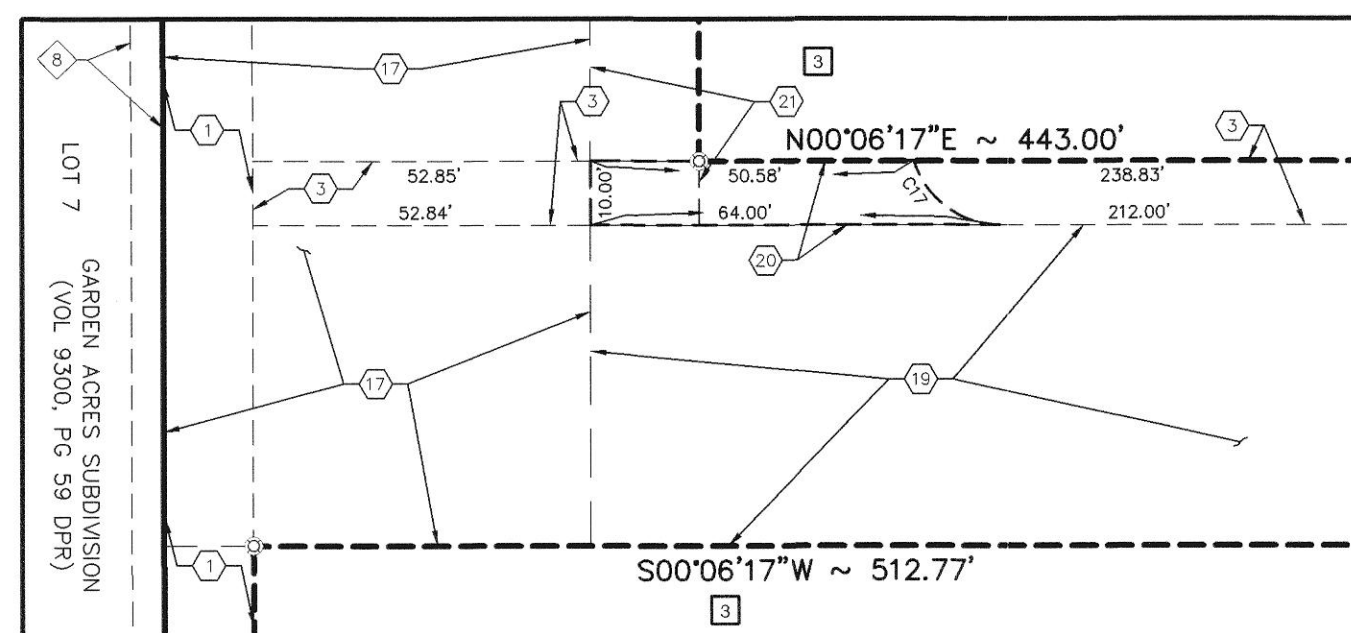
