THENCE, along the east line of said 100 acre tract, North 15° 30′ 21″ East, 1993.89 feet to a point for the northwest corner of the herein described tract;

THENCE, across said 160.522 acre tract, the following courses:

North 60° 39′ 00″ East, 352.76 feet to a point,

South 74° 21' 00" East, 358.28 feet to a point,

South 15° 39' 00" West, 257.36 feet to point,

South 45° 39′ 00″ West, 660.00 feet to a point,

South 15° 39′ 00″ West, 1140.64 feet to a point,

South 74° 21' 00" East, 227.72 feet to a point, and

South 15° 34' 27" West, 273.08 feet to a point on the north line of said Green Road;

North 74° 17' 01" West, 695.04 feet to a 1/2" iron rod found (RPLS 4540),

North 74° 25' 23" West, 50.27 feet to a 1/2" iron rod found (RPLS 4540),

North 74° 18' 06" West, 305.13 feet to a 1/2" iron rod found,

North 74° 27' 28" West, 302.67 feet to a 1/2" iron rod found,

North 74° 24' 01" West, 260.45 feet to a 1/2" iron rod found, and

North 74° 24′ 33" West, 98.69 feet to a point and the southwest corner of herein described tract;

THENCE, across said 160.523 acre tract, the following courses:

North 15° 34' 27" East, 273.08 feet to a point,

North 60° 39' 00" East, 1011.16 feet to a point,

South 74° 21′ 00" East, 698.28 feet to a point,

South 15° 39' 00" West, 779.00 feet to a point, and

South 74° 21′ 00″ East, 299.56 feet to a point on the common west line of said 2.363 acre tract for a northeast corner of the herein described tract;
