**ORDINANCE**

**AUTHORIZING A PROFESSIONAL SERVICES CONTRACT WITH  
AETNA LIFE INSURANCE COMPANY TO PROVIDE OR ARRANGE  
HEALTH SERVICES FOR MEDICARE-ELIGIBLE RETIREES AND  
ELIGIBLE DEPENDENTS FOR A THREE-YEAR TERM BEGINNING  
JANUARY 1, 2021 AND ENDING DECEMBER 31, 2023, WITH TWO ONE  
YEAR RENEWAL OPTIONS FOR AN ESTIMATED ANNUAL COST OF  
\$875,846.00.**

**WHEREAS**, the City issued a Request for Proposals (RFP) for retiree health services; and

**WHEREAS**, a committee including the City Manager's Office, Human Resources, as well as retiree representatives evaluated the proposals received, and recommends Aetna Life Insurance Company as the best able to provide the requested services based on the following criteria: experience, background and qualifications, proposed plan; proposed price and local preference; and

**WHEREAS**, as a result of this process, a contract will be recommended that provides for Medicare health services for retirees and eligible dependents through Medicare Advantage Plans as well as a pharmacy only option; and

**WHEREAS**, said Contract provides for an initial 36-month term, expiring on December 31, 2023; and

**WHEREAS**, the estimated annual cost of this contract is \$875,846.00; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee is hereby authorized to execute the contract with Aetna Life Insurance Company to provide retirees and their eligible dependents with Medicare health services at an estimated annual cost of \$875,846.00. A copy of the Medicare Advantage Contract in final form is attached hereto and incorporated herein as **Exhibit "A"**. The terms of the Contract are hereby approved.

**SECTION 3.** This Ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise, it shall be effective on the tenth day after passage hereof.
