## ORDINANCE 2020-08-13-0521

AUTHORIZING THE CLOSURE, VACATION, AND ABANDONMENT OF AN IMPROVED PORTION OF DANBURY STREET PUBLIC RIGHT OF WAY LOCATED IN NEW CITY BLOCKS 12104 AS REQUESTED BY MEALS ON WHEELS FOR A FEE OF \$5,150.00 IN COUNCIL DISTRICT 10

**WHEREAS**, Meals on Wheels San Antonio ("Petitioner") is requesting to close, vacate and abandon an improved portion of Danbury Street Public Right-of-Way within New City Block 12104 in Council District 10, as shown on the attached **Exhibit A**; and

**WHEREAS**, the proposed closure is located between Nacogdoches Road and Petitioner's property; Petitioner will dedicate land to construct a hammerhead for turnaround traffic as shown on the attached **Exhibit B** wide enough to accommodate the turning radius of any fire apparatus; and

**WHEREAS**, if approved, Petitioner will replat the proposed closure with the dedication and its adjacent property to construct a new corporate headquarters on a 5.7 acre site with access gates operable by fire personnel; and

WHEREAS, Petitioner is an independent not-for-profit 501(c)3 organization that serves Bexar, Atascosa, and Frio counties; in 2019, the organization provided the community 1,021,757 fresh and nutritious meals, 29,025 pounds of pet food through AniMeals and 16,500 days of care through Grace Place; and

**WHEREAS**, per Chapter 37-11 under the Municipal Code, one sign was posted and letters were mailed to property owners within 500 feet notifying them of the proposed closure; and

WHEREAS, the City of San Antonio's Planning Commission recommended approval of this request at its regular meeting on July 22, 2020; and

WHEREAS, in compliance with Chapter 37 of the City Code, Section 37-2 of the City Code, fair market value of the proposed closure was based upon an independent State of Texas Certified Professional Appraisal Report prepared by Noble & Associates, Inc. on November 21, 2019 and the subject property was assessed at \$94,500.00; based on the organizations 501(c)(3) tax-exempt status and its mission benefiting the San Antonio senior community, staff in consultation with Council District 10 recommends the City of San Antonio collect a fee of \$5,150.00 for this closure and such funds will be deposited into the General Fund in accordance with the FY 2020 Adopted Budget; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1**. The City Council hereby authorizes, for a requested Final Closure Fee of \$5,150.00, the closure, vacation, and abandonment of the City's right-of-way interests as to an improved portion of Danbury Street Public Right-of-Way within New City Block 12104 in Council District 10 as shown and described in **Exhibit A**.

**SECTION 2.** All exhibits are incorporated into this Ordinance for all purposes as if they were fully set forth.

**SECTION 3**. Funds generated by this ordinance will be deposited into Fund 11001000, Internal Order 223000000253, and General Ledger Account 4903101.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 5**. This ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.




