APPROVING THE SUBMISSION AND ACCEPTANCE OF A GRANT IN AN AMOUNT UP TO \$700.00 FROM THE TEXAS HISTORICAL COMMISSION FOR PARTICIPANT REGISTRATIONS FOR THE NATIONAL ALLIANCE OF PRESERVATION COMMISSION'S FORUM 2020 CONFERENCE.

WHEREAS, the Texas Historical Commission offers stipends for individuals from Certified Local Governments in Texas to attend the FORUM 2020 conference; and

WHEREAS, FORUM 2020 is the National Alliance of Preservation Commissions' biennial training program for local preservation boards and commissions and will provide City staff valuable training related to staffing the City's Historic and Design Review Commission; and

WHEREAS, City staff from the Office of Historic Preservation has been selected to present at two sessions during the conference; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Office of Historic Preservation or designee, is authorized to submit a grant application and to accept grant funds in an amount up to \$700.00 from the Texas Historic Commission for travel stipends to the National Alliance of Preservation Commission's FORUM 2020 Conference on August 3-9, 2020 for a term beginning June 1, 2020 and ending September 30, 2020. A copy of said application is on file with the Office of Historic Preservation.

SECTION 2. The City Manager or designee, or the Director of the Office of Historic Preservation or designee, is further authorized to execute any and all necessary documents to effectuate said application and acceptance.

SECTION 3 Upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount not to exceed \$700.00 will be appropriated in said funds. A final budget, including Internal Orders and GL Accounts, will be submitted by the Office of Historic Preservation upon award.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
