## ORDINANCE 2020-08-13-0534

AWARDING SIX ON-CALL CIVIL ENGINEERING SERVICES **AGREEMENTS** WITH BGE, INC., **CAMACHO-HERNANDEZ** ASSOCIATES, L.L.C., CP&Y, INC., DON DURDEN, INC. DBA CIVIL ENGINEERING CONSULTANTS, FREESE AND NICHOLS, INC., AND PAPE-DAWSON CONSULTING ENGINEERS, INC. EACH IN AN AMOUNT NOT TO EXCEED \$4,500,000.00 TO PROVIDE NEEDED ON-CALL CIVIL ENGINEERING SERVICES, PROGRAM MANAGEMENT SERVICES, CONSTRUCTION INSPECTION SERVICES, CONSTRUCTION ENGINEERING SERVICES, EXPANDED CONSTRUCTION MANAGEMENT SERVICES, AND TRAINING SERVICES.

WHEREAS, this Ordinance approves the negotiation and execution of six (6) On-Call Civil Engineering and Program Management Services Agreements to allow for expedited delivery of capital projects and provides a cost savings to the City based on negotiated rates for a larger volume of work; and

**WHEREAS**, the six On-Call Civil Engineering Services Agreements will provide all aspects of civil engineering and program management to include street and roadway design, drainage design, site layouts, surveying, architectural or structural design, special projects, engineering services, staff augmentation for inspection services, and training programs for City staff; and

**WHEREAS,** in March 2020 City released a Request for Qualifications (RFQ) for On-Call Civil Engineering and Program Management; and

**WHEREAS**, the City received thirty-seven Statements of Qualifications (SOQ) in response to the solicitation and a selection committee made up of City's Public Works Department and the San Antonio Water System evaluated and ranked the submissions; and

WHEREAS, this Ordinance authorized the negotiation and execution of six (6) On-Call Civil Engineering and Program Management Services Agreements with BGE, Inc., Camacho-Hernandez & Associates, L.L.C., CP&Y, Inc., Don Durden, Inc. dba Civil Engineering Consultants, Freese and Nichols, Inc. and Pape-Dawson Consulting Engineers, Inc. each in the amount not to exceed \$4,500,000.00; NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager, or designee, is authorized to negotiate and execute of six (6) On-Call Civil Engineering and Program Management Services Agreements with BGE, Inc., Camacho-Hernandez & Associates, L.L.C., CP&Y, Inc., Don Durden, Inc. dba Civil Engineering Consultants, Freese and Nichols, Inc. and Pape-Dawson Consulting Engineers, Inc. each in the amount not to exceed \$4,500,000.00 to provide as needed civil engineering services, program

management services, construction inspections services, construction engineering services, expanded construction management services and training services.

- **SECTION 2.** Funding for this Ordinance will be identified when work orders are issued. If funding for any work orders is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating, Grants, and/or Capital Budget funding sources identified. All expenditures will comply with Operating, Grants, and/or Capital Budgets for current and future fiscal years.
- **SECTION 3.** Negotiation and execution of an on-call civil engineering and program management services agreement with BGE, Inc. is authorized in an amount not to exceed \$4,500,000.00.
- **SECTION 4.** Negotiation and execution of an on-call civil engineering and program management services agreement with Camacho-Hernandez & Associates, LLC is authorized in an amount not to exceed \$4,500,000.00.
- **SECTION 5.** Negotiation and execution of an on-call civil engineering and program management services agreement with CP&Y, Inc. is authorized in an amount not to exceed \$4,500,000.00.
- **SECTION 6.** Negotiation and execution of an on-call civil engineering and program management services agreement with Don Durden, Inc. dba Civil Engineering Consultants is authorized in an amount not to exceed \$4,500,000.00.
- **SECTION 7.** Negotiation and execution of an on-call civil engineering and program management services agreement with Freese and Nichols, Inc. is authorized in an amount not to exceed \$4,500,000.00.
- **SECTION 8.** Negotiation and execution of an on-call civil engineering and program management services agreement with Pape-Dawson Consulting Engineers, Inc. is authorized in an amount not to exceed \$4,500,000.00.
- **SECTION 9.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.
- **SECTION 10.** This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
