APPROVING A CONTRACT WITH MUNICIPAL EMERGENCY SERVICES, INC., TO PROVIDE THE SAN ANTONIO FIRE DEPARTMENT WITH 54 TOXIRAE PRO LEL SENSORS AND EIGHT CALIBRATION STATIONS FOR THE DETECTION OF FLAMMABLE OR EXPLOSIVE GASES DURING FIRST RESPONSE FOR A TOTAL COST OF \$52,721.72. FUNDING IS AVAILABLE IN THE 2018 URBAN AREA SECURITY INITIATIVE GRANT.

WHEREAS, bids were submitted to provide the San Antonio Fire Department with 54 ToxiRaE Pro LEL sensors and eight calibration stations; and

WHEREAS, these detectors will allow all front line engine companies to be able to detect flammable or explosive gases during emergency responses; and

WHEREAS, Municipal Emergency Services, Inc., submitted the low bid for a total cost of \$52,721.72; and

WHEREAS, Funding is available from the 2018 Urban Area Security Initiative Grant; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Municipal Emergency Services, Inc., for a total cost of \$52,721.72 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheet is attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Grant funding is available in General Ledger 5501055, Internal Order Number 12000000162, and Fund 2206520006 entitled "PRND Grant 2017" for a total amount of \$52,721.72.

SECTION 3. Payment not to exceed the budgeted amount is authorized to Municipal Emergency Services, Inc., to provide the San Antonio Fire Department with 54 ToxiRaE Pro LEL sensors and eight calibration stations upon issuance of a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.
