ORDINANCE

APPROVING A HIGH VOLUME PET PARTNER CONTRACT WITH SAN ANTONIO PETS ALIVE! IN AN AMOUNT NOT TO EXCEED \$330,750.00 FOR THE RESCUE OF UP TO 4,410 QUALIFYING ANIMALS FROM THE CITY'S ANIMAL CARE SERVICES FACILITY, FOR A ONE-YEAR TERM WITH THE OPTION TO RENEW FOR UP TO THREE (3) ONE-YEAR TERMS; AND AUTHORIZING THE DIRECTOR OF THE ANIMAL CARE SERVICES DEPARTMENT TO MODIFY FUNDING TO ADJUST THE NUMBER OF QUALIFYING ANIMALS RESCUED AND THE AMOUNT PAID PER QUALIFYING ANIMAL.

WHEREAS, in 2012, the City of San Antonio ("City") implemented a High Volume Pet Partner ("HVPP") program to create partnerships with animal rescue groups for rescue and placement of additional pets impounded at the City's Animal Care Services ("ACS") facility; and

WHEREAS, this initiative has been key for increasing the City's animal live release rate from 31% in Fiscal Year 2011, to a record high 91.6% in Fiscal Year 2018, and since maintained at over 90%; and

WHEREAS, since Fiscal Year 2012, San Antonio Pets Alive! (SAPA!) has rescued over 38,000 pets from ACS as part of the HVPP program and often facilitates pet adoptions for animals at risk of euthanasia; and

WHEREAS, the proposed HVPP contract with SAPA! in an amount not to exceed \$330,750.00 is for a one-year term with the option to renew for up to three (3) one-year terms, and provides for rescue services of a maximum of 4,410 dogs or cats from ACS per term at a rate of \$75 per qualifying animal, allows SAPA! to pull animals within their stray-hold period; and authorizes the Director of the Animal Care Services Department to modify funding to adjust the number of qualifying animals rescued and the amount paid per qualifying animal; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee or the Director of the Animal Care Services Department (ACS) or designee is authorized to execute a High Volume Pet Partner contract with San Antonio Pets Alive!, in an amount not to exceed \$330,750.00 for the rescue of up to 4,410 animals from the City's Animal Care Services facility, for a one-year term with the option to renew for up to three (3) one-year terms. A copy of the contract in substantially final form is attached and incorporated for all purposes as **Attachment I**.

SECTION 2. [FINANCIAL LANGUAGE PENDING]

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
