WHEREAS, the City has had sufficient opportunity to obtain a response from the Applicant regarding any questions or concerns about the proposed Development; and

WHEREAS, upon said hearing and after due consideration of the information provided by the Applicant and public comment, the City Council shall provide a Resolution of No Objection as required by the TDHCA 2021 or 2022 Housing Tax Credit Application for the Development; NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. 776In accordance with the requirements of Texas Government Code §2306.67071 and Texas Administrative Code §10.204(4), the City hereby certifies and finds that:

- (i) Notice has been provided to the City in accordance with Texas Government Code §2306.67071(a); and
- (ii) The Governing Body has had sufficient opportunity to obtain a response from the Applicant regarding any questions or concerns about the proposed Development; and

- (iii) The Governing Body has held a hearing at which public comment may be made on the proposed Development in accordance with Texas Government Code, §2306.67071(b); and
- (iv) After due consideration of the information provided by the Applicant and public comment, the Governing Body does not object to the proposed Application.

SECTION 2. The City hereby confirms that it does not object to the Application to the Texas Department of Housing and Community Affairs (TDHCA) for the proposed The Crosswinds (the "Development"), to be located at approximately 4000 N. Loop 1604 East in the City of San Antonio, Texas.

SECTION 3. The City Council of the City of San Antonio, Texas has voted to specifically allow the construction of the 312-unit affordable multi-family rental housing development named The Crosswinds (the "Development"), to be located at approximately 4000 N. Loop 1604 East in the City of San Antonio, Texas and to authorize an allocation of Housing Tax Credits for the Development.
