AUTHORIZING THE AVIATION DEPARTMENT TO SUBMIT AN APPLICATION TO HOST "ROUTES AMERICAS 2022" WITH INFORMA MARKETS (UK) LTD., FOR A HOSTING BID OF \$443,000.00 WITH FUNDING FOR THE INITIAL \$150,000.00 PAYMENT AVAILABLE FROM THE FY 2020 AIRPORT OPERATING AND MAINTENANCE FUND BUDGET AND THE REMAINING \$293,000.00 INCLUDED IN THE FY 2021 AIRPORT OPERATING AND MAINTENANCE FUND PROPOSED BUDGET.

WHEREAS, Routes America is the premier air service conference that attracts up to 1,200 delegates from domestic and international airlines, airports and tourism industries; and

WHEREAS, the City of San Antonio was selected by Informa Markets, Ltd. to host the Routes Americas 2022 Conference; and

WHEREAS, this action will authorize payment of \$443,000.00 for the hosting fee for the event and authorize execution of an agreement with Informa Markets, Ltd. to host the event; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee is authorized to execute an Agreement with Informa Markets, Ltd. in the not to exceed amount of \$443,000 to host the Routes Americas 2022 Conference in San Antonio, a copy of which is set out in **EXHIBIT 1.**

SECTION 2. Funding in the amount of \$150,000.00 for this ordinance is available in Fund 51001000, Cost Center 3305010004 and General Ledger Account 5207510 as part of the Fiscal Year 2020 Budget adopted by City Council.

SECTION 3. Additional funding in the amount of \$293,000.00 for this ordinance is contingent upon City Council approval of the Fiscal Year 2021 Budget.

SECTION 4. Payment in the amount up to \$443,000.00 is authorized to Informa Markets (UK) Limited and should be encumbered with a purchase order. Payment is limited to availability of funds.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.
