## ORDINANCE 2020-09-10-0634

APPROVING THE SETTLEMENT OF A LAWSUIT STYLED BLANCA IDALIA DEGOLLADO AND PRISCILLA DEGOLLADO V. CITY OF SAN ANTONIO, CAUSE NO. 2019-CI-04653 PENDING IN THE 57TH JUDICIAL DISTRICT COURT, BEXAR COUNTY, TEXAS IN THE AMOUNT OF \$275,000.00.

WHEREAS, an auto accident occurred on April 5, 2018 at SW Military Drive and Pleasanton Road involving a vehicle occupied by Blanca Idalia Degollado and Priscilla Degollado and a City owned vehicle being operated by an employee of the City's Solid Waste Management Department; and

**WHEREAS**, as a result of this accident, both Blanca Idalia Degollado and Priscilla Degollado suffered injuries, incurred medical expenses and are seeking to recover damages; and

**WHEREAS**, although the City of San Antonio has vigorously contested this matter, it is in the City's best interest to settle this matter to avoid the uncertainties and risks associated with further litigation; and

WHEREAS, the parties have reached an agreement to settle the claims of Ms. Blanca Idalia Degollado for the amount of \$200,000.00 and Ms. Priscilla Degollado for the amount of \$75,000.00 payable from the Self-Insurance Liability Fund subject to City Council approval; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The amount of \$275,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020001 Risk Management-Liability, and is authorized to be made payable as follows: \$200,000.00 will be paid to plaintiff Blanca Idalia Degollado and \$75,000.00 will be paid to plaintiff Priscilla Degollado and their attorney of record as settlement of Cause Number 2019-CI-04653 styled Blanca Idalia Degollado and Priscilla Degollado v. City of San Antonio.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
