AWARDING A TASK ORDER CONSTRUCTION CONTRACT TO E-Z BEL CONSTRUCTION, LLC IN AN AMOUNT NOT TO EXCEED \$1,730,928.50 FOR NEIGHBORHOOD TRAFFIC CALMING CONSTRUCTION AND OTHER MISCELLANEOUS TRAFFIC RELATED PROJECTS.

WHEREAS, the FY 2021 Budget approved on September 17, 2020, approved \$1 million for citywide Neighborhood Traffic Calming Program and \$219,900.00 for each City Council District Office for the Neighborhood Access Mobility Program (NAMP); and

WHEREAS, the Neighborhood Traffic Calming program includes funding for materials such as illuminated traffic signs and equipment such as speed limit feedback trailers as well as engineering services including consultant design for projects, evaluation and construction; and

WHEREAS, NAMP includes funding for the design and construction of speed humps, flashing beacon installation, sidewalk repair and installation, curb ramp construction and other localized traffic calming and mobility infrastructure improvements; and

WHEREAS, this task order contract will be utilized on an as-needed basis to construct traffic calming projects identified as part of the Neighborhood Traffic Calming Program and will allow for staff to efficiently implement projects currently in design to be funded for construction within the next fiscal year; and

WHEREAS, this contract will also provide capacity to implement projects of similar scope identified in other infrastructure programs such as NAMP; and

WHEREAS, work activities will be allocated in the form of task orders as availability of funds are identified; and

WHEREAS, the use of this task order contract allows for expedited delivery of capital projects and provides a cost savings to the City based on negotiated rates for a larger volume of work; and

WHEREAS, this FY 2021 - 2022 Task Order Contract for Traffic Calming was advertised on July 15, 2020, and two bids were received and opened on August 7, 2020; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in an amount not to exceed \$1,730,928.50 for neighborhood traffic calming construction and other miscellaneous traffic related projects located throughout the City; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by E-Z Bel Construction, LLC in an amount not to exceed \$1,730,928.50 to E-Z Bel Construction, LLC for neighborhood traffic calming construction and other miscellaneous traffic related projects, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates.

SECTION 2. Funding for this Ordinance will be identified when work orders are issued. If funding for any work orders is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating, Grants, and/or Capital Budget funding sources identified. All expenditures will comply with Operating, Grants, and/or Capital Budgets for current and future fiscal years.

SECTION 3. Payment not to exceed \$1,730,928.50 is authorized to be encumbered with a purchase order and made payable to E-Z Bel Construction, LLC for neighborhood traffic calming construction and other miscellaneous traffic related projects.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
