## **ORDINANCE**

AWARDING A CONSTRUCTION CONTRACT TO DAVILA CONSTRUCTION, INC. FOR THE O. P. SCHNABEL PARK ENTRANCE & BRIDGE PROJECT, IN AN AMOUNT NOT TO EXCEED \$684,340.16 OF WHICH \$235,232.96 WILL BE REIMBURSED BY SAN ANTONIO WATER SYSTEM.

WHEREAS, in May 2017 voters approved the 2017 Bond Program which authorized \$1,100,000.00 for roadway and drainage improvements associated with the O. P. Schnabel Park Entrance & Bridge project located in Council District 7; and

WHEREAS, this project will reconstruct the roadway to install a bridge culvert near the O.P. Schnabel Park entrance to reduce drainage issues, enhance safety and access; and

WHEREAS, the City advertised for construction bids on July 29, 2020, and received and opened eight bids on September 1, 2020; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by Davila Construction, Inc. in the amount of \$684,340.16 for the O. P. Schnabel Park Entrance & Bridge project; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The lowest responsive bid submitted by Davila Construction, Inc. in the amount not to exceed \$684,340.16 for the O. P. Schnabel Park Entrance & Bridge project, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates.

**SECTION 2.** Payment is authorized to be encumbered and made payable to Davila Construction, Inc. in an amount not to exceed \$684,340.16. Payment is in support of the O.P. Schnabel Park Entrance & Bridge Project, using Fund 45099000, with the WBS Elements and GL Accounts in the table below. Funding for this project is provided by GO Bonds and is in the FY2021-FY2026 CIP Budget. Reimbursement of \$235,232.96 will be received from SAWS.
