APPROVING THE CLOSURE, VACATION, AND ABANDONMENT OF AN IMPROVED 56-FOOT WIDE DRAINAGE PUBLIC RIGHT-OF-WAY LOCATED WITHIN NEW CITY BLOCKS 13631 AND 14527 AS REQUESTED BY H-E-B, LP IN COUNCIL DISTRICT 2 FOR A FEE OF \$63,100.00.

WHEREAS, Petitioner, H-E-B, LP., ("Petitioner") has requested close, vacate and abandon an improved 56-foot wide drainage public right-of-way within New City Blocks 13631 and 14527 in Council District 2 as shown in **Attachment I**; and

WHEREAS, the drainage public right-of-way closure consists of 1.523 acres (66,359 square feet) located between the H-E-B, LP San Antonio Retail Support Center (SARSC) at 4710 N. Pan Am Expressway to the south and the Lamplighter Mobile Home Park to the north; H-E-B, LP owns the property north of the drainage public right-of-way and intends to connect its properties and cover the channel by installing new drainage infrastructure with new concrete paving upon approval of this acquisition;

WHEREAS, Petitioner has indicated paving this area will provide improved vehicular circulation and trailer parking around its existing retail support buildings the closure will not impact drainage in the area since the intent will be to replace the existing grass-lined channel with a properly designed underground box culvert drainage system to meet current City of San Antonio drainage criteria; once the underground box culverts are designed and approved by the City of San Antonio, Petitioner intends to place concrete paving over the channel; and

WHEREAS, all the abutting property owners have consented to the closure; Lamplighter MHP LLC, has written a letter to relinquish the rights to purchase its portion of the 56-foot wide Drainage Public Right-of-Way; and **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, severally, are authorized to close, vacate, and abandon of an improved 56-foot wide drainage public right-of-way within New City Blocks 13631 and 14527 as described and depicted in **Attachment II** in Council District 2, as requested by H-E-B, LP, for a fee of \$63,100.00.

SECTION 2. All attachments to this ordinance are incorporated into it by reference for all purposes as if fully set forth. The City Manager, or designee, is further authorized to execute and deliver all other documents necessary or convenient to effect the transactions contemplated in the above agreement; and other to do all things necessary or convenient to effect uate the transaction.

SECTION 3. The disposition of property must be coordinated through the city's Finance Department to assure the removal of these assets into the City's financial records and to record the proper accounting transactions.

SECTION 4. Funds generated by this ordinance will be deposited in Fund 11001000, Internal Order 223000000253, and General Ledger Account 4903101.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.


