This Certificate of Exemption is executed and filed with the Finance Department as follows:

1. The undersigned is authorized to approve an exemption.
2. An exemption according to Section 252.022 of the Local Government Code exists. More specifically, the following event has occurred:

The main sanitary sewer line has been damaged at the Ella Austin Community Center. The line has breaks in two locations. As a result of the breaks, restrooms cannot be used as raw sewage would be released at the breaks resulting in unsanitary conditions and possible health risk. The damaged lines have required the Early Head Start Program and other operations at the center to close due to the lack of functioning restrooms. No programs can resume until the line is replaced.

3. Because the exemption stated above exists, the City of San Antonio intends to contract with AAA Auger Plumbing Services which will cost approximately \$ 58,200.00.
