CONSENTING TO A REQUEST FROM BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2, LOCATED WITHIN THE CITY'S EXTRA TERRITORIAL JURISDICTION, TO INCUR DEBT NOT IN EXCESS OF \$30,000,000.00, FOR THE CONSTRUCTION OF FIRE STATION 124, REPLACEMENT OF FIRE STATIONS 121 AND 125, AND REMODEL OF FIRE STATIONS 122 AND 123.

WHEREAS, in October of 2004, through Ordinance No. 97417, City Council approved an agreement with Bexar County, consenting to an election calling for the creation of Emergency Service District #2 (ESD #2) within the City's Extraterritorial Jurisdiction, so that the ESD #2 may provide fire suppression and emergency medical services to individuals residing within its boundaries; and

WHEREAS, an election was held, and ESD #2, in eastern Bexar County, was created; and

WHEREAS, the agreement contained conditions imposed on ESD #2, including the requirement for the district to seek the consent of the City when incurring debt exceeding \$20,000.00; and

WHEREAS, the district has asked for the City's consent for it to secure a loan not to exceed the amount of \$30,000,000.00 for the construction and improvement of fire stations and the purchase of fire fighting equipment; and

WHEREAS, the City is not required to assume any of the debt if the district defaults on the loan, but is required by state law to pay the district its pro-rata share of the debt if the City annexes all or part of the district before the debt is repaid; and

WHEREAS, City staff has reviewed the request and recommends that consent be granted; NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Consent is granted for ESD #2, in accordance with the terms of Texas Health & Safety Code, Chapter 775 and the Agreement for Approval of ESD #2, for the district to incur debt not in excess of \$30,000,000.00, for the purpose of constructing and improving of fire stations and purchasing of fire fighting equipment for use within the district's boundaries.

SECTION 2. The City Clerk is directed to forward a copy of this Resolution to the County Judge, Bexar County on behalf of the City.
