






- Ph 2, TW R cable work, started 17 Aug 202000. Anticipated complete mid-Nov



- FAA Grant award was not full amount requested. In discussions on way ahead
- Potential to award Alternates in later year (upon grant award)





Project Description: Install 15,355 linear feet of new 8 foot tall Perimeter Fence from Aero Sky to Air Star. Fence will be installed <u>+</u> 4 feet of existing Perimeter Fence. Sections include animal intrusion mitigation into the AOA. Work includes installation of two culvert extensions.

- Early to Mid Nov Start installing fence in pavement on East Cargo Ramp






Terminal B Gate Expansion (B9)

Add new passenger screening lane to security screening checkpoint; install new exterior egress stairs on north, east and west of Terminal; additional concessions and airline lounge buildouts and infrastructure alterations to existing switchgear/boiler to support Terminal power requirements

- TB Boiler relocate and PBB added to scope
- TB Boiler relocation options developed. Green field option determined to be best alternative
- Design page-turn reviews scheduled tentatively 3, 5 and 11 Nov







- Repackaged plans and specs received 31 Jul 2020. On hold for final updates and bid date determination



Taxiway H Reconstruction

Project Description: Reconstruct portions of Taxilane H to address pavement deterioration; address direct access issues between apron and Runway 13R-31L between Taxiway G and Taxilane H/Taxiway H; and enhance airfield aircraft movements to/from terminal areas to Runway 13R by extending Taxiway H from Taxiway B to Taxiway N.



Project Status

- Scoping meeting with FAA held 6 Aug 2020 to discuss future RE impacts to grant projects
- Negotiating scope with consultant to start design
- Did not receive discretionary grant funding for design
- IFE being prepared for negotiations
- Master Plan Airfield layout will be used as basis for design
- NEPA approval received from FAA 8 May 2020
