Please provide a brief narrative outlining your reasons for seeking appointment to this board or commission:	The recent COVID-19 pandemic shed a light on the pre-existing health disparities that exist in the United States and San Antonio was not spared. When we reach the other side of this pandemic these health inequities will not cease to exist and we really need to begin to address the systemic racism contributing to these injustices. In addition to home and food security, the other social determinant that heavily contributes to lack of health care access is access to transportation. Lack of transportation is the leading social determinant that affects the ability of community of colors to receive proper preventative medicine and is the main cause of missed or delayed health care appointments, increased health expenditures and overall poorer health outcomes. In fact each year, 25 of patients and 35 of veterans in San Antonio do not obtain timely medical care due to

	transportation issues. Transportation is a vehicle for wellness and as such I think it is very important that a voice from someone with a health care background be at the table when developing the strategy for our citys transportation system moving forward. Developing affordable and appropriate transportation options, walkable communities, bike lanes and other healthy transit options is also vital to boost the health of our city and economic recovery. Now more then ever transportation will serve as an economic tool to get people equal and equitable access to job opportunities. As a small business owner and through my involvement at the San Antonio Hispanic Chamber, I have a unique understanding of the role that transportation plays in helping to enhance the much needed workforce development and access to economic opportunity. At a time when we are prioritizing and establishing the path forward to rebuild the health of our community and to boost our local economy, we can not underestimate the importance of a comprehensive approach to transportation planning.
