

Vaccination Priorities




1)Monitor vaccine doses received and administered;

2)Expand access to mass vaccination clinics;

3)Ensure equity is at the heart of vaccine distribution;

4)Clearly communicate to the community where vaccine is available

Monitoring Doses as of 1/13/2021:



Bexar County

- Doses Received 154,500
- Hosp/Pharm Doses Administered: 62,078
- Mass Vax Doses given by 1-16: ~30,000
- Doses given, not yet reported: ~22,730
- Total doses remaining as of 1-16: ~39,000

Expand Mass Vaccination Locations




Four mass vaccination sites are operational in the San Antonio/Bexar County area:

- Wonderland Mall ~ 1600 doses per day
- Alamodome ~ 1,500 doses per day
- WellMed Cisneros Site ~ 1000 doses per day
- WellMed Lopez Center ~ 500 doses per day


