Please provide a brief narrative Key to the economic mobility of our residents is access to education and employment and I am committed to ensuring that San Antonians are prepared with the technical and life skills to secure employment that provides them and their families sustainable wages and a path to economic mobility. I grew up in the San Juan Homes on Zarzamora, in a low-income community, despite that I have been able to advance in my professional career due to having access to education and caring adults. The pandemic has particularly negatively impacted individuals in lowskill, low-wage jobs whose previous occupations may no longer be available. The data is compelling. The individuals most deeply impacted are those with lower educational attainment with 83 having some college or less and almost 63 having a high school equivalency diploma or less. And of these, the proportion of individuals 34 years old and younger account for almost half of all claimants at 47.8 with females most heavily impacted. The pandemic heightened the need to upskill low-wage workers in order for them to access pathways into better paying and more sustainable jobs of tomorrow. Mary C. Daly, president and CEO of the Federal Reserve Bank of San

Francisco, recently said, "we need to become evidence-based optimists and feed hope with intentionality." This resonated with me as, we at the SAEDF and SA Works, continue to work alongside chambers, non-profits, education, private and public sector partners to bring both HOPE and HELP to our community. I am committed to bringing my professional expertise and relationships with both workforce agencies and employers to ensure that residents access quality training that will prepare them to successfully enter hi-skill, hi-wage jobs that provide economic mobility to them and their families. For years, we have discussed the issues of intergenerational poverty, economic inequity and low educational attainment and this is our moment to positively influence change and opportunity. I am committed personally and professionally to ensuring that our residents are prepared to take on high-wage jobs that have shown resilience to the pandemic. This is our opportunity to competitively position San Antonio to recruit and grow high-wage jobs that will promote economic prosperity.
