In 2017, Irys Technologies, Inc, formerly known as Cityflag, Inc., won a contract with the city of San Antonio to integrate its mobile app into the customer relationship management system inside the government''s 311 call center. The City of San Antonio

serves a population of 1.5 million people. With an average of 70,000 calls per month, the City saw an opportunity for enhance citizen engagement. The mobile app provides access to services and leads directly to savings in time and resources. The City departments worked closely with Irys, to customize and implement the 311SA mobile app, which allows citizens to interact with the city by submitting service requests for concerns that need attention, while earning rewards. City services include pothole repair, graffiti removal, property maintenance concerns, and many more. Through the app, citizens are able to flag requests, attach photos, and provide supporting information for issues. 311SA is integrated with the Citys Customer Relationship Management system which allows the requests to go straight to the appropriate City department for evaluation and investigation. 311SA also has a social network feature, which allows sharing and voting on other users flags/requests. 311SA, launched in the city of San Antonio in August 2018, is creating a boost in civic participation. To date, over 40,000 San Antonio residents have started using the 311SA app, submitting over 85,000 requests, with 93 percent of cases resolved. Cost to implement project: \$40,800 with \$6,000 a year in maintenance.
