AMENDING THE LAND USE PLAN CONTAINED IN THE MIDTOWN REGIONAL CENTER, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF APPROXIMATELY 0.398 ACRES OF LAND LOCATED AT 220 AND 224 EAST COURTLAND PLACE LEGALLY DESCRIBED AS ON LOT 11 AND LOT 12, BLOCK 6, NCB 1726 FROM "NEIGHBORHOOD MIXED USE" TO "URBAN MIXED USE

WHEREAS, the Midtown Regional Center was adopted on June 6, 2019 by City Council as a component of the City's Comprehensive Master Plan adopted August 11, 2016; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on February 10, 2021 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Midtown Regional Center Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of approximately 0.398 acres of land located at 220 and 224 East Courtland Place, legally described as on Lot 11 and Lot 12, Block 6, NCB 1726, from "Neighborhood Mixed Use" to "Urban Mixed Use". All portions of land mentioned are depicted in **Attachment "I"** attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect April 10, 2021.
