WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** Arena District/Eastside Community Plan, A Component Of The Comprehensive Master Plan of the City, by changing the use of approximately 12.088 Acres of Land located at 3623 East Commerce Street, Legally described as 12.088 acres out of NCB 10578 from "Parks Open Space" and "Mixed Use" to "Mixed Use". All portions of land mentioned are depicted in **Attachment "I"** attached hereto and incorporated herein for all purposes.

**SECTION 2.** This ordinance shall take effect April 25, 2021.
