ORDINANCE

2021-04-15-0270 CONTAINED THE AMENDING THE LAND USE PLAN IN **EXTRATERRITORIAL JURISDICTION MILITARY PROTECTION AREA** PLAN, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY. BY CHANGING THE USE OF APPROXIMATELY 2.39 ACRES OF LAND GENERALLY LOCATED AT 25225 BOERNE STAGE RAOD, LEGALLY DESCRIBED AS LOT 8, BLOCK 1, CB 4704A FROM "LOW DENSITY RESIDENTIAL" TO "EMPLOYMENT FLEX/MIXED USE".

WHEREAS, the Extraterritorial Jurisdiction Military Protection Area Plan was adopted on September 19, 2019 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on March 24, 2021 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Extraterritorial Jurisdiction Military Protection Area Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of approximately 4.821 acres of land located at 25225 Boerne Stage Road, legally described as Lot 8, Block 1, CB 4704A, from "Low Density Residential" to "Employment Flex/Mixed Use". All portions of land mentioned are depicted in Attachment "I" attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect April 25, 2021.
