*Brief description of where or how the item(s) will be used: Vroozi, Inc. contract was awarded by Council ordinance on April 7, 2016 to provide the City with an integrated vendor hosted electronic catalog management solution for an amount not to exceed \$994,275.00 funded from Purchasing and General Services Fund. The initial term of the contract with Vroozi, Inc. was for a period of three years with two, one year renewal options. Contract is set to expire on March 31, 2021. A competitive RFCSP was released in 2015 for an initial award for a catalog management solution and Vroozi was the recommended solution for Citywide use with a vendor-hosted implementation. Vroozi, Inc. is the sole source provider of the Vroozi Catalog and Marketplace and Purchase Express solution ("smartOCI").									
This COE is for a new contract term with Vroozi for a four year term, to begin on April 1, 2021 - March 31, 2025.									
*Describe the performance functions proprietary to the item(s) requested and why they are necessary to accomplish the project:									
The Vroozi platform includes a comprehensive supplier catalog management tool to store and create hosted and punch-out compatible supplier catalogs for goods and services, a B2B e-commerce marketplace that connects with ERP systems such as SAP, a self-service supplier portal for creation and maintenance of catalog content, and a visual analytics and reporting solution. The Purchase Express product allows authorized users to create shopping lists/purchase requests from any device including laptops, tablets, and smart phones, which can be submitted for order fulfilment to authorized purchasing professionals. The platform is provides a digital marketplace for employees to purchase from negotiated and contracted supplier catalogs and collaborate with suppliers by exchanging purchasing information electronically and securely. There is no known product or software program that includes all of these components in one package, and the comprehensive
