APPROVING A CONTRACT WITH SIDDONS-MARTIN EMERGENCY GROUP, LLC, FOR ONE PIERCE VELOCITY CLASS B FOAM PUMPER TRUCK FOR THE SAN ANTONIO FIRE DEPARTMENT FOR A TOTAL COST OF \$881,412.00. FUNDING IN THE AMOUNT OF \$881,412.00 IS AVAILABLE FROM THE FY 2021 EQUIPMENT RENEWAL AND REPLACEMENT FUND BUDGET, PENDING A REQUEST FOR FEDERAL MANAGEMENT AGENCY FUND REIMBURSEMENT.

WHEREAS, an offer was submitted by Siddons-Martin Emergency Group, LLC, to provide the City of San Antonio Fire Department (SAFD) with one Pierce Velocity Class B foam pumper truck for a total cost of \$881,412.00, using the Houston Galveston Area Council (HGAC) contract number FS12-19; and

WHEREAS, the replacement Class B foam pumper truck will be utilized by SAFD for day-to-day emergency response use and is a primary response vehicle for the fire suppression division; and

WHEREAS, this purchase meets the requirements under the terms of the Houston Galveston Area Council of Governments Cooperative Purchasing Agreement adopted by the City of San Antonio on October 10, 1996 through Resolution No. 96-41-48; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by Siddons-Martin Emergency Group, LLC, to provide the City of San Antonio Fire Department with one Pierce Velocity Class B foam pumper truck for a total cost of \$881,412.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$879,412.00 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5709080 as part of the Fiscal Year 2021 Adopted Budget approved by City Council.

SECTION 3. Funding for this ordinance in the amount of \$2,000.00 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5201040 as part of the Fiscal Year 2021 Adopted Budget approved by City Council.
