APPROVING THE SUBMISSION OF AN FAA AIRPORT IMPROVEMENT PROGRAM GRANT APPLICATION AND ACCEPTANCE OF FUNDS FOR THE AIRFIELD IMPROVEMENTS PACKAGE 7 PROJECT IN THE AMOUNT OF \$14,396,190.00.

WHEREAS, the City regularly partners with the Federal Aviation Authority for continued Airport Improvement Program grant funding of eligible projects at the San Antonio International Airport; and

WHEREAS, the FAA has designated the City to receive \$14,396,190.00 for Airfield Improvements Package 7 which will fund various Taxiway and roadway projects not covered under the original base bid; and

WHEREAS, this project will cover five alternative bids included in Package 7, including costs for full-strength concrete Taxiway pavement, construction of asphalt shoulders along Taxiway, demolition of a portion of the temporary Taxiway bypass for conversion to a vehicle service road and new asphalt roadway connections; and

WHEREAS, due to the American Rescue Plan Act, this year's grant application to the FAA AIP can be for up to 100% for eligible project costs, with no financial matching funds coming from the City; and

**WHEREAS**, it is now necessary to authorize the submission of the grant application, acceptance of the grant, and execution of the grant acceptance documents associated with the FAA AIP grant for the project; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee, or the Director of the Aviation Department or designee is authorized to submit a grant application and accept funds for up to \$14,396,190.00 from the Federal Aviation Administration for the Airfield Improvements, Package 7 project. This action will amend the FY2021-FY2026 Capital Improvement Program.

**SECTION 2.** Upon approval of this ordinance, new funds and internal order numbers will be created, upon which the sum of up to \$14,396,190.00 from the FAA will be awarded and appropriated and a formal budget provided.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to

specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation

Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
