APPROVING THE SUBMISSION OF AN FAA AIRPORT IMPROVEMENT GRANT APPLICATION AND ACCEPTANCE OF FUNDS FOR DESIGN, ENGINEERING AND ENVIRONMENTAL WORK FOR THE RUNWAY 13R-31L SAFETY AREA IMPROVEMENTS PROJECT IN THE AMOUNT OF \$6,900,000.00.

WHEREAS, the City regularly partners with the Federal Aviation Authority for continued Airport Improvement Program grant funding for eligible projects at the San Antonio International Airport; and

WHEREAS, the FAA has designated the City to receive \$6,900,000.00, which will fund the Runway 13R-31L Safety Area Improvements Project; and

WHEREAS, the grant will provide for design and environmental work for enabling projects which address the Runway 13R-31L Runway Incursion Management location, including the reconstruction of a portion of Taxiway N north of Taxiway D, the intersection with Taxiway D and the reconstruction of the entire keel section and rehabilitation of the remainder of Runway 13R-31L and selected connecting Taxiways within the Runway Safety Area; and

WHEREAS, due to the American Rescue Plan Act, this year's grant application to the FAA AIP can be for up to 100% for eligible project costs, with no financial matching funds coming from the City; and

WHEREAS, it is now necessary to authorize the submission of the grant application, acceptance of the grant, and execution of the grant acceptance documents associated with the FAA AIP grant for the project; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Aviation Department or designee is authorized to submit a grant application and accept funds for up to \$6,900,000.00 from the Federal Aviation Administration for the Runway 13R-31L Safety Area Improvements projects. This action will amend the FY2021-FY2026 Capital Improvement Program.

SECTION 2. Upon approval of this ordinance, new funds and internal order numbers will be created, upon which the sum of up to \$6,900,00.00 from the FAA will be appropriated in said fund. A formal budget will also be provided once funds are awarded.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to

specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
