## RESOLUTION NO.

A RESOLUTION RECOMMENDING APPROVAL OF A STREET NAME CHANGE REQUEST TO CHANGE MULTIPLE STREET SEGMENTS WITHIN THE WORLD HERITAGE AREA LOCATED IN CITY COUNCIL DISTRICTS 3 AND 5, SAN ANTONIO, TEXAS.

WHEREAS, the City of San Antonio Development Services Department staff received a Street Name Change Application to change the name of "Mission Road" to "Roosevelt Park Drive"; and "Napier Avenue" to "Mission Road"; and "Mission Road" to "San Jose Drive"; and "Padre Drive" to "Mission Road"; and "Mission Parkway" to "Riverfront Parkway"; and "Acequia" to "Espada Road"; and "Ashley Road" to "Espada Road"; and "Villamain Road" to "Mission Road";

WHEREAS, Chapter 6 of the City Code of the City of San Antonio requires street name change requests to be considered by the Planning Commission of the City of San Antonio for a recommendation to the City of San Antonio City Council; and

WHEREAS, the City of San Antonio Development Services Department in accordance with Chapter 6 of the City Code of Ordinances notified all owners of real property along the segment of the street proposed for a name change; and

WHEREAS, the Planning Commission of the City of San Antonio held a public hearing on March 10, 2021, where they reviewed evidence and received public testimony regarding the proposed street name change;

NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF SAN ANTONIO THAT:

SECTION 1: The Planning Commission of the City of San Antonio recommends that the San Antonio City Council APPROVE the proposed street name change of "Mission Road" to "Roosevelt Park Drive"; and "Napier Avenue" to "Mission Road"; and "Mission Road" to "San Jose Drive"; and "Padre Drive" to "Mission Road"; and "Mission Parkway" to "Riverfront Parkway"; and "Acequia" to "Espada Road"; and "Ashley Road" to "Espada Road"; and "Villamain Road" to "Mission Road"; in City Council Districts 3 and 5 (Exhibit "A").






