**ORDINANCE**

**APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$1,622,172.70, INCLUDED IN THE RESPECTIVE DEPARTMENT'S FY 2021 ADOPTED BUDGET: (A) BG INTERPOOL, INC., FOR CHEMICAL TREATMENT AND MAINTENANCE FOR THE MAIN PLAZA FOUNTAINS; (B) VULCAN CONSTRUCTION MATERIALS, LLC, AND BRAUNTEX MATERIALS, INC., FOR READY MIX CONCRETE; (C) T & W TIRES, L.L.C., FOR TIRES FOR EMERGENCY VEHICLES; AND (D) OCLC, INC., FOR AUTOMATED CATALOGING SERVICES FOR THE SAN ANTONIO PUBLIC LIBRARY.**

**WHEREAS**, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

**WHEREAS**, the bid submitted by Brauntex Materials, Inc., for section III, failed to meet the City's specifications and/or requirements for ready mix concrete; and

**WHEREAS**, this ordinance approves contracts with (A) BG Interpool, Inc., for chemical treatment and maintenance for the Main Plaza fountains; (B) Vulcan Construction Materials, LLC, (Sections I and III) and Brauntex Materials, Inc., (Section II) for ready mix concrete; (C) T & W Tire, L.L.C., for tires for emergency vehicles; and (D) OCLC, Inc., for automated cataloging services for the San Antonio Public Library; and

**WHEREAS**, the contract with T & W Tire, L.L.C., for tires for emergency vehicles meets the requirements under the terms of the intergovernmental cooperative purchasing agreement entered into by the City of San Antonio by Ordinance No. 98797 on February 12, 2004; and

**WHEREAS**, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply;

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) BG Interpool, Inc., for chemical treatment and maintenance for the Main Plaza fountains; (B) Vulcan Construction Materials, LLC, (Sections I and III) and Brauntex Materials, Inc., (Section

II) for ready mix concrete; (C) T & W Tire, L.L.C., for tires for emergency vehicles; and (D) OCLC, Inc., for automated cataloging services for the San Antonio Public Library. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

**SECTION 2.** It has been found and declared that the bid submitted by Brauntex Materials, Inc., for section III, failed to meet the City's specifications and/or requirements for ready mix concrete.

**SECTION 3.** Funds will be encumbered upon issuance of purchase orders, and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2021 budget, and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

**SECTION 4.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
