## ORDINANCE 2021-05-13-0338

#### APPROVING THE SUBMISSION AND ACCEPTANCE OF A GRANT FROM THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE CONSTRUCTION PHASE OF THE NEW TAXIWAY E PROJECT AT STINSON MUNICIPAL AIRPORT IN THE AMOUNT OF \$1,896,000.00 WITH TXDOT'S SHARE OF \$1,706,400.00 AND THE CITY'S SHARE OF \$189,600.00 FROM THE STINSON REVOLVING FUND.

**WHEREAS,** the Aviation Division of Texas Department of Transportation and the Aviation Department have worked to develop a project at Stinson to design and construct a parallel taxiway, Taxiway E, to Runway 14/32 to enhance future development of the adjacent land and improve safety by reducing the runway crossing once the land is developed; and

**WHEREAS**, as a condition of the grant program, TXDOT will be authorized as the agent for the purpose of administering all funds for these improvements, selecting consultants and contractors and administering contracts necessary for implementation of these improvements; and

WHEREAS, this Ordinance authorizes the acceptance of a grant for the construction of the New Taxiway E project at Stinson in the amount of \$1,896,000.00 with the TXDOT's match in the amount of \$1,706,400.00 and the City's match in the amount of \$189,600.00 from the Stinson Revolving Fund; NOW THEREFORE:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee, or the Director of the Aviation Department, or designee is hereby authorized to submit and accept a grant application for an amount up to \$1,706,400.00 from the Texas Department of Transportation (TXDOT) for the construction of the New Taxiway E project at Stinson Municipal Airport. The City will provide a cash match of \$189,600.00 from the Stinson Revolving Fund. This ordinance appropriates funding, amends the FY 2021 - FY 2026 Capital Improvement Program and authorizes the execution of all necessary grant documents.

**SECTION 2.** Upon award, a new fund and internal order will be created for use in the accounting for the fiscal transaction in the acceptance of this grant and the amounts listed above totaling a sum not to exceed \$1,896,000.00 will be appropriated in said funds. A formal final budget which will include Internal Order numbers and General Ledger numbers will be submitted by the department upon award.

**SECTION 3.** Upon Acceptance of this \$1,896,000.00 award and appropriation of \$1,706,400.00 to New TXDOT Fund, IO 13300000xxxx(TXDOT), GL account 6102100 Interfund Transfer Out entitled Transfer to 33-00238-90-10-xx the amount of \$1,706,400.00 is authorized to be transferred to fund 51099000 Airport Capital Projects.

SECTION 4. The amount of \$189,600.00 is authorized to be transferred from Fund 51016000, Stinson Revolving Fund, WBS AV-00008-01-01-xx, GL account 6102100 Interfund Transfer out entitled to 33-00238-90-01 to Fund 51099000 Airport Capital Projects.

SECTION 5. The budget in SAP Fund 51099000 Airport Capital Projects, SAP Project Definition 33-00238 Stinson New Taxiway E, shall be revised by increasing the WBS Elements in the table below with GL Account 6101100 by the amount of \$1,896,000.00 and by increasing the WBS Elements and GL Accounts 5201xxx in the table below by the amount of \$1,896,000.00.

The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 7. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

## SALE OF 56.9 ACRES – DISTRICT 6



- \$3,053,000 purchase price is full fair market value determined by an independent appraiser.
- Property has remained vacant since City acquisition in 1995. City's Southwest Business & Technology Park Parcelization Plan calls for commercial & industrial uses.
- Majority of property is zoned I-1 with MAOZ-1 overlay. Residential uses are not permitted. JBSA has no objections to the buyer's plans.
