# ORDINANCE 2021 - 06 - 17 - 0 4 8 4

APPROVING AN AMENDMENT TO AN INTERLOCAL COOPERATION CONTRACT BETWEEN TEXAS STATE UNIVERSITY AND THE SAN ANTONIO POLICE DEPARTMENT FOR PARTICIPATION IN THE TOBACCO ENFORCEMENT PROGRAM, TO INCREASE THE REIMBURSEMENT TO THE POLICE DEPARTMENT BY \$25,000.00.

WHEREAS, Chapter 791 of the Texas Government Code, the Interlocal Cooperation Act, provides that local governmental entities may contract with entities of the State to provide governmental functions and services, including police protection and associated services, to protect public health; and

WHEREAS, the Texas School Safety Center at Texas State University contracts with counties and municipalities to enable local law enforcement agencies to enforce Chapter 161, Subchapter H of the Texas Health and Safety Code, to reduce the sale and distribution of tobacco products to persons under the age of 21 years; and

WHEREAS, in Ordinance No. 2020-12-10-0904 City Council approved a contract with Texas State University to reimburse the San Antonio Police Department for conducting on-site controlled buy/stings at a rate of \$125 per sting, up to a maximum of 800 separate buy/stings, for a maximum of \$100,000.00; and

WHEREAS, there is additional funding in the amount of \$25,000.00 available for the police department to conduct a total or 200 more buy/sting operations; NOW THEREFORE:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager and designee, and the Chief of Police and designee, are hereby authorized to execute the amendment to the interlocal agreement, as set forth in Exhibit A, with Texas State University, that is materially and substantively the same as the agreement set forth in Exhibit A. The terms and conditions of the amended interlocal agreement, which terminates on August 31, 2021, are hereby approved.

**SECTION 2.** Funding for this ordinance is not required in that there is no commitment or expenditure of funds, cash match, or in-kind match in connection with this agreement; any necessary expenses can be paid through the current San Antonio Police Department budget.

**SECTION 3.** Funds generated by this ordinance will be deposited in Fund 29817000, Internal Order 817000000024, and General Ledger Account 6301120.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage hereof.

This Amendment ("Addendum") to the existing agreement # TXST-IA-2021-6248-TSSC ("Agreement" or "Contract") amends or modifies and is hereby incorporated into the Agreement entered into by, and between, San Antonio Police Department. ("Contractor" or "Service Provider") and Texas State University on January 6, 2021 as follows:

**Increase** maximum number of buy/stings from **800** to **1000** at a rate of **\$125.00** per buy/sting. **Increase** contract not to exceed from **\$100,000.00** to **\$125,000.00**.

Addendum Controlling. Except as specifically modified and amended herein, all of the terms, provisions, requirements and specifications contained in the executed Agreement remain in full force and effect. In the event there is a conflict between the terms and conditions of the Agreement and this Addendum, this Addendum shall prevail.
