September 28, 2021 – Submit to Policy Council Chair for signature

September 29, 2021 – Certification Letter forwarded to Mayor for signature.

October 22, 2021 - Certification Due to Office of Head Start (OHS).

Approach:

Site Visits:

- Corrective Action will be completed on-site when possible.
- City of San Antonio Monitoring Staff will work with providers to correct findings and verify successful and adequate corrective action.
- Corrective action must be complete and finalized within 10 calendar days of receiving each review summary.
- Once all Corrective action is completed Head Start Administrator will sign Certification of Health and Safety Screener.

Governing Body:

- Head Start Policy Council Chair will review the Health and Safety Screener on **September 28, 2021** for signature.
- Certification Letter will be forwarded to the Mayor on **September 29, 2021** for signature.
- Certification of Health and Safety Screener will be submitted to OHS on October 22, 2021.
