# FINAL Meeting Minutes City Council A Session

The City Council convened in a Regular Meeting. The City Clerk took the Roll Call as follows:

Councilmember Medina moved to approve the Minutes for the January 29-30, 2014 City Council Meetings. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:

City Clerk Leticia M. Vacek administered the Oath of Office to Councilmember Cris Medina to serve as Mayor Pro Tem beginning March 31, 2014 through June 9, 2014.

# **POINT OF PERSONAL PRIVILEGE**

Councilmember Saldaña invited everyone to attend the Texas Alliance for Minorities in Engineering (TAME) Event. He stated that the event was being held to promote minorities into the Science, Technology, Engineering, and Math Fields. He noted that the Trailblazer Science on Wheels would be stationed in front of City Hall on Friday, March 28, 2014 at 11:00 am. He also mentioned that a Science Fair would be held the following day at Port San Antonio from 10:00 am to 2:00 pm.

# **CONSENT AGENDA ITEMS**

Items 16, 24, 26, 28, 29, and 30 were pulled for Individual Consideration. Councilmember Saldaña moved to approve the remaining Consent Agenda Items. Councilmember Bernal seconded the motion.

Mayor Castro called upon the individuals registered to speak:

Jack M. Finger spoke against the On-Call Construction Inspection Service Agreements (Item 7) noting that various Councilmembers had received Campaign Finance Contributions from them. He stated that he was opposed to the Resolutions of Support for the Low Income Housing Tax Credit Applications (Items 26-30) and asked if the Homeowners and Neighborhood Associations had been apprised of the developments.

David Iruegas stated that he was a resident of the area near the Eagles Rest Housing Project (Item 28) and was supportive of their Low Income Housing Tax Credit Application.

Jason Arechiga stated that he was also a resident of the area near the Eagles Rest Housing Project (Item 28) and was supportive of their Low Income Housing Tax Credit Application.

Nazirite Ruben Flores Perez congratulated Councilmember Gallagher for being declared the Elected Councilmember for District 10 (Item 18).

Nikki Kuhns submitted written testimony in opposition to the Flouride Dental Sealants (Item 23) and asked the City Council to stop the Fluoridation Program.

Faris Hodge, Jr. submitted written testimony in favor of Items 5, 6, 8, 9, 11B-14, 19, 21-30. He wrote against Item 7 noting that the Construction Inspection Service Agreements were too expensive. He wrote in opposition to Items 15-18.

Mayor Castro congratulated Councilmember Gallagher as the new District 10 Councilmember.

Councilmember Viagran asked for additional information on the Study and how it would help the Urban Core. Mr. John Dugan stated that the Study would allow for more effective leveraging of Local and Federal Dollars to stimulate Private Market Investment. He noted that it would define redevelopment sites in current REnewSA Target Areas. He indicated that it would define future REnewSA Redevelopment Area Locations and Priorities based on need and market data. Councilmember Viagran highlighted the investment that would help redefine vacant and underutilized Commercial Corridors, specifically in the Urban Core.

Councilmember Gallagher stated that this was a very important issue and referenced the Perrin-Beitel/Nacogdoches Corridor in District 10. He noted that he was pleased that the initiative was moving forward which would help revitalize San Antonio.

Councilmember Medina highlighted the work occurring in the St. Mary's University Area and asked if work would occur in Historic Districts. Mr. Dugan replied that they were looking at Commercial Corridors and vacant properties throughout the city to include Historic Areas. He noted that the Study would be completed within six months.

Councilmember Krier expressed his support and commended Councilmember Gallagher for continuing the work in District 10.

Councilmember Lopez asked how the Study would tie into the investments already made by the City Council on Land Banks. Mr. Dugan replied that the Land Bank Program utilized pilot neighborhoods selected through the OurSA Program and the city had purchased properties to make them available to the private sector. He noted that the process was underway and was being managed by the Center City Development Office. He added that the REnewSA Program was an overall umbrella initiative that combined that process into the new Targeted Neighborhoods.

Councilmember Saldaña highlighted the great project and spoke of the importance of civic engagement. He stated that he would like to discuss the Indian Creek Neighborhood located in the 78242 Zip Code to implement some of these practices.

Councilmember Taylor stated that she had pulled Items 26, 28, 29, and 30 as a result of the Quality of Life (QOL) Council Committee Meeting held on March 18, 2014. She noted that the QOL Council Committee recommended that the Resolutions be revised from "Resolutions of No Objection" to "Resolutions of Support."

Councilmember Nirenberg thanked the QOL Council Committee for addressing said issue. He spoke of the need to ensure consistency with the application of criteria for applications.

Councilmember Gallagher asked of the difference between a Resolution Stating No Objection and a Resolution of Support. Mr. Dugan explained that the new criteria had been adopted in regard to awarding points. He stated that the projects with a Resolution of Non Objection would receive 14 points while those with a Resolution of Support would receive 17 points. He added that although it was a small spread; the projects were very competitive.

Councilmember Taylor moved to approve Items 26, 28, 29, and 30 as Resolutions of Support for Vista Point at Wilde Pine, Eagles Rest, Eckhert Village, and Silver Oaks Village. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

# **32.** City Manager's Report

A. Financial Report Update

Mrs. Sculley reported that the General Fund net financial result for the 1st Quarter of FY 2014 was \$9 Million better than budgeted. She stated that the General Fund Projection in total for the year was \$39.7 Million better than projected. She noted that while the financial update was positive, financial challenges existed for the FY 2015 Budget Cycle. She explained that 80% of the additional CPS Energy Revenue was attributed to unseasonably cold weather and the CPS Rate Increase. She indicated that the Police Department estimated \$2.6 Million in more expenses for FY 2014 due to overtime and less attrition.

Mrs. Sculley stated that in September, the FY 2015 Budget Plan projected a \$30 Million Budget Challenge not including potential increases for Collective Bargaining and Civilian Pay Increases. She noted that rising Healthcare Costs in FY 2014 have resulted in a

projected deficit of \$15 Million in the Employee Benefits Fund. She mentioned that Moody's had cited a lower General Fund Ending Balance as a challenge for the city to maintain its current Bond Rating. She recommended that \$39.7 Million be reserved for the FY 2015 Budget Process. She noted that staff would recommend updates to the current Financial Policies to the City Council in May 2014.

Mrs. Sculley spoke of the deficit within the Employee Benefits Fund. She noted that Uniform Claims were projected to be 10% over the FY 2014 Budget and Civilian Claims were projected to be 7% over Budget. She reported that the Hotel Occupancy Tax Fund was \$200,000 above budget for the 1st Quarter and the Development Services Fund was \$600,000 better than projected. She stated that 1st Quarter Revenues for the Airport Fund were received on budget while expenses were below budget. She noted that Solid Waste Fund Revenues were \$132,000 below budget but savings in expenses would offset the lesser revenue. She highlighted the FY 2015 Budget Calendar which would conclude with Budget Adoption on September 11th.

Maria Villagomez indicated that a status of Budget Initiatives and Performance Measures was included in the binder provided to the City Council. She highlighted the expansion of the District 2 and District 6 Senior Centers that were on schedule and budget. She noted that the new Senior Center in District 7 was scheduled to open in July 2014 and the District 10 Senior Center would be completed in Summer 2016. In regard to Performance Measures, she mentioned that 93% of the Code Compliance Violation Cases had been closed within 45 calendar days.

Mayor Castro commended city staff for their great work on the budget and stated that he was pleased with the additional revenue and cost savings that had been realized to address FY 2015 Challenges.

Councilmember Gallagher asked of restrictions on the Contingency Reserve. Mrs. Sculley replied that they would present policy recommendations to the City Council with the Six Plus Six Report.

Councilmember Krier asked if the information presented today would be posted on the City's Website. Mrs. Sculley replied that it would be posted following the meeting.

Councilmember Nirenberg highlighted the importance of the AAA Bond Rating and the value of same.

# **EXECUTIVE SESSION**

Mayor Castro recessed the meeting into Executive Session at 10:10 am to discuss the following:

# **RECONVENED**

Mayor Castro reconvened the meeting at 2:05 pm and announced that no action was taken in Executive Session.

# INDIVIDUAL ZONING ITEMS

Mayor Castro announced that Item Z-1 had been withdrawn by the applicant and would not be addressed. Item 33 was addressed at this time.

The City Clerk read the caption for Item 33:

An Ordinance waiving the variance criteria requirements of Sections 4-6(c), 4-6(d) (6), and 4-6(e)(1) and authorizing the sale of alcoholic beverages for a portion of Lot 6, Block 1, NCB 10934, currently addressed as 2603 Southeast Military Drive, Suite 107, for on-premise consumption within three-hundred (300) feet of the Seidel Learning Center, a Public Educational Institution, located in Council District 3.

John Jacks stated that staff recommended approval with two conditions: 1) This authorization shall not transfer to a land use not listed in the ordinance (proposed restaurant); and 2) The authorization shall terminate in the event of non-operation or non-use for a period of twelve (12) or more successive calendar months.
