# FINAL Meeting Minutes City Council A Session

The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

**PRESENT:** 10 - Mayor Taylor, Trevino, Warrick, Viagran, Saldaña, Gonzales, Lopez, Nirenberg, Krier and Gallagher

**ABSENT:** 1 - Medina

Mrs. Vacek announced that Councilmember Medina was out on Temporary Duty Assignment with the United States Air Force.

- 1. The Invocation was delivered by Pastor Manny Alaniz, Redeemer Presbyterian Church, guest of Councilmember Ray Lopez, District 6.
- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.

## **POINT OF PERSONAL PRIVILEGE**

Councilmember Viagran recognized students that participated in the District 3 Legacy Leadership Initiative noting that the program provided them exposure toward civic engagement. She stated that they were all residents of District 3 but attended high schools throughout the city. She thanked them for their participation.

Councilmember Lopez highlighted Morgan's Safe House at the Fire Training Academy (Item 18). Chief Hood thanked Gordon Hartman and community partners for their support.

Councilmember Nirenberg recognized Dr. Wilson's Class from the UTSA Public Policy Center for being present and participating in the City Council Meeting.

Mayor Taylor recognized Jean Brady with the San Antonio Public Library for National Library Week. Ms. Brady thanked the City Council for their support and invited everyone to utilize libraries year-round.

**3.** Approval of Minutes for the Regular City Council Meetings of March 4 - 5, 2015.

Councilmember Gallagher moved to approve the minutes for the Regular City Council Meetings of March 4-5, 2015. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

# **4A.** A. Resolution on Local Control

Jeff Coyle presented an update of the 84th State Legislative Session and outlined City of San Antonio Initiatives to include: 1) Municipal Court; 2) Military Funding; 3) Third Trimester Syphilis Testing; 4) G.J. Sutton Building; 5) Missions Resolution; and 6) Local Procurement Preference. He spoke of the weeklong Hearings for:

- Edwards Aquifer Protection Program (House Bill 3620)
- Alamo Funding (House Bill 2968)
- Animal Shelter Euthanasia (Senate Bill 1781)
- Revenue Caps (Senate Bill 182)
- Fire Sprinklers (House Bills 3089 and 4011)
- VIA Election (Senate Bill 1837)
- Transportation Network Companies (House Bills 2440, 3358, and 1733)
- Open Carry (House Bill 910)

Mr. Coyle outlined the Session Timeline, noting that June 1, 2015 was the last day of the Regular Session. He stated that based on direction provided by Councilmember Saldaña at the previous week's City Council Meeting, staff had drafted three versions of a Resolution in support of Local Control. He reported that Councilmember Saldaña preferred Version #1 which specified opposition to Senate Bill (SB) 343 and House Bill (HB) 1556. He noted that the Intergovernmental Relations Council Committee had voted to approve Version #3 in which a list opposing over 60 bills would be attached to the ordinance. He mentioned that Version #2 was more general in nature and reaffirmed support for Local Ordinances.

Mayor Taylor thanked staff for the presentation and called upon the citizens registered to speak on Item 4.

Jack M. Finger addressed the City Council and expressed concern that detailed backup information had not been provided.

Daniel Grainey stated that he was a Gay Man residing in District 10 and had been a community activist for many years. He expressed support for the City of San Antonio maintaining the ability to adopt ordinances such as the Non-Discrimination Ordinance (NDO) without approval from the State of Texas.

Robert Salcido stated that he was supportive of the Lesbian, Gay, Bisexual, and Transgender (LGBT) Community and that Local Control should not be stripped at the State

Level.

Nazirite Ruben Flores Perez addressed the City Council and stated that he was supportive of funding for Transportation.

Andrea Figueroa thanked Councilmember Saldaña for his support of Version #1 of the Resolution on Local Control and stated that she was supportive of same.

David Plylar stated that the City Council should take a strong stand against Legislative Initiatives that undermine municipal authority.

Carolee Moore thanked Councilmember Saldaña for his support of Version #1 of the Resolution on Local Control and expressed her support for same.

Dee Villarrubia stated that she was also supportive of Version #1 of the Resolution on Local Control and noted that all citizens should have equal rights.

Councilmember Krier stated that the City's Legislative Agenda already opposed the Erosion of Local Control and did not believe that specific bills should be highlighted in the Resolution. He noted that he was supportive of Version #2 of the Resolution on Local Control which was general in nature; however, the Intergovernmental Relations Council Committee approved Version #3.

Councilmember Krier moved to approve Version #3 of the Resolution on Local Control as recommended by the Intergovernmental Relations Council Committee. Councilmember Gallagher seconded the motion.

Councilmember Saldaña stated that it was important to address bills in the Legislative Session that were specific to the City of San Antonio such as the Non-Discrimination Ordinance. He noted that he did not believe there would be any controversy as it had been adopted by a majority of the City Council.

Councilmember Saldaña moved to approve Version #1 of the Resolution on Local Control. Councilmember Treviño seconded the motion.

Councilmember Gonzales expressed support for Version #1 of the Resolution on Local Control and stated that it would reinforce decisions already approved by the City Council. She asked of Senate Bill (SB) 1837. Mr. Coyle replied that VIA Metropolitan Transit had initiated the bill and that it would allow VIA to hold an election if a vote was required on a Streetcar or Light Rail Project.

Councilmember Gallagher stated that the basic point of the Resolution on Local Support was to protect the City's right to govern. He noted that he was supportive of Version #3 as it included the list of 60 bills of which some were left off of Version #1.

Councilmember Treviño stated that they must be specific in their message to the Legislature and he was supportive of Version #1 of the Resolution on Local Control. Councilmember Nirenberg stated that they should speak to specific issues that protect the values demonstrated by the City Council and expressed support for Version #1.

Councilmember Nirenberg moved to vote on Councilmember Saldaña's motion first. Councilmember Treviño seconded the motion.

Councilmember Lopez spoke of the importance of opposing SB 343 which would greatly strip Local Control and expressed support for Version #1 of the Resolution which denoted specific opposition to SB 343 and HB 1556.

Councilmember Warrick asked of the staff recommended version of the Resolution. Mr. Coyle replied that any of the Resolutions approved today would reaffirm the City's Position on Local Control. Councilmember Warrick asked of the bill restricting Sanctuary Cities. Mr. Coyle responded that it was widely opposed by the Law Enforcement Community and would provide a status of the bill to the City Council.

Councilmember Warrick made a friendly amendment to Councilmember Saldaña's motion to include TNCs and Annexation Control within the Resolution and add the full list of bills as an attachment. Councilmember Saldaña accepted the friendly amendment.

Councilmember Krier stated that they should not pick and choose favorite issues and believed that Version #3 of the Resolution addressed all concerns regarding the Erosion of Local Control.

Councilmember Viagran stated that the main issue was the Erosion of Local Control that was taking place at the State Level and felt that all versions would demonstrate the City's Position

Mayor Taylor stated that the Council Consideration Request (CCR) Process was deviated from when Councilmember Saldaña moved to direct staff to draft the Resolution in support of Local Control from the dais. She mentioned that his CCR should have been addressed at the Governance Council Committee Meeting. She stated that Version #3 of the Resolution on Local Control addressed basic issues and felt that they should continue to reaffirm the

Legislative Package previously adopted by the City Council.

The motion by Councilmember Nirenberg to address Councilmember Saldana's motion first prevailed by the following vote:

Jack M. Finger expressed concern with the ground lease for \$1.00 per year with the YMCA of Greater San Antonio (Item 12B). He noted that he was opposed to the \$39.9 Million Affordable Multi-Family Rental Housing Development (Item 21).

Nazirite Ruben Flores Perez expressed concern with the funding agreement and ground lease with the YMCA of Greater San Antonio (Items 12A and 12B) noting that they were a religious organization. He noted concerns that religious information was being provided to Pre-K 4 SA Students (Item 17).

Faris Hodge, Jr. submitted written testimony in favor of Items 5-12A, 13-18, and 20-22. He wrote in opposition to Items 12B and 19.

Mr. Armando Cortez, President of Mission San Jose Membership Association expressed his support and stated that he was pleased with the Community Revitalization that would occur in the area.

Councilmembers expressed their support and congratulations.

Councilmember Nirenberg asked for a briefing. John Dugan presented a Power Point noting were requesting authorization to reprogram \$1,425,274.72 in Community Development Block Grant (CDBG) Funds available from completed or cancelled projects. He outlined the four programs recommended for reprogramming: 1) Palo Alto Apartments; 2) Pedestrian Safety Improvement Plan; 3) City's Green and Healthy Homes Initiative; and 4) Habitat for Humanity-Hope Village. He stated that they would also establish a Revolving Fund with Neighborhood Stabilization Program (NSP) revenues to support redevelopment efforts NSP Targeted Areas. Councilmember Nirenberg in support and noted that the Quality of Life Council Committee had approved the reprogramming.

Councilmember Warrick asked if any pedestrian safety improvements were programmed in District 2. Mr. Dugan replied that there were not and that the recommended funding for pedestrian safety improvements were proposed in District 5. He noted that they had to utilize the funds by July 1st and selected projects they felt could be completed within that time frame.

Councilmember Nirenberg moved to adopt the proposed ordinance. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:

23. City Manager's ReportA. Historic Preservation Month

Mrs. Sculley reported that May was National Preservation Month and the Office of Historic Preservation (OHP) was offering numerous events and activities as part of an education and outreach campaign on the role of Historic Preservation in achieving economic, cultural and

environmental sustainability. She noted that Historic Preservation had demonstrated a positive impact on economic development efforts in the community. She indicated that it was a tool for neighborhood stabilization and community revitalization connected to broader strategies of land use, smart growth, sustainability and job creation. She mentioned that Historic Neighborhoods tended to outperform the city as a whole in terms of walkability, transit scores, proximity to parks, and bikeability. She reported that the heritage portion of San Antonio's Tourism Industry was responsible for generation of \$2.5 Billion in visitor expenditures, resulting in 52,000 jobs and \$1.7 Billion in salary and wages. She noted that this impact could be attributed to the preservation historic resources that set San Antonio apart from other destinations. She added that the Office of Historic Preservation was a leader in the nation for active community engagement by a City Preservation She provided a calendar of events that would be hosted throughout the month of May and invited everyone to attend. She thanked the sponsors and partners that helped make the events possible.

#### **RECONVENED**

Mayor Taylor reconvened the meeting at 2:00 pm and announced that no action was taken in Executive Session. She addressed the Consent Zoning Items.

Items Z-8, Z-9, and Z-10 were pulled for Individual Consideration. Items P-2 and Z-6 were postponed by the Applicant and were not addressed. Councilmember Treviño moved to approve the remaining Consent Zoning Items: 24, 25, Z-1, Z-2, Z-3, Z-4, P-1, Z-5, Z-7, P-3, and Z-11. Councilmember Warrick seconded the motion.

Mayor Taylor called upon Jack M. Finger to speak.

Mr. Jack M. Finger addressed the City Council and expressed concern with the Alcohol Variances requested in Items 24 and 25. He spoke in opposition to Item Z-1 noting that there were already too many taverns on Martinez Street.

Faris Hodge, Jr. submitted written testimony in opposition to the Alcohol Variances (Items 24 and 25), as well as Items P-1 and Z-6. He wrote in favor of Items Z-1 through Z-4, Z-5, P-2, and Z-7 through Z-11.

The motion to approve the Consent Zoning Items prevailed by the following vote:
