FINAL Meeting Minutes City Council A Session

The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

PRESENT: 11 - Mayor Taylor, Trevino, Warrick, Viagran, Saldaña, Gonzales, Lopez, Medina, Nirenberg, Krier and Gallagher

- 1. The Invocation was delivered by Senior Pastor Jeff Doria, King of Kings Church, guest of Councilmember Mike Gallagher, District 10.
- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the Regular City Council Meetings of April 15 16, 2015.

Councilmember Lopez moved to approve the minutes for the Regular City Council Meetings of April 15-16, 2015. Councilmember Gallagher seconded the motion. The motion prevailed by the following vote:

POINTS OF PERSONAL PRIVILEGE

Councilmember Nirenberg recognized Madeleine Hickman, Anthony Holmes, and Calista Ibarra, three of the four students from Hobby Middle School that were part of the Team that built a Rocket to study crystals. He also recognized Jacob Rubio who was part of the Team but could not be present today. He noted that they had rebuilt their rocket which exploded after take-off and went on to compete in Washington, DC. He commended them for their work and thanked Walt Downing and the Southwest Research Institute who helped sponsor the students to attend a Space Flight Experience Program in Washington, DC this summer.

Councilmember Warrick welcomed the 7th Grade IDEA Carver Students that were present. Mayor Taylor welcomed all of the students to the City Council Meeting.

ACTION ITEMS FOR STAFF BRIEFING

The City Clerk read the caption for Item 4:

4. Briefing and possible action on legislation filed in the 84th Regular State Legislative Session, an update on the status of proposed State legislation and its impact on the City of San Antonio. [Carlos Contreras, Assistant City Manager; Jeff Coyle, Director, Intergovernmental Relations]

Jeff Coyle reported on the status of various bills at the Legislative Session and highlighted the following funds awarded through House Bill (HB) 1: 1) Funding for G.J. Sutton Building in the amount of \$132 Million and 2) Funding for the Alamo in the amount of \$31 Million. He expressed concern that no funding was awarded for Military Infrastructure. He provided an overview of the City of San Antonio Initiatives to include Municipal Court, Third Trimester Syphilis Testing, Missions Resolution, and Local Procurement Preference. He stated that the following bills had missed the deadline: 1) HB 2221 related to Annexation; 2) HB 1965 related to Revenue Caps; 3) HB 2440 related to Transportation Network Companies (TNCs); and 4) HB 961 related to Stormwater Fees. He noted that they would continue working on priority issues to include Senate Bill (SB) 1639 related to Annexation and SB 182 and 1760 related to Revenue Caps. He mentioned hearings scheduled this week on Eminent Domain and Randolph Air Force Base Compatible Land Use. He added that June 1, 2015 was the last day of the Regular Session and that June 21,

2015 was the last day the Governor could sign or veto bills.

Mayor Taylor called upon the citizens registered to speak.

Nazirite Ruben Flores Perez spoke of the importance of protecting The Alamo.

Jack M. Finger stated that the Residents of an area proposed for Annexation should be able to vote on whether or not they would like to be annexed.

Councilmember Warrick stated that he was pleased with the funding allocated to the G.J. Sutton Building and asked of the project timeline. Mr. Coyle replied that the funding would be available immediately but the timeline for the project had not been established yet. He noted that it was a State Project but the City was a key stakeholder. He added that they would begin conversations on a potential Public Private Partnership (P3) after the Session ended.

Councilmember Krier thanked Mayor Taylor and the City Councilmembers that testified in Austin. He expressed concern that no funding was allocated for Military Infrastructure.

Councilmember Treviño stated that he was pleased with the funding allocated for The Alamo since it was in need of repairs. He asked of HB 2440 related to TNCs. Mr. Coyle replied that it had missed the deadline but there were other bills that it could be attached to and they were monitoring them closely.

Mayor Taylor thanked the IGR Council Committee and IGR Staff for their work on the Legislative Session and stated that San Antonio was in a good place.

POINT OF PERSONAL PRIVILEGE

Councilmember Viagran stated that she did not want to pull Item 5 from the Consent Agenda but wanted to recognize the Representatives of the RK Culinary Group that were present. She congratulated them on the Catering and Concessions Services Agreement for the Henry B. Gonzalez Convention Center. Mr. Greg Kowalski thanked the City Council for their continued support and recognized staff from his team that were present. Mayor Taylor and the City Council congratulated the RK Culinary Group on the contract award and thanked them for their commitment to the City of San Antonio.

CONSENT AGENDA ITEMS

Items 10, 11, 12, and 20 were pulled for Individual Consideration. Mayor Taylor announced that Item 14 was pulled from the agenda by staff and would not be addressed.

Councilmember Gallagher moved to approve the remaining Consent Agenda Items: 5, 6, 7, 8, 9, 13, 15, 16, 17, 18, 19, 21, 22, 23, 24, 25, and 26. Councilmember Treviño seconded the motion.

Mayor Taylor called upon the citizens registered to speak.

Nazirite Ruben Flores Perez spoke in support of the cameras being purchased for the FY 2015 ATD Intersection Improvement Project (Item 7).

Jack M. Finger expressed concern with the Catering and Concessions Services Agreement with RK Culinary Group, LLC noting that many of the City Councilmembers had received campaign contributions from the RK Group (Item 5). He noted that he was opposed to the reprogramming of HOME Funds (Item 25).

Written testimony was received from Brooks City Base and the San Antonio River Authority in support of the Texas Enterprise Project Designation for Calumet San Antonio Refining, LLC (Item 23).

Faris Hodge, Jr. submitted written testimony in support of Items 4-14, 16-23, 25, and 26. He wrote in opposition to Items 15 and 24.

Councilmember Saldaña stated that he was excited about this project which had recently won an award for Landscape Design. Mike Frisbie noted that Pearsall Park was a Regional Park and highlighted the Fitness Challenge Zone, Family Fun Zone, and connection to the Linear Park.

Mayor Taylor called upon Mr. George Alva to speak.

Mr. George Alva stated that he was a Taxicab Industry Representative on the Airport Advisory Commission and was supportive of the project. He noted that it would provide amenities for Taxicab and other Ground Transportation Providers at the Airport to include clean restrooms and vending machines.

Councilmember Nirenberg asked about the project costs. Mr. Razi Hosseini replied that additional funding was needed because the original cost estimate was prepared without the final design. He stated that due to the amount of individuals utilizing the facility, it would have to be durable. Councilmember Nirenberg stated that he was supportive of the project He asked for additional information on the increased costs. but concerned with the cost. Mr. Tim O'Krongley stated that they had increased the square footage of the facility and would use Industrial Finishes instead of Standard Finishes. He added that changing the location had also increased the costs. Councilmember Nirenberg asked how they would Mr. O'Krongley replied that they ensure that the new facility was properly maintained. would work closely with the users and would have staff that also utilized the facility to maintain the building.

Councilmember Treviño stated that one of his first projects as an Architect had been to design a similar facility at Miller International Airport in McAllen, Texas. He noted that it was important to design a durable building that would provide a place of comfort for its users. He asked of the maintenance features. Mr. O'Krongley noted that the sealed floors would assist when it rained and that the stainless steel fixtures were durable and easy to clean. Councilmember Treviño expressed his support for the project and stated that he was pleased that the City of San Antonio was moving forward with the project.

Councilmember Krier noted that the project was being funded by Aviation Capital Improvement Funds and expressed his support. Councilmember Lopez added his support for the project.

Councilmember Treviño moved to adopt the proposed ordinance. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

Councilmember Krier moved that the City of San Antonio authorize the use of the power of eminent domain to acquire property for a public use project for the Redland Road North (Loop 1604 to Ridgewood Parkway) Project by acquiring the following property described by the City Clerk and incorporated as part of this Motion. Councilmember Gallagher seconded the motion.

The City Clerk read the property description: The properties consist of the following all along Redland Road: A total of approximately 3.7859 acres out of 12 parcels of real property, for right-of-way easement interests in real property, located in NCB 15671, NCB 17586, NCB 17866 and NCB 17867. These properties are specifically shown on the Site Map attached hereto as Exhibit A and more particularly described by metes and bounds in Exhibits B through M, attached to the ordinance and incorporated as part of this Motion.

20. An Ordinance authorizing the permanent closure of a railroad crossing at Hoefgen Avenue and Essex Street, located in Council District 2, as approved by Union Pacific Railroad. [Peter Zanoni, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Mayor Taylor called upon the citizens registered to speak.

Mr. Chuck McGinnis spoke against the street closure and noted that at every Public Hearing held to date; most citizens expressed opposition. He expressed concern that the closure was initiated by Union Pacific and stated that there should be a way to address the infrastructure without closing the street. He asked the City Council to uphold the decision of the Planning Commission to deny the request.

James McKnight of Brown and Ortiz addressed the Council and stated that he represented the property owner at 1407 Hoefgen Avenue. He noted negative impacts of the temporary closure to include improper drainage and large trucks coming onto their property when trying to turn around. He stated that they had received confirmation from Councilmember Warrick's Office that the drainage issue would be addressed and that a turnaround would be included north of the property and were not opposed to the closure.

Terry Bellamy presented a Power Point noting that staff was requesting approval of the permanent railroad crossing at Hoefgen Avenue near Essex Street. He stated that the railroad crossing presents vehicle safety issues and that the tracks were configured in a large curve that obstructs sight distance for trains. He indicated that the track was higher than the roadway approaches and could cause vehicles to get stuck. He stated that on September 4, 2014, the City Engineer authorized temporary closure of the Hoefgen Avenue Railroad Crossing due to life safety concerns. He reported that 10 crashes took place between 2010 and 2014 and that there had been other incidents of vehicles stuck on the tracks without train collisions. He mentioned that the permanent closure would not isolate the neighborhood from alternate travel routes and highlighted the North to South and East to West Alternate Routes.

Councilmember Warrick asked when the drainage issues would be addressed. Mr. Bellamy replied that they had completed the design and would begin upon project approval. Councilmember Warrick asked of the number of accidents at the crossing in 2014. Mr. Bellamy replied that there were 4 accidents in 2014.

Councilmember Viagran asked of the difference between a Temporary and Permanent Closure. Mr. Bellamy replied that the main difference was the guardrails and stated that they would work with the adjacent property owner to ensure the turnaround area was cleaned and maintained. Councilmember Viagran asked if a walking or bike path could be made available. Mr. Bellamy replied that it could be made available and would discuss same with Union Pacific.

Councilmember Gallagher stated that safety was most important and he would support the closure. Councilmember Nirenberg thanked Mr. McGinnis for being present and expressing his concerns but concurred with Councilmember Gallagher that safety was the top priority.

Councilmember Warrick moved to adopt the proposed ordinance. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:
