Staff recommends Approval.

Staff mailed 22 notices to the surrounding property owners, 0 returned in favor, and 0 returned in opposition. The Government Hill Alliance Association is in favor, and no response from the Downtown Residents Association.



Patrick Christensen, representative, explained the planned project of for-sale single-family townhomes. Willing compliance with all processes and recommendations, were also noted by the representative.

Janet Dietel, San Antonio Conservation Society Representative, is concerned with the zoning request due to the architectural significance as a late Victorian style residence with physical feature findings. The home is documented as one of the most architectural significant houses in the Government Hill Neighborhood, and appears on the 1886 bird eye's map of San Antonio, possibly making the property eligible for designation as a local land mark.

Claudia Guerra, Office of Historic Preservation, Cultural Historian, has spoken with the applicant, and explained the process for review in regards to a demolition permit. A thorough research review must be completed in order to recommend approval or denial for the permit.

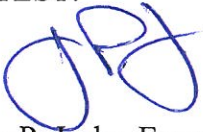
