# FINAL Meeting Minutes City Council A Session

Councilmember Viagran highlighted the project which was part of the World Heritage Work Plan and asked for additional information. Mike Frisbie stated that the project

included South East Loop 410 to Ashley Road. He outlined the benefits to include full road reconstruction, dedicated bike lanes, and Mission Trail Themed Enhancements. He added that construction would begin May 2016 and be completed by July 2017. Councilmember Viagran thanked the voters for approving the project.

Councilmember Viagran moved to adopt the proposed Ordinances for Items 9A and 9B. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 10:

10. An Ordinance authorizing the execution of a Developer Participation Agreement with New Leaf Homes whereby the City provides up to \$300,000.00 for New Leaf Homes to build sidewalks in a developing subdivision located in District 2; and requiring New Leaf Homes to build a total of eight infill houses in the Wheatley area in collaboration with San Antonio Affordable Housing, Inc. [Peter Zanoni, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Councilmember Warrick requested additional information. Debbie Racca-Sittre stated that the City of San Antonio would enter into an agreement with New Leaf Homes to provide \$300,000 for them to build sidewalks in the Katy Way Subdivision. She noted that for each 10 homes built in Katy Way; New Leaf will finance and build one infill home in the Wheatley Area. She reported that they would finance and build a total of 8 homes at a cost of \$120,000 or less. She indicated that they would begin with two San Antonio Affordable Housing Inc. (SAAH) owned lots at 127 and 131 Gabriel Street. She stated that if New Leaf could not sell a home within 12 months; they would donate the home to SAAH. Councilmember Warrick asked if this had been done before. Mrs. Racca-Sittre replied that it had not been done before. Councilmember Warrick recognized New Leaf Homes and thanked them for their commitment.

Councilmember Nirenberg stated that this was an innovative project and commended Councilmember Warrick. He asked if the \$120,000 was an average or if all of the homes would be sold at that price range. Mrs. Racca-Sittre replied that all of the homes would fall in the \$120,000 range. Councilmember Nirenberg asked what SAAH would do with the homes that were not sold. Mrs. Racca-Sittre responded that they would market the homes via various avenues to include programs that help with mortgages and lending.

Councilmember Saldaña stated that he was pleased to support the project and commended

Councilmember Warrick for the innovative approach.

Mayor Taylor stated that she was very excited about the project and that she hoped they could build momentum to address vacancy challenges in the inner city. She asked staff to look at a mixed element income to some of the neighborhoods in the inner city.

Councilmember Gonzales asked if the properties were city-owned. Mrs. Racca-Sittre replied that these particular lots were owned by SAAH but they were looking at city-owned lots for the future. Councilmember Gonzales stated that she looked forward to the success of the program and seeing it expand.

Councilmember Treviño congratulated Councilmember Warrick and stated that this was a great project.

Councilmember Warrick moved to adopt the proposed Ordinance for Item 10. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 11A:

An Ordinance authorizing the acquisition, through negotiation or condemnation of interests, in approximately 0.138 acres of privately-owned real property in NCB 789, Lots 11 and 12, and declaring it to be a public use project for and authorizing up to \$450,000.00 payable to the selected title company, for land, litigation expenses and associated title fees

Mayor Taylor called upon the citizens registered to speak.

Bebb Francis addressed the Council and stated that he was representing APA Institute Properties. He commended City Staff for their work but noted that there was an error on Section 5 of Item 11B regarding an issue of title that could impede development.

Mitsuko Ramos with Government Relations Group of Texas stated that she was representing Dr. Bernard Swift who owns one of the properties subject to condemnation in support of the Roundabout Project. She thanked staff for working to address their concerns.

Steve Horvath stated that they were the Engineer representing APA and had been working closely with city staff and the legal team on the agreement. He noted that they needed to

show encumbrances on the property that allow utilities in the area where they will build their structure.

Councilmember Treviño asked city staff for a presentation. Mike Frisbie stated that they would be reconstructing the intersection at: 1) San Pedro; 2) North Main; 3) Navarro; 4) Buffalo Run; 5) Camden; and 6) Soledad. He noted that the design consisted of a Roundabout and Raised Medians. He reported that Item A authorized the acquisition of Lots 11&12. Item B authorized the closure of approximately 0.171 acres; and Item C authorized an aerial easement to be conveyed to American Payroll Institute Properties, Inc. Councilmember Treviño thanked everyone for their work on the project and working to address previous concerns.

Councilmember Treviño moved that the City of San Antonio authorize the use of the power of eminent domain to acquire right of way interest for a public use project for the Downtown Streets Reconstruction Project relating to the property described by the City Clerk and incorporated as part of this Motion. Councilmember Warrick seconded the motion.

City Clerk Vacek read the property description: The 3 parcels of land consist of a combined total of 0.138 acres for right of way interests, all out of New City Block 789, Real Property Records of Bexar County, Texas. These properties are depicted in Exhibit A and more particularly described in Exhibits B through D attached to the Ordinance and incorporated as part of this Motion.

The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 18:

Councilmember Warrick asked for additional information. Fred Garcia stated that they were requesting authorization of the reappointment of nine Full-Time Municipal Court Judges. He noted that Judge Bull was the Presiding Judge and was appointed in odd-numbered years.

Councilmember Viagran stated that the item had been vetted through a Subcommittee of the

Criminal Justice, Public Safety and Services Council Committee consisting of herself, Councilmember Gallagher, and Ciro Rodriguez appointed by Mayor Taylor. She noted that they had interviewed all of the Judges and provided said recommendation to the full Committee.

Councilmember Gallagher added that it was an important process and he was pleased with the interviews and responses. Councilmember Warrick asked why the Presiding Judge was on a different schedule. Martha Sepeda stated that in 2004 or 2005, the City Council held over the Presiding Judge Appointment so that there was not a full transition. She noted that the City Council could decide to change the process.

Councilmember Viagran moved to adopt the proposed Ordinance for Item 18 to reappoint nine full-time Municipal Court Judges. Councilmember Gonzales seconded the motion. The motion prevailed by the following vote:

Items 24A and B were addressed jointly. City Clerk Vacek read the captions for Items 24A and 24B:

**24A.** An Ordinance authorizing the execution of a contract with Coastal Securities, Inc. to provide Co-Financial Advisor Services in connection with various of the City's financings for a period to commence April 1, 2016 and terminate March 31, 2019, with an option to extend the contract for one additional two-year period under the same terms and conditions.

#### 2016-04-14-0290

**24B.** An Ordinance authorizing the execution of a contract with FirstSouthwest, a Division of Hilltop Securities Inc. to provide Co-Financial Advisor Services in connection with various of the City's financings for a period to commence April 1, 2016 and terminate March 31, 2019, with an option to extend the contract for one additional two-year period under the same terms and conditions.

Councilmember Saldaña thanked staff for their work on the item but stated that he would be

voting against the staff recommendation. He apologized to Mayor Taylor and the City Council. He added that said item was presented to the Audit Committee via High Profile Contracts and he should have addressed particular questions at that time. He noted that the incumbent which has had the contract for 22 years did not score in the top two but felt there should have been justification regarding same. He stated that Coastal Securities and Estrada Hinojosa had worked well together and felt confident in their work going into the 2017 Bond Process.

Councilmember Saldaña moved to extend contracts with Coastal Securities and Estrada Hinojosa for two years. Councilmember Krier seconded the motion.

Councilmember Viagran stated that she felt that the RFP Process had been fair and did not want to set a new precedent by changing that on the dais. She noted that she was comfortable with the staff recommendation which was the best team moving forward with the 2017 Bond Process.

Councilmember Viagran moved to approve the staff recommendation for Items 24A and 24B. Councilmember Gallagher seconded the motion.

Councilmember Gallagher stated that he appreciated Councilmember Saldaña's sensitivity to the issue but did not feel they should change the rules. He highlighted the experts that served on the Evaluation Committee and noted their great experience. Ben Gorzell added that this was a very competitive industry and that they had scored the proposals on other criteria than just past performance.

Councilmember Nirenberg stated that he takes the staff recommendation very seriously but was supportive of Councilmember Saldaña's comments. He noted that it was good policymaking to pause and answer questions that remain before moving forward and that they should examine the process in the future.

Councilmember Gonzales asked if it was typical that only City Staff reviewed RFP's. Mr. Gorzell replied that it depended on the contract. Councilmember Gonzales asked if the current contractors were working on the 2017 Bond Process. Mr. Gorzell responded that both contracts were expired so they were not actively engaged on any financial advisory work at this time. Councilmember Gonzales stated that she was pleased with the success of the previous Bond Programs and noted that Estrada Hinojosa was one of the largest Minority-Owned Firms in the country.

Councilmember Krier stated that it was very important for the city to have a Triple A Bond Rating and had achieved same due to the good team backing up City Staff. He noted that he

did not feel that the rules were changing but that as the City Council; they must make a thoughtful judgment on what was best for the city. He expressed concern with the process and recognized Estrada Hinojosa for their great work over the years.

Councilmember Treviño stated that this had been a thoughtful process and commended Councilmember Saldaña for his thoughtful leadership. He noted that the issue had become complicated but did not feel that it was appropriate to change the assessment on the dais. He added that they should take a closer look at the process in the future.

Councilmember Saldaña asked of the consequences of re-issuing the RFP. Mr. Gorzell replied that they needed to move forward on preparation for the 2017 Bond Program and spoke of the Airport Capital Improvements Program (CIP). Additionally, he noted that they need the assistance of the Financial Advisors to narrow down the Pool of Underwriters which will be up later this year. Mrs. Sculley added that the 2017 Bond Program would be the largest in the City's History and they need to get started as soon as possible. Councilmember Saldaña stated that all of the top four firms were of high quality and could perform work to satisfy the city's needs. He noted that Estrada Hinojosa had 22 years experience in working with the city and had positive outcomes.

Councilmember Lopez stated that he did not feel that a bad decision would be made between the two firms in question. He noted that there was a process in place that had worked but noted a gap with regard to the Small Business Economic Development Advocacy (SBEDA) Ordinance. He stated that they should move forward with the recommendation and fix the gap for the future.

Councilmember Gonzales asked why there was not a representative regarding SBEDA on the Evaluation Committee. Mr. Gorzell explained that the SBEDA Portion was formula driven and that the points for SBEDA were added to the total scored by the Evaluation Committee.

Councilmember Warrick stated that he appreciated all of the comments that had been made and hoped that some changes would be made to the process in the future. He noted that there should have been more communication with the firms but felt that the staff recommendation was sufficient to move forward.

Mayor Taylor stated that she was grateful to all of the firms that responded to the RFP and thanked the City Councilmembers for their thoughtful reflection on this decision. She noted that they should all be working to ensure that San Antonio is a globally competitive city. She stated that there are established policies and procedures that guide the decision-making process and felt uncomfortable extending the current contract. She added that there was

some work to be done on the SBEDA Ordinance and requirements for notifying firms of their performance.

The motion to extend the current contracts for two years failed by the following vote:

# 25. City Manager's Report

A. Alamodome Concessions Update

Mrs. Sculley reported that last year, a Request for Proposals (RFP) had been issued for the Concessions and Catering Operations at the Alamodome. She stated that their goal was to improve the quality of Food and Beverage Service and showcase new and unique San Antonio Flavors. She noted that locally-owned Black Tie Affairs Catering created a Joint Venture with nationally known concessionaire, Savor, and won the bid on the project. She reported that the Alamodome's New Concession Program features four of San Antonio's most recognized restaurants that highlight the History and Culture of San Antonio: 1) Los Barrios Continental Mexican Cuisine; 2) The Big Bib Barbecue; 3) Earl Abel's; and 4) Frost 321. She showed a video highlighting the four businesses.

# **POINTS OF PERSONAL PRIVILEGE**

Councilmember Saldaña recognized Donald Gonzales of Estrada Hinojosa. Mr. Donald Gonzales thanked the City Council for the opportunity and commended City Staff for their work over the past 22 years. He stated that they had always acted in the best interest of the city and would continue to do so. He congratulated the two firms selected as Financial Advisors. Mayor Taylor thanked Estrada Hinojosa for their work over the years.
