## **Meeting Minutes**

## **City Council A Session**

The City Council of San Antonio convened in a Regular Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

Mrs. Vacek announced that Councilmember Nirenberg was attending the National League of Cities Infrastructure Week in Washington, D.C.

- 1. The Invocation was delivered by Pastor David K. Caruthers, Calvary Church, guest of Councilmember Mike Gallagher, District 10.
- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the Regular City Council Meetings of April 13 14, 2016.

Councilmember Krier moved to approve the Minutes for the Regular City Council Meetings of April 13-14, 2016. Councilmember Gallagher seconded the motion. The motion prevailed by the following vote:

## POINTS OF PERSONAL PRIVILEGE

Councilmember Medina presented a Citation to Dr. William Elizondo in recognition of being the recipient of the Volunteer of the Year Award by the Houston College of Optometry. He stated that Dr. Elizondo had also been awarded the 2016 Texas Optometric Association Distinguished Service Award and was the First Hispanic to receive this award. Dr. Elizondo thanked the City Council for the recognition and stated that he was honored to represent San Antonio. He introduced his wife, Maria and thanked her for her support. Mayor Taylor and the City Council commended Dr. Elizondo on his awards and thanked him for his work in the community.

Councilmember Saldaña recognized all of the volunteers that assisted with the San Antonio Sports Fit Family Challenge in District 4. He stated that this was the sixth year of the 5K Event and hoped it would continue to grow.

Mayor Taylor recognized National Infrastructure Week and thanked the many partner agencies that help coordinate investments for the region. She spoke of the value of infrastructure and the need to invest in same.

#### **CONSENT AGENDA ITEMS**

Faris Hodge, Jr. submitted written testimony in favor of Items 5-18B, and 20-24. He requested that backup documents be provided for the City Manager's Report.

City Clerk Vacek read the caption for Item 8:

information regarding the Development Rod Sanchez presented Services Department (DSD) Parking Lot Project. He stated that 80 parking spaces would be added for DSD Staff and that the project would include a Bioswale Low Impact Development (LID) Feature. He noted that the San Antonio River Authority (SARA) had approved a \$34,527 rebate. He highlighted the Art Component, a water themed fence similar to the railing on the stairs and second floor balcony at the One Stop Center. He stated that an access control gate would be used during business hours and would be available to the public after hours. He mentioned that an ADA Enhanced Crosswalk with a curb ramp would be added and that they would utilize energy-saving LED Lighting. He reported that the low bidder was D. Plata Construction and the cost was \$515,868.15. Councilmember Treviño noted that this was a good investment and highlighted the features and design.

Councilmember Warrick asked when the project would be completed. Mr. Sanchez replied that the project was scheduled for completion in August. Councilmember Warrick requested that he be informed when the firm met or exceeded their Small Business Enterprise Development Advocacy (SBEDA) Goals.

Councilmember Gallagher noted that he was pleased with the additional parking at the One Stop Center and stated that he looked forward to the completion.

Councilmember Gonzales asked of the safety features. Mr. Sanchez replied that the enhanced crosswalk would be fully code compliant and staff had worked with TCI to ensure that it was safe. He stated that they would utilize LED Lighting to keep the parking lot well-lit. Councilmember Gonzales stated that while she was pleased with the Bioswale; she was concerned that people could not cross the street directly in front of the parking lot. She asked of the maintenance and life span of the parking lot. Mr. Sanchez stated that it was a temporary parking lot and their future goal was to build a garage structure.

Councilmember Medina expressed support for the item and stated that this was a good step toward easing traffic concerns. He noted that he appreciated the public art component but felt it was important to ensure public safety.

Councilmember Treviño moved to adopt the proposed Ordinance for Item 8. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Councilmember Warrick requested a brief presentation. Razi Hosseini presented a map outlining the Martin Luther King Park Project. He highlighted project details to include: Roadway Alignment, Park Entry Signage, Lighting Upgrades, New Bridge Structure at Salado Creek, and Vehicle Traffic and Pedestrian Separation. He stated that design would be complete by September 2016 while construction would be completed in September 2017. Councilmember Warrick asked if there were any upcoming community meetings to showcase the design and inform the public of the timeline. Mr. Hosseini replied that they were hosting a community meeting later this month and that flyers had been mailed. Councilmember Warrick asked of the impact to the park. Mr. Hosseini stated that there would not be an impact to the park. Councilmember Warrick asked if the contractors were in place for the project. Mr. Hosseini reported that staff would advertise the project later this year.

Councilmember Viagran spoke of the importance of the city retaining local control of annexation and performing due diligence when identifying areas of future growth. She thanked TCI Staff and the Fire Department for their delivery of services.

Councilmember Saldaña expressed his support and stated that he was pleased that they were planning for future growth.

Councilmember Viagran moved to adopt the Ordinances for Items 15A and 15B. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:

Councilmember Gonzales asked of the funding dedicated thus far and asked for a brief presentation. Terry Bellamy stated that they were requesting authorization to submit an application and accept funds if awarded for the Vision Zero San Antonio: Traffic Safety Education and Enforcement Program. He noted that the Vision Zero Initiative would reduce traffic related fatalities to zero, educate people, and enforce traffic laws. He outlined the 5 Essential Elements: 1) Engineering; 2) Encouragement; 3) Enforcement; 4) Education; and 5) Evaluation. He highlighted the proposed program activities within each of the elements to include hosting a Vision Zero Symposium. Councilmember Gonzales noted that San Antonio was one of the first Vision Zero Cities in the country and asked if San Antonio was ready for a Scorecard. Mr. Bellamy replied that it was too soon in the process but would continue to work on improvements.

Councilmember Krier thanked Councilmember Gonzales for her leadership on the initiative and encouraged all school districts to sign up for Vision Zero. He asked when the School Zone Improvements would be completed throughout the city. Mike Frisbie replied that they were 30% complete and noted that they hoped to complete the program a year early.

Councilmember Gonzales moved to adopt the proposed Ordinance for Item 17. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

**18B.** An Ordinance authorizing the submission of a grant application to the Office of the Governor, Criminal Justice Division, in an amount up to \$900,000.00 to support the Cure Violence Project; authorizing the acceptance of those funds, upon award; and authorizing the San Antonio Police Department and/or the San Antonio Metropolitan Health District to seek out and apply for additional grants to fund the continuation of the Cure Violence Grant Program beyond December 31, 2016.

Councilmember Warrick asked of the metrics for the program. Interim Deputy Chief Anthony Treviño responded that they were working with the Health Department in reference to the metrics and performance. Dr. Vincent Nathan noted that they were looking at how many contacts they had and interruptions conducted. He added that they were using some of the metrics from the evaluation created by Northwestern University in Chicago. Councilmember Warrick asked how the grant funds could be used. Dr. Nathan replied that they used funds to pay Interrupters, Staff, and could host community activities.

Councilmember Medina acknowledged the great work that has been done for the program and added that this week is National Police Week.

Councilmember Saldaña asked of the sites. Dr. Nathan identified the four sites: 1) Wheatley Heights, 2) Lincoln Heights, 3) Springhill, and 4) East Point. He clarified that the Lincoln Heights Site was located off Zarzamora South of Culebra. Councilmember Saldaña asked if utilizing Violence Interrupters was a common practice at SAPD. Chief Treviño replied that it was a new concept that they were working on in coordination with the Health Department. He stated the Interrupters were typically individuals that had a criminal background and street credibility. Councilmember Saldaña expressed support for the program but noted that he would like to see metrics.

Councilmember Gonzales asked how many people were involved in the program. Dr. Nathan noted there were 24 in the program. Councilmember Gonzales noted that they

usually had previous gang affiliations and lived in the neighborhood they were serving. She mentioned that although it was difficult to see progress; it was a very important program. Dr. Nathan stated that the program tries to prevent a subsequent violent crime.

Mayor Taylor stated that the program was very important and encouraged Councilmembers to talk with some of the individuals performing the work. She noted that they should expand the approach which makes a tremendous difference to prevent these types of crimes from occurring. She commended everyone involved in the program.

Councilmember Warrick moved to adopt the proposed Ordinances for Items 18A and 18B. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Rene Dominguez presented the proposed amendments to the Small Business Economic Development Advocacy (SBEDA) Ordinance. He noted that Minority and Women-Owned Businesses make up 43% of all available firms; however, disparities continue in the broader San Antonio Marketplace. He outlined the tools for Small, Minority, and Women-Owned Business Enterprises (S/M/WBE) Prime Contractors to include the Joint Venture and He stated that S/M/WBE Capacity Building Tools Emerging Contractor Programs. included the Mentor-Protégé and Distributorship Development Programs. He mentioned that tools for S/M/WBE Subcontractors include the Subcontracting and Segmented He stated that the most important change was the Prime Subcontracting Programs. Self-Performance of Subcontracting Goals. He added that if approved today; the amended SBEDA Ordinance would be effective on July 1, 2016.

Mayor Taylor called upon the citizens registered to speak.

Ramiro Cavazos, President and CEO of the Hispanic Chamber of Commerce, provided background information on the history of the SBEDA Ordinance. He stated that the Hispanic Chamber was in support of the renewal of the Ordinance and the proposed

amendments. He added that the program was vital to bringing prosperity to the community.

Don Gonzales stated that the SBEDA Ordinance was based on Small Businesses and asked that they look at how "Small" is determined. He also requested that they consider Local Ownership as a qualification for Local Preference. He asked that there be more coordination with the Goal Setting Committees.

Jane Gonzales stated that she was the owner of Med Wheels, a National Medical Distribution Company and expressed support for the SBEDA Ordinance and amendments. She stated that she was pleased that it would allow her to start performing work for the City of San Antonio.

Irene Chavez addressed the City Council in support of the SBEDA Ordinance and Amendments. She mentioned that she was a member of the Hispanic Contractor's Association and the Interim Executive Director of the Entrepreneur Center. She commended all for their work and spoke of the importance of advocating and building capacity for small businesses.

Julissa Carielo stated that she was a Vendor for the City of San Antonio and had also served on the Small Business Advocacy Committee (SBAC). She expressed support for the SBEDA Ordinance and amendments and spoke of her experiences as a Small Business Owner. She explained her involvement in order to provide feedback and help improve processes.

Christopher Herring, Chairman of the Board for the Texas Association for African American Chambers of Commerce and the Mayor's Appointee to the SBAC, addressed the City Council in support of the SBEDA Ordinance and proposed amendments. He stated that the Ordinance focused on business and families and thanked everyone for their support.

Roland Gonzales stated that he served on the SBAC and was supportive of the SBEDA Ordinance and proposed amendments. He thanked everyone for their work and the community stakeholders that provided feedback.

Councilmember Viagran thanked everyone that spoke and stated that she was grateful for the years of work that had been spent on this monumental task. She noted that she was pleased with the opportunities that the amendments would provide for Small. Minority-Owned Businesses. requested a measurement the impact She of of the amendments. Mr. Dominguez stated that there was a provision in the Ordinance that required them to develop an Annual Report with that data.

Councilmember Treviño thanked everyone for their work and asked of the input received from the American Institute of Architects (AIA) and the Hispanic Contractor's Association. Mr. Dominguez stated that the majority of the amendments were recommended by the community. He noted that AIA was a key partner and had provided pertinent feedback with regard to the Emerging Small Business Tool. Councilmember Treviño noted that he was a Mentor Protégé Graduate and recognized Irene Chavez who had been championing these types of efforts for many years.

Councilmember Lopez thanked everyone for their work and stated that this had been a significant process. He asked of the dialogue with the SBAC and Goal Setting Committees. Mr. Dominguez replied that they play an extremely important role and are very involved in all of the decisions made. He stated that they meet on a monthly basis and provide feedback on the SBEDA Ordinance. Councilmember Lopez encouraged staff to continue engaging those businesses that have grown and bring them into the process from a Mentorship Perspective.

Councilmember Gonzales thanked everyone involved in the process and called upon Ms. Julissa Carielo to speak on the Maestro Program. Ms. Carielo stated that she had worked with SAISD to purchase a building to use for the Maestro Program. She explained that it is an Incubator Acceleration Program that helps small businesses have a place to conduct their business. She noted that she also coordinated with the Hispanic Chamber of Commerce and they provide training to the small businesses. She added that their focus was strictly on building existing businesses; not startups. Councilmember Gonzales thanked Ms. Carielo and the staff for their work to help small businesses in the community.

Councilmember Warrick asked of organizations that have graduated from the "Small" to "Large" Category. Mr. Dominguez replied that they were researching the data and would provide it to the City Council. Councilmember Warrick asked of strategies to bring in businesses from other cities or grow the current businesses in San Antonio. Mr. Dominguez stated that they focused on marketing their program and getting businesses registered in the Central Vendor Registry (CVR). He noted that they hosted a Vendor Orientation Program in the community every month and provided materials to participants regarding the services they offered. He mentioned that they also work with the Trade Organizations and Chambers of Commerce to provide information throughout the community.

Councilmember Saldaña stated that even if approved today; there was still more improvements that would need to be made to the SBEDA Ordinance. He thanked everyone that had worked on the program thus far and stated that they should continue to monitor progress.

Mayor Taylor thanked everyone for their work and stated that she was pleased to move forward on improving the current SBEDA Program and engaging small businesses to grow.

Councilmember Viagran moved to adopt the proposed Ordinance for Item 21. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Mrs. Sculley reported on National Public Works Week, celebrating those that provide and maintain infrastructure and provide services that improve the quality of life. She stated that each year since 1960, the American Public Works Association observes National Public Works Week to bring awareness, educate, and extend much deserved recognition of the Professionals in this field. She noted that in 2014, she consolidated the Public Works and Capital Improvements Management Services Departments into the Transportation and (TCI) Department resulting streamlined Capital Improvements in operations and She mentioned that next week is "Flood Awareness Week in Texas" and that it efficiencies. was important to understand flood risks and safety as heavy rainfall, thunderstorms and flooding continue across parts of Texas. She reported that Texas has led the country in flood deaths for most of the past 36 years. She stated that between 1993 and 2014, flood events have caused \$14.9 Million in Property Damages, 507 Injuries, and 16 Fatalities. She noted that since 2007, the City of San Antonio has invested \$300 Million in Drainage She added that the week would recognize past significant Flooding Events to help Projects. educate and communicate Flood Safety in an effort to save lives from future Flooding Events.

Mrs. Sculley congratulated the TCI Storm Water Division for receiving the 2016 Field Excellence Award from the American Public Works Association for their management of Storm Water Operations. She recognized TCI Assistant Director Art Reinhardt for his leadership in securing the award. She stated that the Award recognizes organizations for their actions in the field that have had a significant impact on the services provided to the public while protecting the environment.

Councilmember Saldaña noted that San Antonio had received an award due to having one of the oldest intact concrete streets, Belknap Street, which was 100 years old.

Councilmember Treviño stated that they would be showcasing a few panels of precast concrete sidewalk at the Cement Celebration on Saturday from 10:00 am to 2:00 pm. Councilmember Viagran commended Art Reinhardt for his leadership on the Stormwater Award. Mr. Reinhardt spoke of their work to monitor low water crossings and encouraged the public to "Turn Around Don't Drown."

Mayor Taylor recognized City Manager Sculley who would be celebrating her birthday on May 20th. The City Council wished Mrs. Sculley a Happy Birthday.

Mayor Taylor opened the Public Hearing. There being no citizens registered to speak, Mayor Taylor declared the Public Hearing closed.

Catherine Hernandez presented Item Z-1 and stated that staff recommended approval while the Zoning Commission recommended denial. She reported that of 22 notices mailed; 10 were returned in favor and 2 were received in opposition. She noted that the Mahncke Park Neighborhood Association was opposed to the request. Mrs. Hernandez also stated that 50 letters of support were received from Neighborhood Residents.

Mayor Taylor called upon the citizens registered to speak.

Paula Bondurant stated that she was the President of the Monte Vista Historical Association and was opposed to the zoning request.

Dr. Homer Hayes stated that he was a resident of Mahncke Park and opposed to the zoning request. He spoke of the importance of following the Master Plan for the neighborhood and added that businesses should be encouraged to use vacant properties zoned for commercial use.

Mark Fassold addressed the City Council in opposition to the zoning request. He stated that the applicant was aware that the property was zoned "Residential" when he purchased it.

He noted that the Zoning Commission had denied the request and the City Council should also deny the request.

Cindy Comfort stated that she was a client of the applicant's and supportive of the zoning request. She noted that he had kept the exterior true to its roots and repurposed the interior.

Michael Stelzer addressed the City Council in support of the zoning request. He noted that the applicant, Andrew Guerra, had contacted the Mahncke Park Neighborhood Association and City Zoning Staff prior to purchasing the property.

Carlynn Ricks addressed the City Council in opposition to the zoning request. She stated that she had received 80 signatures from residents of Mahncke Park opposed to the request.

Collin Stone stated that he lives on Perry Court and supportive of the zoning request. He mentioned that there was an apartment complex on the street owned by the University of the Incarnate Word and stated that the home was not desirable as a single family residence.

Richard Felter, President of the Mahncke Park Neighborhood Association asked the City Council to uphold the decision of the Zoning Commission and deny the request.

Maria Olivarez stated that she resides at 147 Perry Court and was in support of the zoning request. She noted that Mr. Guerra had been a good neighbor and asked the City Council to approve his request.

Ruth Galaz stated that she was a property owner at 132 Perry Court and supportive of the zoning request. She noted that the renovated property had been significantly upgraded and that a mix of property uses already existed on the street.

Suzanne Menick stated that she was a Real Estate Agent and supportive of the zoning request. She noted that parking would occur in the rear off Burr Road. She mentioned that the property had been on the market for 451 days and felt this was the best use of the property.

Emily Johnson addressed the City Council in opposition to the zoning request. She expressed concern that the applicant had not adhered to the proper zoning in Mahncke Park.

Cathy Johnson stated that she resides at 138 Perry Court and supportive of the zoning request. She noted that Mr. Guerra had been a good neighbor and involved the neighborhood when transforming his property.

Dolly Holmes stated that she was the President-Elect of the Monte Vista Historical Association but had also lived in Mahncke Park for 17 years. She stated that she was opposed to the zoning request as the owner was aware of the zoning.

Francille Radmann stated that she was a long-time resident of Mahncke Park and opposed to the zoning request. She expressed concern with the continued pressure for change in Downtown Neighborhoods.

Joyce Felter stated that she had lived in Mahncke Park since the 1970's and was opposed to the zoning request. She stated that Perry Court was zoned as "Residential" and not "Commercial" and that they had worked very hard to protect the neighborhood.

Andrew Guerra, Property Owner and Applicant, addressed the City Council in support of his request. He stated that they would not be using Perry Court as the main entrance and asked for a Conditional Use for his Hair Salon. He noted that he had worked in Mahncke Park for the past 16 years and never had to advertise his salon. He showed photos of the remodel of the property and added that they had submitted an official address change to use Burr Road.

Don Gonzales addressed the City Council in support of the zoning request. He spoke of the great work by Mr. Guerra to remodel the home and asked that the staff recommendation be upheld.

Robert Charles addressed the City Council in support of the zoning request. He stated that he was also a small business owner and well aware of hardships due to unforeseen circumstances in business. He spoke of the work of Mr. Guerra to preserve the home.

Stephanie Reeves stated that she was Andrew Guerra's Wife and supportive of the zoning request. She noted that the home had been on the market for 451 days and that there had been no interest in purchasing the home as a Residential Property. She added that they would operate the business from Tuesday through Saturday during daytime hours.

Silvia McCollom stated that she lived at 158 Perry Court and was fully supportive of the conditional use request. She noted that the home had been restored and thanked Mr. Guerra for his work. She added that Mr. Guerra was meeting the goals of the neighborhood plan.

Alicia Perez stated that she is a resident of Mahncke Park and supportive of the zoning request. She noted that there were other small businesses in the neighborhood and was pleased with the investment and restoration of the property.

Councilmember Warrick asked of the zoning request. Mrs. Hernandez stated that the request was for "R-4 CD NCD-6," Residential Single-Family Neighborhood Conservation District with a Conditional Use for a Hair Salon. She noted that it could be used as a Hair Single-Family Residence, or both. Councilmember Warrick asked of the staff Salon. recommendation. Mrs. Hernandez replied that the lot was one of two remaining Single-Family Zoned Lots on the block and was adjacent to a Multi-Family Residence. She stated that there was Commercial Zoning on the block and that there were lots that could be developed as Commercial or Apartments. She added that the Hair Salon had one of the lowest impacts of Commercial Use and was a good example of a Conditional Use. Councilmember Warrick asked of the consensus on the Neighborhood Plan from 2001. Mrs. Hernandez stated that the R-4 and Multi-Family Residential Units were consistent with the Urban Low Density Designation. Councilmember Warrick thanked everyone that was in attendance and noted that the case was about land use. He noted that it was a difficult case as many of the property owners in the immediate area were supportive of the request. However, the greater Neighborhood Association was opposed to the request and they were unable to come to a compromise.

Councilmember Warrick moved to deny Item Z-1. Councilmember Treviño seconded the motion.

Councilmember Gallagher stated that the arguments were strong on both sides of the issue. However, he could not support the motion to deny due to the staff recommendation in favor of the request. He stated that it was a benefit for the neighborhood and that the owner had spent a great deal of money preserving the look of the neighborhood.

Councilmember Gonzales asked staff to speak to the conditional use permit. Mrs. Hernandez stated that staff had analyzed the Site Plan to understand the design. She noted that parking would occur in the rear of the structure and have minimal impact on Perry Court. She added that there were three conditions tied to the conditional use: 1) Must maintain the residential character; 2) Hours of operation are restricted; and 3) Limited to one sign of three square feet on the façade of the property. She stated that the base zoning must be maintained so it remained "Residential." Councilmember Gonzales asked Mr. Andrew Guerra it he would stay in this location for a while. Mr. Guerra replied that he would like to set roots and retire at this location.

Councilmember Saldaña stated that it was hard to dispute the level of investment by Mr. Guerra and looked to the neighbors for their input. He asked if this was strictly a conditional use for the Hair Salon. Mr. Rod Sanchez confirmed that it was. Councilmember Viagran asked what would occur if the zoning request was denied. Mr. Sanchez stated that it could only be used as a single family home if denied.

Mayor Taylor thanked everyone that was part of the process and stated that they needed to continue to have focused discussions about neighborhood change.

The motion to deny failed by the following vote:

Catherine Hernandez presented Item Z-5 and stated that staff and the Zoning Commission recommended approval with the following conditions: 1) A Minimum of a 5-foot front yard Type C Landscape Buffer; 2) All parking shall be located in the rear of the property with the exception of handicap spots in the front parking area; 3) Ingress shall be from Rigsby and egress onto New Braunfels; 4) Lighting must be directed away from residential areas; and 5) Hours of Operation to be Monday through Saturday 7:00 am to 6:00 pm. She

reported that of 24 notices mailed; 2 were received in favor and 1 was received in opposition. She added that no response was received from the Highland Park Neighborhood Association.

Mayor Taylor called upon the citizens registered to speak.

Bertha Saucedo addressed the City Council in opposition to the request. She stated that she operated a Child Care Center across the alley from the property in question and was concerned with the size of the building and large enough to be used as rental property.

Richard Medellin stated that the Highland Park Neighborhood Association had initially endorsed the project based on facts that could no longer be verified. He expressed concern that parking would be allowed in the front yard and that they had withdrawn their support due to the change in plans.

Councilmember Viagran asked for clarification of the Type C Landscape Buffer. Ms. Hernandez replied that the Type C Landscape Buffer is typically required between Neighborhood Commercial Uses and Residential Uses. She stated that it provides more shrubbery for screening and maintains Neighborhood Character. Councilmember Viagran called upon the applicant, Jose Martinez, and asked him of the Professional Office that he would be operating. Mr. Martinez stated that they had operated an Insurance Business on South New Braunfels since 2009 and they would continue to operate same at this location. He added that their intent was not to rent the space out. He stated that they had modified the parking to remove three spaces from the front and only keep the Handicap Parking Spaces in the front. He noted that they were working with VIA and had applied for a grant from San Antonio Growth for the Eastside (SAGE) to place some fencing along the property to keep homeless individuals from the property.

Councilmember Viagran asked of the signage on the property. Ms. Hernandez replied that one sign of three square feet could be attached to the front façade of the building. She noted that the Site Plan indicates where the Office Uses and Residential Uses are located on the property.

Councilmember Viagran moved to approve Item Z-5 with the conditions read by Ms. Hernandez. Councilmember Treviño seconded the motion. The motion with the conditions prevailed by the following vote:

- **ABSENT:** 3 Medina, Nirenberg and Krier
