The City Council of San Antonio convened in a Regular Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

Mayor Taylor announced that Councilmember Nirenberg was attending the meeting via videoconference from Wuxi, China.

- 1. The Invocation was delivered by Pastor Kevin Nelson, Calvary Baptist Church, guest of Councilmember Alan E. Warrick, II, District 2.
- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the Regular City Council Meetings of September 28 29, 2016

Councilmember Warrick moved to approve the Minutes for the Regular City Council Meetings of September 28-29, 2016. Councilmember Gallagher seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 8:

Councilmember Viagran seconded the motion.

City Clerk Vacek read the property description: The privately owned properties for temporary construction easements are out of New City Blocks 17487, 10568, 12175 and 12174, Real Property Records of Bexar County, Texas. These properties are depicted in the Overall Project Drawing Map marked Exhibit A-1 and along the route shown in Exhibit A-2 attached to the Ordinance and incorporated as part of this Motion.

Councilmember Treviño stated that he wanted to highlight this first step in the process for the City to purchase the Frost Bank Tower. Troy Elliott confirmed that this was the first step in the process toward the acquisition of the Frost Bank Tower. He noted that said item included the Notice of Intent and that staff would present the financing of the \$52 Million to the City Council in early December. He added that the City would look to close on the

property no later than December 22, 2016.

Councilmember Treviño moved to approve the Ordinance for Item 17. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Councilmember Gallagher asked staff to highlight the agreements. Emergency Operations Officer Lawrence Trevino stated that the Office of Emergency Management had worked with the Fire Department's Wildfire Team and Texas A&M Forest Service to develop a Wildfire Protection Plan. He noted that the Plan identified 500 Neighborhoods with an estimated 142,000 homes at a risk cost of \$3.8 Billion. He added that the Plan included 600 Mitigation Projects that would reduce that risk. Councilmember Gallagher expressed his support and stated that everyone needed to be aware that wildfires were a significant problem in San Antonio. Councilmember Nirenberg recognized Walter Ague from his staff for his work on the Wildfire Plan.

Councilmember Viagran expressed her support and stated that she was pleased with the efforts to ensure that San Antonio was prepared.

Councilmember Gallagher moved to adopt the Ordinance for Item 18. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Councilmember Krier asked staff to highlight the new Brush Collection Schedule. Xavier Urrutia stated that they were implementing a new schedule to address the issue with Oak Wilt. He noted that they had worked in collaboration with Solid Waste and Development Services to develop strategies for Oak Wilt suppression. David McCary presented information on Oak Wilt noting that it was a fungus that attacks Oak Trees. He mentioned that the fungus occurs from February through June and that is when staff will alter the collection schedule. He added that those affected would still receive Brush and Bulky Collection two times each per year. Councilmember Krier thanked staff for their work on the issue and asked of the requirements for Licensed Tree Trimmers. Mr. Urrutia replied that they would be required to receive training on same in order to become Certified.

Councilmember Nirenberg thanked everyone for their work on the issue and asked of outreach to Homeowners Associations. Mr. Urrutia stated that they were utilizing a Public Relations Campaign to include radio advertisements and Social Media. He noted that they would also provide notification through door hangers and provide information through SAWS and CPS Energy Newsletters.

Councilmember Medina thanked Councilmember Krier for his leadership to address the issue of Oak Wilt and stated that he was pleased that they were working to mitigate it.

Councilmember Krier moved to adopt the Ordinance for Item 20. Councilmember Medina seconded the motion. The motion prevailed by the following vote:

# **21.** City Manager's Report

Mrs. Sculley reported that the Development Services Department had received good news from the Insurance Services Office (ISO). She stated that the ISO was an Independent Organization that conducts evaluations on Building Code Enforcement Departments every 5 years and rates them on their effectiveness of enforcing Building Codes. She noted that the City of San Antonio was now recognized as the first city in Texas and one of only a dozen cities across the country to have achieved an Exemplary Building Code Effectiveness Grade of 1 for Commercial Properties and 2 for Residential Properties. She explained that the Rating Classification was on a scale from 1 to 10 with Class 1 representing Exemplary Commitment to Building Code Enforcement. She mentioned that San Antonio would be featured in Community Fire Protection News to highlight the Department's Work, Best Practices, and the road to having one of the Best Building Code Enforcement Departments in the nation.

Mrs. Sculley bid farewell to Martha Sepeda who has served the City of San Antonio as First Assistant City Attorney for the last 13 years. She reported that during that period, Martha filled in for two separate terms as City Attorney. She stated that Martha had been involved in a number of High Profile Issues including Collective Bargaining Negotiations, and had always served the City with Integrity and Professionalism. She noted that Martha has over 30 years of Legal Experience including work as the City Attorney in Del Rio, Chief of the Federal Public Defender's Office in Laredo, and Assistant City Attorney for the City of Laredo. She stated that Martha was a native of Monterrey, Mexico, grew up near Chicago, and graduated from the University of Chicago before heading to Law School at the University of Texas in Austin. She wished Martha well in her retirement. Mayor Taylor and the City Council thanked Martha for her service to the City of San Antonio and wished her well on her future endeavors.

# **EXECUTIVE SESSION**

Mayor Taylor recessed the meeting at 9:51 am to convene the previous day's Executive Session for discussion on the following:

#### **RECONVENED**

Mayor Taylor reconvened the meeting at 2:03 pm and announced that no action was taken in Executive Session.

# **CONSENT ZONING ITEMS**

Mayor Taylor announced that Item Z-8 was withdrawn by the Applicant and Items P-1 and Z-3 were being Postponed by the respective applicants. Items P-3 and Z-10 were pulled for Individual Consideration. Councilmember Medina moved to approve the remaining Consent Zoning Items. Councilmember Krier seconded the motion.

Mayor Taylor called upon Mr. Jack M. Finger to speak.

Mr. Jack M. Finger expressed concern that the World Heritage Buffer Zone included a one-mile radius (Item 22). He spoke in opposition to the Manufactured Housing Park and Home requested in Item Z-1 and Z-5, respectively. He stated that he was against the four dwelling units requested in Item Z-4.

Councilmember Viagran submitted a statement regarding Item 22 noting that it was the first of many steps toward putting together a coherent, common sense Land Use Plan in place around the new World Heritage Site. She wrote that she recently represented the City of San Antonio at the World Historical and Cultural Cities Expo in China and that she heard from many community members that there was only one chance to get this right. She wrote that she believed the city could balance the rights of businesses, residents, and visitors with the desire to respect the Heritage, History, and Culture that the Missions represent. She added that she looked forward to tackling the project with her Council Colleagues and continuing the conversation with District 3 Residents and all that loved the Missions. She wrote that they would work to ensure the growth and opportunity created by the World Heritage Designation was spread throughout the community so that everyone can benefit from the exciting changes in the future.
