The City Council of San Antonio convened in a Regular Council Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

**PRESENT:** 11 - Mayor Taylor, Treviño, Warrick, Viagran, Saldaña, Gonzales, Lopez, Medina, Nirenberg, Krier, and Gallagher

- 1. The Invocation was delivered by Pastor Scott Olsen, Trinity Church, guest of Councilmember Mike Gallagher, District 10.
- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the Regular City Council Meetings of December 14 15, 2016.

Councilmember Warrick moved to approve the Minutes for the Regular City Council Meetings of December 14-15, 2016. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

# POINT OF PERSONAL PRIVILEGE

Councilmember Warrick highlighted Black History Month and recognized Famous Blues Artist Mel Waiters. He provided background on Mr. Waiters' upbringing on the East Side and noted his accomplishments which include performing at the World Famous Carnegie Hall. He welcomed Mr. Waiters' Wife Portia and Daughter Brittany. Ms. Brittany Waiters thanked the City Council for the recognition of her father and stated that this was a great honor. Councilmembers Nirenberg and Medina also recognized Mr. Waiters and thanked the family for being present. Mayor Taylor stated that it was wonderful to recognize Mr. Waiters who was from San Antonio during Black History Month. She thanked Mr. Waiters' Family for carrying on his legacy.

# **ACTION ITEMS FOR STAFF BRIEFING**

City Clerk Vacek read the caption for Item 4:

#### 2017-02-09-0067

4. An Ordinance ordering a General Obligation Bond Election to be held on May 6, 2017 in the City of San Antonio, Bexar County, Texas on a proposed bond issue for Streets, Bridges, and Sidewalks Improvements; Drainage and Flood Control Improvements; Parks, Recreation, and Open Space Improvements; Improvements; Safety **Facilities** Public Facilities Improvements; Neighborhood Improvements; specifying that the Election shall be held jointly with other participating local political subdivisions within Bexar County; making provision for the holding of this election; and providing for an effective date. [Peter Zanoni, Manager; Mike Frisbie, Director, Transportation Deputy City Capital Improvements]

Mike Frisbie presented a Power Point outlining the Proposed 2017-2022 Bond Program. He noted the Community Process and presentations made to the City Council on the recommended projects. He stated that there were six Bond Propositions with a total of 180 Projects. He highlighted each Proposition and reported that there would not be a Property Tax Increase. He added that the Election would be held on May 6, 2017.

Mayor Taylor called upon Mr. Jack M. Finger to speak.

Jack M. Finger spoke in opposition to the Bond Program and stated that General Funds should be utilized to fix roads instead of asking voters for Bond Funds.

Mayor Taylor thanked everyone for their work and acknowledged the Tri-Chairs-Carri Baker, Eddie Aldrete, and Darryl Byrd. She recognized the community volunteers that vetted the project list to ensure that the Bond Proposal represents the Community's Priorities.

Councilmember Viagran also thanked everyone that was engaged in the process and recognized two of her Committee Members that were present. She stated that she was pleased with the funding for sidewalks and that there would not be a Property Tax Increase.

Councilmember Gonzales thanked all for their work and asked where residents could get a Bond Brochure. Mr. Frisbie replied that they would be available at the District Field Offices, Libraries, and City Facilities. In response to Councilmember Gonzales, Mrs. Sculley noted that they could add Council District Contact Information and that the brochures would also be available online in English and Spanish. Councilmember Gonzales asked if information on projects with multiple sources was included in the Bond Brochure. Mr. Frisbie replied that they noted the leveraging of funds on projects but not the specific amounts as some were yet to be determined.

Councilmember Saldaña thanked the Tri-Chairs and his District 4 Community Members for their work. Councilmember Lopez also thanked everyone for their work on the Bond Program and highlighted the work of the Neighborhood Improvements Committee which was a new category. Councilmember Nirenberg acknowledged and thanked the citizens that participated in the Bond Process and stated that this was a transformative Bond Program.

Councilmember Warrick thanked staff, citizens, and Committee Members that participated in the Bond Process. He stated that he was pleased with the leveraging of funds and spoke of the importance of educating the community. Councilmember Medina added his thanks to everyone involved in the Bond Program.

Councilmember Krier expressed his support and thanked all that worked on the Bond Program. He stated that he was pleased with the leveraging of funds and that there would not be a Property Tax Increase. He highlighted projects in District 9 and asked of the projects with leveraged funds. Mrs. Sculley replied that they had leveraged \$350 Million in funds and had executed Memorandums of Understanding with each of the organizations bringing funds to the table.

Councilmember Gallagher stated that the Bond Program was a huge investment for the City's future and asked of the impact of not approving the program. Mr. Frisbie replied that there were a great number of infrastructure needs in the community that would have to rely on the Annual Budget Process if the Bond Program was not approved. He noted that these funds were limited and would not be able to solve major drainage and street issues. He added that the price of construction would likely increase in the future and would increase project costs.

Councilmember Treviño thanked everyone for their work on the Bond Program and asked of the Context Sensitive Design. Mr. Frisbie explained that this concept referred to a process in which they would review the context of a project a month or two prior to implementation. He noted that they would look at aesthetics, bicycle lanes, landscaping, and other features of the area to help protect the investment. Councilmember Treviño stated that he was pleased that they were able to include a potential project list if funding was available.

Councilmember Viagran moved to adopt the Ordinance for Item 4. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

5. An Ordinance ordering the General City Election to be held on Saturday, May 6, 2017 and a Run-off Election to be held on Saturday, June 10, 2017, if necessary; and setting election procedures. [Leticia M. Vacek, City Clerk]

City Clerk Leticia Vacek presented a Power Point regarding the General Election to be held on Saturday, May 6, 2017. She stated that residents would have the opportunity to elect the Mayor and City Councilmembers (Places 1-11) and also vote on Six Bond Propositions totaling \$850 Million. She outlined Key Dates noting that the last day for Residents to Register to Vote in the Election was Thursday, April 6th. She mentioned that Early Voting by Personal Appearance would be held from April 24-May 2, 2017 at various locations. She reported that the last day for Bexar County to receive a request for a Mail Ballot was Tuesday, April 25th. She stated that Election Day was Saturday, May 6th and that polls would be open from 7:00 am to 7:00 pm. She added that the Election Results would be canvassed at a B Session/Special Meeting on Wednesday, May 17th at 2:00 pm.

Mrs. Vacek presented a list of 43 Early Voting Sites and noted that Early Voting would not be conducted on the following dates/locations:

- 1)Friday, April 28th–All Sites (Battle of Flowers Holiday)
- 2)Saturday, April 29th-Bexar County Justice Center and Windcrest Takas Park Civic Center
- 3) Sunday, April 30th-All Sites

She stated that the Early Voting Sites were subject to change as the last day for entities to cancel their Elections was February 17th.

Mrs. Vacek stated that the Contract for Election Services with Bexar County for the General and Bond Election was estimated not to exceed \$400,000 and would be presented at a later date. She noted that the cost was based on the number of entities participating in the May Joint Election. She indicated that if a Run-Off Election was necessary; said date was set for Saturday, June 10, 2017 and was included in this Ordinance. She noted that Early Voting for the Run-Off was scheduled for May 30-June 6, 2017 with the Canvassing of Election

Returns and Swearing-In of the 2017-2019 Mayor and Council scheduled for June 21, 2017. She added that the Election was ordered and conducted in accordance with the Voting Rights Act, Texas Election Code, Government Code, Local Government Code, City Charter, and any other applicable law. She mentioned that the Ordinance Ordering the General Election was coordinated with the Office of the City Attorney and Bexar County Elections Office and that staff recommended approval.

Councilmember Viagran moved to adopt the Ordinance for Item 5. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

Councilmember Saldaña stated that the issue of Truancy had come to light in 2013 when there was State Legislation requiring cities across the State to better focus on students that were missing school. He noted that students who drop out of school are likely to end up incarcerated, in poverty, and less likely to get a good-paying job. He stated that he had chaired a Truancy Committee to discuss ways to improve services in San Antonio. He mentioned that they had consolidated all Truancy Cases to go through the Municipal Court System and created Diversionary Contracts with parents and students to get them back on track.

Councilmembers Nirenberg and Treviño commended Councilmember Saldaña and the Truancy Committee for their work to address the issue.

Councilmember Saldaña moved to adopt the Ordinance for Item 10 with the amendment that the grant application be authorized in an amount up to \$2,000,000. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Councilmember Medina asked for a brief presentation. Bridgett White presented a Power Point and stated that they were requesting consideration of Resolutions of Support for 5 Multi-Family Rental Housing Development Projects by applicants seeking competitive 9% Housing Tax Credits with the Texas Department of Housing and Community Affairs She reported that the current year applications were due to TDHCA by March 1st and that projects could receive 17 points for a Resolution of Support or 14 points for a Resolution of No Objection. She mentioned that the City Request for Applications Period was open from December 12th through January 4th. She reported that applications earning at least 85 points were eligible for a Resolution of Support. She stated that of 16 applications received; 9 have withdrawn. She noted that two applications were recommended by the Housing Committee and five projects were recommended Resolutions of Support. Councilmember Medina stated that the projects would provide affordable housing for working families. He asked how Neighborhood Associations were notified. Ms. White replied that the Developer would notify the Council Offices and could require them to notify Neighborhood Associations.

Councilmember Gonzales clarified that the Rio Lofts Project was located in District 5 and

expressed support for the projects.

Councilmember Medina moved to approve the Resolutions for Items 14A through 14E. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

# 15. City Manager's Report

# **REVENUE CAPS**

Mrs. Sculley highlighted an article from the Dallas Morning News regarding the State Legislature's Proposal to limit cities' abilities to raise revenues. She stated that limiting a city's ability to raise Property Tax Revenue to keep pace with growth could have disastrous consequences to the City of San Antonio Budget. She reported that the City of San Antonio makes up only 22% of the Property Tax Bill in Bexar County and the legislation does not address rising Property Valuations or Public School Finance. She stated that the City of San Antonio has not raised the Property Tax Rate in 24 years and has lowered the rate seven times during that period. She noted that if a 4% Revenue Cap had been State Law for the past decade; it would have cost the City of San Antonio nearly \$300 Million over 10 years. She added that the City's Team would continue working with the Bexar County Delegation in the House and Senate to prevent legislation that would negatively impact San Antonio's ability to maintain a healthy fiscal outlook.

# **SMART CITIES**

Mrs. Sculley reported that San Antonio was one of 10 Cities selected to participate in Envision America 2017. She stated that Envision America was a nationwide Non-Profit supported by the White House in 2015 that issues a challenge to cities to become smarter in accelerating deployment of Innovative Technologies. She noted that Envision America aims to connect the resources of the Private Sector with the innovative spirit of Urban Communities to help create America's New Smarter Future. She mentioned that the City of San Antonio was selected to participate due to the "SA-Trip" Project that was approved by the City Council as part of the FY 2017 Budget. The purpose of SA-Trip is to ensure that people get around the city safely and efficiently. She noted that with the implementation of technology; SA-Trip will gather real-time traffic data along two of the busiest corridors in the South and North Areas of the city: Military Drive on the South Side and Blanco Road on the North Side. She stated that data would be collected to manage traffic congestion and sensors would be installed at several intersections to detect a pedestrian in the walkway and hold

vehicular traffic until the pedestrian has crossed the intersection. The data will be fed into an application which will be used to provide real-time notifications so residents can make informed travel decisions. She added that they were pleased to participate in this program and receive the recognition.

# FY 2016 SBEDA ANNUAL REPORT

Mrs. Sculley reported that today, the City's Economic Development Department released its Fiscal Year 2016 Annual Report for the Small Business Economic Development Advocacy Program (SBEDA). She stated that the SBEDA Program incentivizes the utilization of Small, Minority, and Women-Owned Businesses on City Contracts at the Prime Contractor and Subcontractor Level. She noted that in FY 2016; \$208 Million or 45% of City Contract Dollars were paid to Small, Minority, and Women-Owned Businesses. She indicated that this represented an increase of \$40 Million in utilization compared to FY 2015. She reported that \$152 Million of the \$208 Million was paid to Minority and Women-Owned Businesses. She mentioned that the SBEDA Annual Report included updates on the City's Mentor Protégé Program which builds the capacity for Certified Businesses through Mentoring and Educational Opportunities. She added that recent amendments to the SBEDA Ordinance should further help the City of San Antonio attain its goals in utilizing Small, Minority, and Women-Owned Businesses on City Contracts.

# STATE LEGISLATIVE UPDATE

Mrs. Sculley provided a brief update on the activity at the State Legislature in Austin. She reported that one month into the Session; Legislators have filed 2,500 Bills and the City of San Antonio was tracking more than 500 that could impact the city. She stated that the Bill Filing Deadline was one month out and anticipated Legislators would file significantly more bills than last session. She noted that staff has been at the Capitol daily for the past few weeks, discussing Legislative Priorities and the potential impact of Legislation with Members of the Legislature, Texas Municipal League, and other Large Cities.
