The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call and noted the following Councilmembers present:

PRESENT: 10 - Mayor Taylor, Treviño, Warrick, Viagran, Saldaña, Lopez, Medina, Nirenberg, Krier and Gallagher

ABSENT: 1 - Gonzales

Mrs. Vacek announced that Councilmember Gonzales was out on City Business attending the 2017 Women in the World Summit.

1. The Invocation was delivered by Reverend Dave Felps, Pastor, Chapel Hill United Methodist Church, guest of Councilmember Rey Saldaña, District 4.
2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the Regular City Council meetings of February 22-23, 2017.

Councilmember Warrick moved to approve the Minutes for the Regular City Council meetings of February 22-23, 2017. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

POINTS OF PERSONAL PRIVILEGE

Mayor Taylor presented a Proclamation acknowledging the Centennial of Kelly Air Force Base and recognized Port SA Board Members Chris Alderete and Juan Solis, Port SA CEO Roland Mower, Colonel McClintock, Virginia Van Cleave and Rosalie Pesina. They thanked the City Council for the recognition and spoke of the great investments that had been made at Port SA. The City Council expressed congratulations on the 100-Year Anniversary of Kelly and thanked everyone for their work.

Mayor Taylor recognized Councilmember Saldaña who called upon Kim Abernathy of ChildSafe to speak on the issue of child abuse and neglect. Ms. Abernathy highlighted ChildSafe's Cardboard Kids Campaign to bring awareness to the issue and spoke of their accomplishments thus far. She thanked the City Council for their continued support of ChildSafe. The City Council thanked Ms. Abernathy and ChildSafe for their work to bring awareness and address the issue of child abuse.

Councilmember Lopez recognized his Senior Executive Secretary, Vicky Salazar, who would be retiring after 20 years of service with the City of San Antonio. He thanked her for great work over the years and wished her well in her future endeavors. Mayor Taylor and the City Council thanked Ms. Salazar for her service to the City of San Antonio.

CONSENT AGENDA ITEMS

Item 8 was pulled for Individual Consideration. Councilmember Warrick moved to approve the remaining Consent Agenda Items. Councilmember Treviño seconded the motion. Mayor Taylor called upon the citizens registered to speak.

Jack M. Finger spoke in opposition to the professional services agreement with Pape-Dawson Engineers (Item 16) due to the campaign finance contributions they made to various City Councilmembers.

Rhett Smith expressed concern with the lack of access to Elected Officials and stated that

there were ways to use the Internet to make the city more efficient. He added that the State Legislature could also do the same so that citizens were made aware of what was occurring throughout the session.

Mike Hylander expressed concern that he had done as he was instructed by the 3-1-1 Operator regarding brush and bulky collection and received a \$300 fine from Code Compliance. He asked that citizens not be penalized for following what was instructed by city staff.

17. City Manager's Report
A. State Legislative Update

Jeff Coyle reported that there were 54 days remaining in the 85th Legislative Session with the last day for House Committees to report House Bills being Monday, May 8th. He highlighted the status of bills related to Revenues Caps (Senate Bill 2) and Annexation (SB 715 and 1878/HB 424 and 3214). He provided an update on the following City Priorities: 1) Protection of Military; 2) Economic Competitiveness; 3) Alamo Funding; and 4) Transportation. He outlined bills regarding Rideshare Companies, Solid Waste Collection in County, Small Cell Deployment, Debt Transparency, Animal Care, and Short-term Rentals. He mentioned moving bills with regard to the Budget, Sanctuary Cities, and Statewide Texting. Councilmember Krier thanked Mr. Coyle for organizing the team's presentation on Annexation the previous day. He also thanked General Pringle for spending the day in Austin advocating on the City's behalf.

Councilmember Nirenberg referenced Senate Bill 744 and asked that the City of San Antonio not take a position that would weaken the Tree Ordinance. Councilmember Viagran thanked Councilmember Krier and City Staff for their work on the Legislative Session.

Mayor Taylor recognized Councilmember Ron Nirenberg who would be celebrating his birthday on April 11th. The City Council wished Councilmember Nirenberg a Happy Birthday.

RECESSED

Mayor Taylor recessed the meeting at 10:22 am and announced that the meeting would resume at 2:00 pm for Zoning.

RECONVENED

Mayor Taylor reconvened the meeting at 2:03 pm and addressed the Consent Zoning Items.

Jack M. Finger spoke in support of the four single-family dwellings requested in Item Z-3. He stated that he was opposed to the hotel request in Item Z-19 noting that there had been opposition at the Zoning Commission Meeting. He expressed concern with the multi-family housing requested in Item Z-21.

Steve Martin stated that he was representing the applicant in support of Item Z-9. He stated that they would continue to operate a convenience store but would like to add an automated carwash.

Jose Mascorro stated that he worked for Prospera Housing Community Services, a non-profit affordable housing entity in San Antonio, who are opposed to the zoning request (Item Z-23). He expressed concern with the open storage of tires and freight containers.

Councilmember Nirenberg submitted a copy of the Restrictive Covenants that were executed for Item Z-16.
