The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

1. The Invocation was delivered by Reverend David G. Read, Rector, St. Luke's Episcopal Church, guest of Councilmember Mike Gallagher, District 10.
2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.

POINT OF PERSONAL PRIVILEGE

Mayor Taylor recognized the United States Army's 242nd Birthday and called upon Colonel Martha Brooks, Director of Public Affairs for United States Army North. Colonel Brooks noted the birth of the Army on June 14, 1775 and called upon Lieutenant General Jeffrey Buchanan, Commanding General of United States Army North. Lieutenant General Buchanan thanked the City Council for the recognition. The oldest and youngest service members cut a cake honoring the Army's Anniversary. The City Councilmembers thanked

the Army for their service and wished them a Happy Birthday.

Colleen Swain presented a power point and stated that staff was requesting approval of four items: 1) Transfer of the former streets of Mission, Napier, Woodhull, and Trawalter to the National Park Service (NPS); 2) Transfer and exchange of six city-owned properties to the NPS; 3) Memorandum of Understanding (MOU) for 5.5 acres to protect the viewshed of Mission San Jose; and 4) Acceptance of NPS property for a right turn lane. She noted that the city properties requested by NPS were critical to their long range master plan and that they would continue to use the properties for park and open space. She added that the right turn lane on Napier Avenue was requested by residents and would improve the traffic flow exiting the national park. She invited Mardi Arce, Superintendent of San Antonio Missions National Historical Park to speak. Ms. Arce spoke of the importance of the project to the NPS and highlighted the Visitor Center on a map. She noted the need for the turn lane that will help both park visitors and the neighborhood.

Mayor Taylor called upon Mr. Jack M. Finger to speak.

Jack M. Finger asked if the city was giving away too much land to the Federal Government. He commented on the Birthday of the US Army noting that the military afforded him the ability to speak.

Councilmember Viagran asked if the land in the MOU would be kept as open space. Ms.

Arce replied yes. Councilmember Viagran stated that she pulled said item as it was a big step forward in the process with the World Heritage Plan and working with the neighborhoods. She entered into the record letters of support from the San Antonio River Authority, Los Compadres de San Antonio Missions, South Central Alliance of Neighborhoods, East Pyron-Symphony Lane & Hot Wells Neighborhood Association, Rogelio Martinez, and Mardi Arce.

Councilmember Krier commended Councilmember Viagran for her work on the Missions and thanked the National Park Service for their partnership.

Councilmember Sandoval asked of the bicycle or pedestrian infrastructure included in the turn lane. Ms. Swain replied that there was not enough room for a bike lane but noted that improvements would be made through the Bond Program.

Councilmember Viagran moved to adopt the ordinances for Items 8A, 8B, 8C, and 8D. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Xavier Urrutia presented a power point and stated that during the 2015 Texas Legislative Session; State Representatives Trey Martinez Fischer and Justin Rodriguez had championed funds to be included in the Texas Parks and Wildlife Budget for Woodlawn Lake Park and Monterrey Park. He noted that said ordinance would accept the \$1.75 million local park grant and provide the required matching funds identified in the 2014 Bond. He outlined the proposed capital projects within each park: 1) Monterrey Park: Sports fields and general park improvements; and 2) Woodlawn Lake Park: Development of a multi-generational center.

Councilmember Sandoval asked of the cost of the multi-generational center. Mr. Urrutia replied that it was budgeted at \$6.5 million. Councilmember Sandoval expressed her thanks to Representatives Martinez Fischer and Rodriguez for helping secure the funding.

Councilmember Gonzales asked of the total for Monterrey Park. Mr. Urrutia replied that the total was \$725,000. Councilmember Gonzales asked of community input. Mr. Urrutia stated that they would follow the usual process that would include community input.

Councilmember Nirenberg asked if the matching city funds had been allocated to any other projects. Mr. Urrutia confirmed that they had not been allocated and that staff had identified the matching funds through the Bond Program. He added that there was no fiscal impact to any existing parks projects.

Councilmember Sandoval moved to adopt the ordinance for Item 9. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

Councilmember Gonzales requested a brief presentation. Dr. Colleen Bridger stated that on May 1, 2016, the Centers for Medicare and Medicaid Services approved a 15-month extension of Texas' Medicaid 1115 Waiver. On January 30, 2017, the Texas Health and Human Services Commission (HHSC) requested an additional 21-month extension. She noted that the program evaluation assesses the impact of interventions and is a requirement of HHSC for sustainability. She mentioned that the Teen Pregnancy Prevention Program benefits were associated with the goal of reducing the teen pregnancy rate among females ages 15-19 in San Antonio and Edgewood Independent School Districts. She added that the Baby Café Program benefits were associated with the goal to increase breastfeeding initiation and duration rates of women accessing Baby Café services. She reported that the department had identified two qualified vendors through an informal bid process: 1) Teen Pregnancy Prevention – UTSA Department of Kinesiology, Health & Nutrition; and 2) Baby Café – Erica T. Sosa, PhD, MCHES. She added that the funds were budgeted within Metro Health's 1115 Medicaid Waiver Fund.

Mayor Taylor called upon Mr. Jack M. Finger to speak.

Jack M. Finger spoke in opposition to the Teen Pregnancy Prevention Program and asked if reductions in pregnancies were due to abortions.

Councilmember Gonzales asked if the funding was contingent on the evaluations. Dr. Bridger replied that they received funding if they accomplished their goals. Councilmember Gonzales spoke of her experience with the Baby Café and expressed her support for both programs.

Councilmember Viagran asked if there had been a decrease in the Baby Café Program due to current events. Dr. Bridger replied that there had not been a decrease in program participation.

Councilmember Sandoval asked of the targets for the program. Dr. Bridger replied that their goal was to provide comprehensive sex education to 2,500 middle and high school students and had accomplished 100%. She added that they would share the results of the evaluations with the City Council.

Councilmember Gonzales moved to adopt the ordinance for Item 11. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

13. City Manager's Report

AIRPORT CANOPIES

Mrs. Sculley reported that a new customer service enhancement had been completed at the airport in time for summer. She stated that four umbrella-like canopies were installed along a portion of the lower level outer pick-up curb to provide shade for passengers waiting for shuttles. She noted that they would serve as an interim solution while a longer term solution is developed. She added that cold water bottles would be made available to passengers in several locations in the parking garage.

ILLEGAL DUMPING INITIATIVES

Mrs. Sculley reported that the Solid Waste Management Department had received a \$72,000 grant in FY 2017 from the Texas Commission on Environmental Quality through the Alamo Area Council of Governments to reduce illegal dumping by educating residents on free alternatives. She stated that the focus of the grant was a magnet depicting the four locations of the city's free bulky drop-off centers. She noted that the magnets were currently being delivered door-to-door with Solid Waste curbside brush collection notification. She added that delivery was scheduled for completion in two to three months. She mentioned that the education campaign includes neighborhood billboards that will run for eight weeks, focusing on areas with a high concentration of illegal dumping, directing residents to sure free bulky drop-off centers. She stated that in a concurrent program; the Development Services Department was allocated \$100,000 from the Smart Cities Budget for the creation of a pilot program to detect, curb, and enforce illegal dumping throughout the city. She noted that they had partnered with CPS Energy and TCI to deploy 12 cameras to known dumping areas in the community.

YANAGUANA GARDEN AND PLAYGROUND

Mrs. Sculley also reported that the Yanaguana Garden and playground had been recognized as one of the Best Playgrounds in 2017 by "Play Across America." She stated that "Play Across America" was a national blog that connects families through a website and free mobile application that helps them find and share playgrounds wherever they go. She highlighted features of the park and stated that she appreciated the recognition.

AMERICAN PUBLIC WORKS ASSOCIATION 2017 AWARDS

Mrs. Sculley recognized the TCI Department for being recognized by the Texas Chapter Awards Committee of the American Public Works Association. She stated that the awards recognize outstanding individuals and groups that represent the best in the Public Works profession. She noted the five top Public Works Awards received by the City of San

Antonio: 1) Top Public Works Leader of the Year Award, Mike Frisbie; 2) Public Works Project of the Year awarded to three projects (Hemisfair Interior Area Streets, Hemisfair Historic Homes, SA Tomorrow Multimodal Transportation Plan); and 3) Diversity Exemplary Practices Award for the City of San Antonio's 5-Year Diversity Plan. She congratulated TCI on the awards.

POINT OF PERSONAL PRIVILEGE

Mayor Taylor recognized Councilmember Shirley Gonzales who would be celebrating her birthday on June 2nd. The City Council wished Councilmember Gonzales a Happy Birthday.

City Clerk Vacek read the caption for Item 14:

14. Second Public Hearing regarding the annexation of the Neal Road Area consisting of approximately 5.9 square miles generally located north of South Loop 1604 East, east of Applewhite Road, west of Pleasanton Road, and south of Mauermann Road, adjacent to the City limits of San Antonio in south Bexar County within the City of San Antonio's Extraterritorial Jurisdiction (ETJ). [Peter Zaroni, Deputy City Manager; Bridgett White, Director, Department of Planning & Community Development]

Mayor Taylor opened the second public hearing regarding the annexation of the Neal Road Area.

Bridgett White provided an overview of the Neal Road Area consisting of approximately 5.9 square miles. She stated that the area had a number of agricultural uses, vacant land, residential uses, and a sparse number of commercial properties. She noted that annexation would provide protection of environmentally sensitive areas and protect economic development investment in the area. She added that property owners received written notification and this was the second of two public hearings required.

There being no citizens registered to speak; Mayor Taylor closed the public hearing. No action was required for Item 14.

Melissa Ramirez presented Item Z-6 and stated that staff and the Zoning Commission recommended approval with the following conditions: 1) A six foot solid screen fence is required around the property that abuts residential property and/or land uses; 2) All on-site lighting shall be directed onto the site and point away from any surrounding residential uses; 3) Outdoor amplification speakers are not allowed during the hours of 7 pm and 7 am; 4) The storage of the appliances is confined to 1,000 square feet in the back of the building of the property and must be screened with a solid screen fence; and 5) Outdoor display is permitted in front of the building, but is limited to no more than 200 square feet. She reported that of 32 notices mailed; one was returned in favor and three in opposition. She added that the applicant was requesting a continuance.

Mayor Taylor called upon the citizens registered to speak.

Primrose Ladduwahetti stated that she was the applicant and would like to request a continuance.

Peter Martino stated that he was supportive of the request.

Salvador Aguilar stated that he lived in the neighborhood and was supportive of the request.

Councilmember Sandoval moved to continue Item Z-6 until August 3, 2017. Councilmember Nirenberg seconded the motion. The motion to continue prevailed by the following vote:
