The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the Regular City Council meetings of May 3 4, 2017.

Councilmember Warrick moved to approve the Minutes for the Regular City Council meetings of May 3-4, 2017. Councilmember Gallagher seconded the motion. The motion prevailed by the following vote:

Mayor Taylor recognized the NEISD Robotics Team that won first place and the Harlandale ISD STEM Team that won second place at the Regional Marine Advanced Technology Education Competition in May. She congratulated the students and their coaches and wished both teams well in the upcoming international competition. The City Councilmembers congratulated all of the students and wished them good luck on the next competition.

Councilmember Lopez highlighted the Northwest Area Recreation Center Project (Items 18A and 18B) and recognized 210 Developers for their investment.

Councilmember Treviño recognized District 1 Ambassador Interns Nabil Kapasi and Samantha Montez and welcomed all of the summer interns to the city.

City Clerk Vacek read the caption for Item 10:

An Ordinance authorizing an amendment to an Advanced Funding Agreement with the Texas Department of Transportation for the City to accept an additional \$9,542,584.00 from federal funds and an additional \$1,025,827.00 from State funds for a total not to exceed amount of \$18,262,586.00 for project costs related to the construction of the Harry Wurzbach at Austin Highway Intersection Improvements Project, located in Council Districts 2 and 10, and authorizing payment in the amount of \$23,667.00 to TxDOT for the increase in State oversight due to an increase in scope. [Peter Zanoni, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Councilmember Gallagher requested a brief presentation. Razi Hosseini presented the project was located at the intersection of Harry Wurzbach and Austin Highway north of

Fort Sam Houston. He explained that the scope was to improve mobility and provide connectivity between Harry Wurzbach and Austin Highway and create a Single Point Urban Interchange (SPUI). He stated that connection ramps would be installed and that bike lanes and sidewalks would be constructed. He noted that construction would begin in August 2018 and be completed in January 2020. He added that staff was requesting approval to accept additional funding in the amount of \$9.5 million from Federal Funds and \$1 million in State Funds. Additionally, to authorize payment to the Texas Department of Transportation for state oversight in the amount of \$23,667. Councilmember Gallagher stated that he was pleased with the partnership among federal, state and local entities and highlighted the SPUI.

Councilmember Gallagher moved to adopt the ordinance for Item 10. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 12:

An Ordinance authorizing a Task Order Contract with Flasher Equipment Co. in an amount not to exceed \$1,699,364.35 for projects in support of the Bike Infrastructure Management Program and intersection improvements for special traffic calming and Vision Zero pedestrian safety projects. [Peter Zanoni, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Councilmember Gonzales requested a brief presentation. Art Reinhardt presented the annual on-call contract to support the Bike Infrastructure Management Program (IMP). noted that staff recommended approval of a contract with Flasher Equipment Company in an amount not to exceed \$1,699,364.35. He outlined the project scope to include intersection improvements, traffic calming devices, and addressing Vision Zero. Councilmember Gonzales expressed her support and stated that it was important to address bicycle and pedestrian safety. She asked if projects had already been identified. Mr. Reinhardt replied that the projects had been identified through the IMP and that they had been selected using the 2011 Bike Master Plan.

Councilmember Gonzales moved to adopt the ordinance for Item 12. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Councilmember Gonzales requested a brief presentation. Razi Hosseini presented background information on the project noting that they had reconstructed 2.5 miles of roadway on Theo and Malone Corridors to include a parking lane, bicycle lane, sidewalks, and storm drainage improvements. He highlighted current conditions and noted that improvements would include new curbs, ADA compliant sidewalks, driveways & pavement resurfacing along adjacent streets. He added that the project would be completed in August. Councilmember Gonzales stated that she pulled the item to highlight that it was a large bond project from 2012 that would be very impactful to the community.

Councilmember Viagran added her support and stated that she was pleased with the improvements that would be made.

Councilmember Gonzales moved to adopt the ordinance for Item 14. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

25. City Manager's Report

SUMMER AMBASSADOR PROGRAM

Mrs. Sculley reported that the city's Summer Ambassador Program kicked off the 13th year of the program on May 22nd. She stated that the program was implemented in 2004 as a workforce development initiative designed to connect college students with summer employment opportunities to encourage them to remain in or return to San Antonio following graduation. She noted that the program began with 60 students and has since doubled to serve 120 students thanks to the support of the City Council. She thanked the private, non-profit employers, public utilities and city departments for being partner

employer organizations.

PARKS SUMMER RECREATION

Mrs. Sculley also reported that the Parks Department would kick off their summer program activities this weekend. She mentioned the launch of the 2017 Fit Pass Program with a 5K at 8:00 am at Pearsall Park. She stated that Fit Pass was a program that offered participants an opportunity to accumulate points by participating in a variety of fitness, wellness, and nutrition events through July 29th. She noted that incentive prizes were offered at the end of the program for various levels of participation. She mentioned that the city's 23 outdoor swimming pools would be open this Saturday and remain open through August 13th. She also highlighted the Summer Youth Program which begins on June 12th and runs through August 4th at 60 locations across the city. She noted that the program operates Monday through Friday and includes a free lunch and snack. Lastly, she stated that families could still register and should visit the City of San Antonio Parks Department website for more information.
