City Clerk Leticia Vacek presented the official results of the June 10, 2017 Run-Off Election for Council Districts 1, 2, 6, 8, 9, 10, and Mayor. She presented the Total Votes Cast for each candidate in the Run-Off Election as follows:

Mrs. Vacek reported the total number of votes cast, including 13 provisional ballots, was 99,250 and the total number of registered voters for the City of San Antonio as of May 11, 2017 was 753,841. She stated that the voter turnout for the City of San Antonio Run-Off Election was 13.17%.
