CALL TO ORDER

Chairwoman Adriana Garcia called the meeting to order at 6:00 pm.

ROLL CALL

Mrs. Diaz called the roll noting that a quorum was present.

At this time, the ERB addressed Item 2.

2. Approval of the minutes of the ERB Meeting held on March 28, 2017.

Mr. De Leon moved to approve the minutes of the Ethics Review Board Meeting held on March 28, 2017. Mr. Van Kirk seconded the motion. Motion carried unanimously.

At this time, Mr. Shelton entered the meeting.

At this time, the ERB addressed Item 6.

6. Training on the Texas Open Meetings Act, Texas Public Information Act, San Antonio Ethics Code, and Municipal Campaign Finance Code.

Mrs. Kunau presented on the Texas Open Meeting Act, Texas Public Information Act, San Antonio Ethics Code and the Municipal Campaign Finance Code. She responded to questions regarding the various topics. She also referenced an overview of the Complaint Timeline provided to the board.

3. Approval of the ERB Annual Report

She noted that once the Municipal Campaign Finance Code was finalized; the panel would discuss and prepare a formal response to the City Council Governance Committee regarding the Council Consideration Requests.

Chairwoman Garcia stated that there were no additional questions or comments regarding the redlined version of the Ethics Code provided at the last meeting.

Chairwoman Garcia opened the floor for nominations for the position of Chair. Mr. Shelton moved to nominate Dr. Garcia as Chair. Mrs. McGee seconded the motion. There being no other nominations for Chair; the motion carried unanimously.

Chairwoman Garcia opened the floor for nominations for the position of Vice-Chair. Mr. Shelton moved to nominate Mrs. McGee as Vice-Chair. Mr. De Leon seconded the motion. There being no other nominations for Vice-Chair; the motion carried unanimously.

At this time, the ERB addressed Item 7.
