The City Council convened in a Regular Meeting. Deputy City Clerk Leticia Saenz took the Roll Call noting the following Councilmembers present:

Ms. Saenz announced that Councilmember Gonzales was running late as she was representing the City of San Antonio at the 3rd Annual National Latino Leadership Conference.

- 1. The Invocation was delivered by Reverend Robert Woody, The Episcopal Church of Reconciliation, guest of Councilmember John Courage, District 9.
- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the City Council Special Session of August 15, 2017 and the City Council Regular Meetings of August 16 17, 2017

Councilmember Treviño moved to approve the Minutes for the City Council Special Session of August 15, 2017 and the City Council Regular Meetings of August 16-17, 2017. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

#### **POINT OF PERSONAL PRIVILEGE**

Mayor Nirenberg spoke of the devastating earthquake that hit Mexico City and asked all for a moment of silence to recognize the many lives lost. He welcomed Reyna Torres Mendivil, Consul General of Mexico, and Bexar County Judge Nelson Wolff. Ambassador Mendivil expressed her appreciation for the solidarity and support from the City of San Antonio. spoke of Mexico's efforts to address the emergency including assessment, recovery, reconstruction. Judge Wolff thanked Mayor Nirenberg for his leadership on this effort and spoke of the friendship between San Antonio and Mexico. Mayor Nirenberg added that San Antonio was supportive of all that had experienced recent tragedies and would continue to be compassionate city. He recognized Frances Schultschik, President of Antonio/Mexican Friendship Council to speak. Ms. Schultschik thanked Mayor Nirenberg and the City Council for their leadership and support of Mexico. Mayor Nirenberg presented Ambassador Mendivil with a letter to Mexico on behalf of the City Council. The City Council expressed their support of Mexico and thanked everyone for being present.

will be financed through tax-exempt lease purchase financing or other financial obligations, contingent on the execution of a lease program schedule or other issuance approved by subsequent ordinance. [Erik Walsh, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Councilmember Sandoval highlighted said item and stated that it was extremely important in keeping Firefighters healthy. She requested a brief presentation. Mike Frisbie presented information on the San Antonio Fire Department (SAFD) Exhaust Ventilation Project and stated that it would provide direct capture of exhaust from apparatus and Emergency Management Services (EMS) Vehicles. He noted that they would install the new exhaust ventilation-capture systems in 52 Fire Stations as well as the SAFD Services/Logistics Facility. He reported that the project was scheduled for completion in October 2018 and that each ventilation system would become operational as it was installed at each facility. Fire Chief Charles Hood added that they had many discussions regarding Cancer in Fire Service and this was one way to make members safer. Councilmember Sandoval asked if there was currently any Environmental Health Staff available to identify potential reductions to health risks. Chief Hood replied that there was and would continue to work on ensuring a healthy environment for Firefighters.

Councilmember Pelaez commended the SAFD for their work and noted the great amount of research regarding the positive impact of reducing exposure to diesel fumes. Councilmember Brockhouse expressed his support and stated that he was pleased with making the environment safer and healthy for Firefighters.

Councilmember Treviño also expressed his support and stated that this was a best practice that he was glad to implement. Councilmember Perry asked if this was a new design for future fire stations. Chief Hood replied that it would be standard for all new stations.

Councilmember Sandoval moved to adopt the Ordinance for Item 15. Councilmember Brockhouse seconded the motion. The motion prevailed by the following vote:

He noted that they were also listed to receive federal funding for the project through the Alamo Area Metropolitan Planning Organization (MPO) Statewide Transportation Improvement Project for FY 2019. He reported that the Federal Highway Administration sent a termination letter stating that for safety reasons, they would not allow construction of new on and off ramps. He explained that they would reallocate the funding for three new projects: 1) South Presa Street; 2) Zarzamora Street Pedestrian Improvements; and 3) World Heritage Underpass Infrastructure. He stated that staff recommended approval of a Resolution to cancel the Presa Ramps Project, declaring as surplus bond funds previously allocated to this project, and adopting an Ordinance authorizing reprogramming of funds to the three new projects. He noted a correction within the backup memo which noted that \$3 million was being allocated to the Zarzamora Railroad Project but that was not the correct project. He stated

that the correct project that would receive the \$3 million was the Zarzamora Street Pedestrian Project from Fredericksburg Road to Southwest Military.

Councilmember Viagran stated that she was disappointed that the Presa Ramps at Highway 90 Project did not make it to fruition but was pleased that they were able to work with District 5 to move the new projects forward.

Councilmember Shaw highlighted the work of ChildSafe and recognized Kim Abernathy, ChildSafe President and CEO. Ms. Abernathy thanked the City Council for their support and recognized city staff for their work.

Councilmember Saldaña expressed his support and thanked Ms. Abernathy for her work. Councilmember Treviño stated that this was great for the community and he was proud to support it. Councilmember Brockhouse stated that he had the opportunity to visit ChildSafe a few weeks ago and commended them for their great work. Mayor Nirenberg expressed his support and recognized Harvey Najim for his efforts.

Councilmember Shaw moved to adopt the Ordinance for Item 23. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Pelaez highlighted the project and asked for a brief presentation. Rene Dominguez recognized representatives from Pelican Therapeutics, a Division of Heat Biologics, Inc. and provided an overview of the project. Councilmember Pelaez recognized Dr. Rahul Jasuja, CEO of Pelican Therapeutics. Dr. Jasuja addressed the City Council and thanked them for their support. Councilmember Pelaez expressed his support and thanked them for selecting San Antonio.

Councilmember Viagran expressed her support and stated that she was pleased with the investment. Councilmember Courage highlighted the Biomed Industry and spoke of its importance to the community. Councilmember Brockhouse also expressed his support noting that it was good for the community. He asked staff to look at providing these types of incentives in other areas that need them. Mayor Nirenberg added his support and thanked Pelican Therapeutics for their great work.

Councilmember Pelaez moved to adopt the Ordinance for Item 34. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Viagran highlighted Item 36 and recognized George Hempe, Executive Director of Workforce Solutions Alamo. She spoke of her work on the Committee of Six

and stated that she looked forward to continuing the good work.

Councilmember Viagran moved to adopt the Ordinance for Item 36. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

[Ben Gorzell, Jr., Chief Financial Officer, Troy Elliott, Deputy Chief Financial Officer]

Councilmember Courage expressed concern with Wells Fargo and stated that he did not believe they should be included as eligible brokers.

Councilmember Courage moved to strike Wells Fargo from the list of eligible broker dealers as shown in Exhibit 1 of the supporting documents and authorize the City's Investment Officers to find a reasonable alternative. Councilmember Shaw seconded the motion.

Councilmember Gonzales entered the meeting at this time.

Ben Gorzell stated that staff was requesting approval of an Investment Policy and Strategy that was required annually by State Statute. He noted that the list of brokers was included in the Investment Policy and that the process began a year ago through a Request for Qualifications. He mentioned that staff was aware of the issues with Wells Fargo and would continue to monitor their work. Councilmember Courage stated that Wells Fargo did not represent the best financial institution and that it was important to set the standard as a city.

Councilmember Pelaez stated that he understood the challenges related to Wells Fargo but noted their remediation efforts. He added that they were an important employer and great contributor to the community.

Councilmember Treviño stated that this was a big issue and he would like to have additional time to discuss the concerns. Mr. Gorzell explained that they needed to approve the Investment Policy before the end of the fiscal year to be statutorily compliant. He added that the City Council could approve the item and place Wells Fargo on hold until staff could have future conversations on moving forward.

After discussion, Councilmember Courage withdrew his motion.

Councilmember Treviño moved to adopt the Ordinance for Item 37 with the condition that staff not utilize Wells Fargo until the Council can have further discussion on the matter. Councilmember Courage seconded the motion.

Councilmember Perry asked how long Wells Fargo had been partners with the City of San Antonio. Mr. Gorzell replied that they had been partners for many years and had done well over the past nine months.

Councilmember Shaw asked if removing Wells Fargo from the pool would affect the City's credit rating. Mr. Gorzell replied that it would not affect the City's credit rating.

Councilmember Brockhouse clarified that the pool would be approved but Wells Fargo would not be utilized until further discussion occurred with the City Council. Councilmember Saldaña stated that he welcomed the opportunity to have further discussion regarding the pool of brokers.

Mayor Nirenberg stated that it was important to keep in mind how the city is best serving the tax dollars that are being invested. He made a friendly amendment that the pool be provided to the Audit City Council Committee for further discussion and possible action. Councilmembers Treviño and Courage accepted the friendly amendment. The motion to approve with the friendly amendment prevailed by the following vote:

[Carlos J. Contreras, Assistant City Manager; Jeff Coyle, Director,

# Government and Public Affairs]

Councilmember Treviño highlighted said item and asked staff for a brief presentation. Jeff Coyle stated that the City of San Antonio was committed to engaging the Spanish-speaking community in all City-related business. He noted that a contract had been approved with Solis Translations in March 2017 to provide written Spanish translations of City Council A and B Session agendas, memos, and selected City news release documents. However, the vendor was unable to fulfill the contract. He mentioned that on July 26, 2017, the City entered into a short-term professional services contract with Worldwide Languages & Communications to provide Spanish translation services. He indicated that the proposed contract would provide for a one-year term with the option to renew and extend the term with three additional one-year periods. He added that staff recommended approval. Councilmember Treviño stated that this was very important and thanked staff for their work.

Councilmember Pelaez thanked staff for their work and expressed his support. Councilmember Perry stated that he appreciated the work to be more inclusive; however, he was concerned with not reaching the hearing impaired. He asked that staff develop recommendations to address same.

Councilmember Sandoval stated that it was very important to continue the Spanish Translation Services and that they should embrace the City's heritage. She commended Councilmember Treviño for his efforts and thanked staff for their work. She asked how the services would be promoted. Carlos Valenzuela stated that they would work with Spanish Media to promote the services as well as create an infrastructure on Social Media. Councilmember Sandoval stated that she would like to see best practices for engaging the Spanish-speaking community that all city departments could use as a resource.

Councilmember Treviño moved to adopt the Ordinance for Item 39. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

Deputy City Clerk Saenz read the caption for Item 46:

An Ordinance authorizing a six-year contract and two optional one-year extensions with Alanis Wrecker Service to provide and manage storage services for the impounding, releasing and auctioning of vehicles for the San Antonio Police Department with revenue of approximately \$3.0 million, based on the graduated scale

of the Total Adjusted Gross Income, or 85% of Auction Sales and 2% of Impound Fees in revenue, whichever is greater of the two. [Erik Walsh, Deputy City Manager; William McManus, Chief of Police]

Councilmember Brockhouse requested a brief presentation. Erik Walsh presented information regarding the management of the Growdon Vehicle Storage Facility. He outlined the current contract in which an average of 27,000 vehicles are impounded and 5,600 vehicles auctioned annually. He noted that the contract expires on September 30, 2017. highlighted City Towing Services in which 54,000 policed-directed tows occurred by four subcontractors: 1) Mission Wrecker; 2) Richard's Towing; 3) Texas Roadside Towing; and 4) Texas Towing. He provided an overview of the solicitation requirements, evaluation committee, and score matrix. He stated that the recommended respondent was Alanis Wrecker Service who would subcontract with AutoReturn, who had national presence in major U.S. Cities. He outlined the contract terms and added that staff recommended approval.

Mayor Nirenberg called upon Mr. Patrick Christensen to speak.

Patrick Christensen expressed concern with the process noting that AutoReturn applied as a Prime Contractor and as a Subcontractor.

Councilmember Brockhouse stated that he also had some concerns with the process and asked of the impact of postponing the item. Mr. Walsh expressed concern with negotiating with the current company which they do not intend to keep and the quality of service that would be provided.

Councilmember Courage stated that the Audit Committee had reviewed the contract and asked how often that companies received multiple opportunities to bid on multiple projects. Mr. Walsh replied that he did not have an exact number but it was not uncommon.

Councilmember Pelaez stated that he was concerned with the process noting the intended purpose of the SBEDA Policy. Rene Dominguez stated that they encouraged small businesses to apply as Prime and Subcontracts in order to build capacity and was often done on construction contracts.

Councilmember Gonzales expressed concern with the lack of information provided to the Audit Council Committee. Ben Gorzell stated that the information provided to the Audit Council Committee was related to the process and that names of companies were not provided. He further noted that the scoring matrix did not include information regarding the names of companies due to the Ethics Code and restriction on communication.

Councilmember Shaw asked if the highest rated score had to be awarded the contract. Mr. Walsh replied that it was the decision of the City Council on who to award the contract to.

Councilmember Perry stated that it was standard practice to submit a proposal as a Prime and Subcontractor. He noted that he served on the Audit Council Committee and felt they received adequate information to bring the contract to the full City Council. He asked of the requirement that the Prime perform at least 51% of the work. Mr. Dominguez confirmed that was a requirement for Prime Small Businesses; however, in this case they have committed to perform 90% of the work.

Councilmember Perry moved to adopt the Ordinance for Item 46. Councilmember Treviño seconded the motion.

Councilmember Saldaña stated that it was his understanding that the rules were the same for all bidders and that they all received the same information.

Councilmember Treviño concurred with Councilmember Perry that this was standard practice and spoke of the city's work to make the process more inclusive for small businesses.

Councilmember Viagran stated that her issue with the process was regarding the process for selecting Evaluation Committee Members. Mr. Walsh replied that a member of the Executive Leadership Team and the Department Director were required to serve and explained the process for this selection.

Councilmember Brockhouse stated that his questions and concerns had been addressed; however, he would like to know the consequence of the Prime not performing the required amount of work. Mr. Dominguez replied that they had a robust monitoring system and payments were based on same. Councilmember Brockhouse stated that he would like to have a larger discussion on small businesses.

Mayor Nirenberg stated that he appreciated the comments and thanked staff for their work on small businesses. He noted that if they wanted to create opportunities for small businesses, this type of partnership should be encouraged.

The motion to approve prevailed by the following vote:

Councilmember Sandoval requested a brief presentation. Nefi Garza presented information regarding the release of two City-owned drainage easements. He stated that the easements must be released by the city prior to the developer establishing new easements. He provided a map of the location and subdivision layout. He added that the subdivision design meets storm water Code requirements. Councilmember Sandoval stated that she was pleased to see the on-site mitigation and asked of the detention pond. Mr. Garza replied that the Homeowners Association that would be established would be required to maintain the pond. Councilmember Sandoval confirmed that the developer would pay for the underground drainage. Mr. Garza stated that the developer would be responsible for same.

Councilmember Sandoval moved to adopt the Ordinance for Item 48. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Deputy City Clerk Saenz read the caption for Item 51A:

#### 2017-09-21-0714

51A. An Ordinance authorizing an agreement with the Bexar County Hospital District d/b/a University Health System (UHS) for adolescent health services to prevent teen pregnancy for the San Antonio Metropolitan Health District's Teen Pregnancy Prevention Medicaid 1115 Waiver Program in an amount up to \$325,000.00 for a

term commencing October 1, 2017 to September 30, 2018, and further provides two, one-year renewal options.

Councilmember Brockhouse requested a brief presentation. Dr. Colleen Bridger presented background information regarding the Teen Pregnancy Prevention Program and noted that the teen birth rate in Bexar County had declined 53% since 2006. She spoke of the use of Long Acting Reversible Contraceptives (LARCs) that were effective for preventing teen pregnancy. She stated that the agreement with University Health System would allow them to provide no-cost LARCs for female teens ages 13-19 and behavioral and mental health counseling services for teens. She added that parental consent was required for minors. She reported that there was no impact to the General Fund.

Mayor Nirenberg called upon the citizens registered to speak.

Jack M. Finger spoke in opposition to the program that provides contraceptives to teenagers which he feels promotes promiscuity.

Reiana Fernandez spoke in support of the initiative to prevent teen pregnancy and noted that she knew many teenagers who could use the service.

Patricia Fernandez spoke in support of the initiative to prevent teen pregnancy and stated that she had two teenagers of her own. She noted that many families could not afford the service on their own and could use the assistance.

Dr. Janet Realini stated that she was supportive of the initiative to prevent teen pregnancy. She spoke of the great progress that had been made thus far and noted that it should continue.

Vanessa Lopez spoke in support of the program and highlighted the benefits of contraception. She noted that parental approval was required for minors.

Patrick Von Dohlen stated that he was speaking on behalf of the San Antonio Family Association in opposition to the program and expressed concern with the safety of young females.

Councilmember Brockhouse stated that he pulled the item for transparency and asked if the funds were limited to the use of LARCs. Dr. Bridger replied that the funds were not limited to LARCs and could be used for any aspect of the comprehensive Teen Pregnancy Prevention Program. Councilmember Brockhouse asked the estimated number of teens that would receive counseling. Mario Martinez stated that they did not have an estimated number as there was not a baseline to compare to. Councilmember Brockhouse asked if they could

use more funds to educate teens and provide counseling. Dr. Bridger replied that 25% of the funding was being utilized for contraception and 75% was being used for education and counseling.

Councilmember Gonzales asked if education was the most effective way to address the issue. Dr. Bridger replied that it was difficult to determine the best solution but both education and contraceptives were effective methods.

Councilmember Viagran asked how the proposed Healthcare Reform Bill would affect these programs. Dr. Bridger replied that the latest version of the bill that she had seen allows insurers not to cover contraceptives. Councilmember Viagran thanked Dr. Realini and the females that spoke in support of the program.

Councilmember Pelaez noted that the United States had the most teen pregnancies among first world countries and that teen pregnancy prevention education and contraception helped to reduce the number of teen pregnancies. Councilmember Sandoval stated that this would have a great impact on community health and thanked the females that spoke. She noted the risks associated with teen pregnancies.

Councilmember Treviño thanked everyone for their work and noted that the program was evidence-based and supported by experts. Mayor Nirenberg added that the City Council makes decisions based on evidence and data.

Councilmember Gonzales moved to adopt the Ordinance for Item 51A. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Melissa Ramirez presented Item P-2 and stated that it would amend the North Central Neighborhoods Community Plan. She noted that staff and the Planning Commission recommended denial.

For Item Z-4, she stated that staff recommended denial while the Zoning Commission recommended approval. She reported that of 20 notices mailed; none were returned in favor and five in opposition. She added that the Monte Vista Terrace Neighborhood Association was in favor of the request.

Mayor Nirenberg exited the meeting and Mayor Pro Tem Pelaez presided.

Councilmember Treviño asked Jerry Arredondo if he was willing to amend his request to Medium Density. Mr. Arredondo confirmed that he would.

Councilmember Treviño moved to approve Items P-2 and Z-4 with a land use of Medium Density. Councilmember Shaw seconded the motion. The motion prevailed by the following

**Z-11.** ZONING CASE # Z2017185 S (Council District 6): An Ordinance amending the Zoning District Boundary from "C-2 AHOD" Commercial Airport Hazard Overlay District to "C-2 S AHOD" Commercial Airport Hazard Overlay District with Specific Use Authorization for a Bingo Parlor on 5,487.43 square feet out of NCB 18080, located at 8061 Culebra Road. Staff recommends Approval. Zoning Commission recommends Denial.

Melissa Ramirez presented Item Z-11 and stated that staff recommended approval while the Zoning Commission recommended denial. She reported that of 8 notices mailed; one was returned in favor and none in opposition. She added that staff had received a 123-signature petition of businesses and individuals in favor of the request.

Mayor Pro Tem Pelaez called upon the citizens registered to speak.

Kimberly Rogers spoke in support of the request and noted that she worked for a number of charities that would benefit from the bingo. She outlined the process she followed and noted that she had received a great amount of support.

Brenda Chapman stated that she served on the board of St. Jude's Ranch for Children which received proceeds from Circus Bingo and expressed support for the request.

Sandy Merrill, CEO of Guide Dogs of Texas expressed support for the request and spoke of the funding they received from the bingo.

Louann Williams stated that she used a Guide Dog and was supportive of Guide Dogs of Texas which would benefit from the bingo. She expressed support for the request.

Edward Harloe stated that his wife was the CEO of Guide Dogs of Texas and he was supportive of the request which would provide funding to the organization.

Shelly Chance, President and COO of Theater for Change, stated that she was supportive of the request noting that the bingo would provide funding for her organization.

Terri Orrender stated that she was an employee of Circus Bingo and supportive of the request.

Grace Hernandez representing Mujeres Hispanas Por Mejor Justicia spoke in support of the request and noted the great work of Circus Bingo.

Charles Christian stated that he was representing the Cowboy Breakfast in support of the request noting that they would provide funding to the organization.

Councilmember Brockhouse stated that there had been a great amount of misinformation provided and he was concerned with the great amount of bingo halls in the area. He provided an overview of the timeline of events noting that the Certificate of Occupancy was denied in May. Additionally, the Development Services Department issued a violation for work being performed without permits for electrical and plumbing a few days later. He added that he understood that the applicants had spent money but they should have followed the rules. He stated that they had already identified another location for a bingo one block away. He indicated that he would work with those charities that would be affected and noted that he would like to see other opportunities for the area.

Councilmember Brockhouse moved to deny Item Z-11. Councilmember Courage seconded the motion.

Councilmember Gonzales asked if there was a state or local limit on how many of a certain type of business could be in an area. Mrs. Ramirez responded that there was not a limit.

The motion to deny prevailed by the following vote:

Melissa Ramirez presented Item P-5 and stated that it would amend the San Antonio International Airport Vicinity Land Use Plan. She noted that staff and the Planning Commission recommended approval.

For Item Z-14, she stated that staff recommended approval with the following conditions: 1) Incorporate high-quality building materials into façade the building. Minimize or eliminate the use of metal siding; however chain-link with mesh screening shall be permitted as a fencing material; 2) Outside storage, service areas, mechanical equipment, and dumpsters should be screened from the view of the public right-of-way through the use of landscaping and approved fencing, to include chain-link with mesh screening; 3) Install heavy landscaping to minimize view of parking and storage areas, reduce amount of impervious ground cover, and enhance the public realm-particularly along the Naco-Perrin Boulevard and Burt Drive corridors; and 4) All signage should be designed to reduce clutter and contribute to a cohesive site. She reported that of 13 notices mailed; one was returned in favor and none in opposition.

Councilmember Perry moved to approve Items P-5 and Z-14 with the conditions read by Mrs. Ramirez. Councilmember Courage seconded the motion. The motion prevailed by the following vote:
