The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

PRESENT: 9 - Mayor Nirenberg, Treviño, Shaw, Viagran, Saldaña, Gonzales, Brockhouse, Sandoval, and Courage

ABSENT: 2 - Pelaez, and Perry

Mrs. Vacek announced that Councilmember Pelaez was attending a funeral out of town while Councilmember Perry was attending the Texas Municipal League Conference in Houston.

1. The Invocation was delivered by Pastor James P. Amerson, St. Paul United Methodist Church, guest of Councilmember William "Cruz" Shaw, District 2.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the City Council Special Sessions of August 22 - 23, 2017

Councilmember Courage moved to approve the Minutes for the City Council Special Sessions of August 22-23, 2017. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

POINTS OF PERSONAL PRIVILEGE

Mayor Nirenberg noted the passing of Mr. Robert Anguiano who was recently recognized at a City Council Meeting for his community efforts in District 3. Councilmember Viagran thanked the City Council for acknowledging Mr. Anguiano and expressed her condolences to his family. She led everyone in a moment of silence honoring Mr. Anguiano.

Councilmember Treviño recognized Sofia Lopez on her appointment to the Zoning Commission (Item 16D) and thanked Siboney Diaz Sanchez for her previous service. He highlighted the Alamo Street Pedestrian Lighting Project (Item 22).

ACTION ITEM FOR STAFF BRIEFING

City Clerk Vacek read the caption for Item 4:

4. An Ordinance authorizing the negotiation and execution of 48 professional services contracts for Civil Engineering Services, 14 professional services contracts for Architecture services and 45 professional services contracts for Landscape Architecture services, in an aggregate amount not-to-exceed \$58,000,000.00; the negotiation and execution of agreements with utility companies to accept reimbursement for utility work from respective utilities included in the contracts; and payment subject to the availability of funds in connection with the 2017-2022 General Obligation Bond Program and the 2018-2023 Capital Budget. [Peter Zaroni, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Mike Frisbie presented a power point regarding the 2017 Bond Program Mass Selection of Design Consultants. He reported that the Request for Qualifications (RFQ) was released on May 9, 2017. He stated that 180 Projects had been approved by the voters and provided an overview of the timeline for design and construction. He highlighted the lessons learned and refined approach to the 2017-2022 Bond Program to include partnerships, planning, innovation, and transparency. He noted that 105 of the 180 projects were part of the mass

selection process within the Civil Engineering, Architecture, and Landscape Architecture Categories. He mentioned that there were over 400 attendees at the Pre-Submittal Conference held on May 24, 2017. He outlined the recommendations which include 48 Civil Engineering Contracts, 14 Architecture Contracts, and 45 Landscape Architecture Contracts. He reported that there were 79 Primes and 247 Subcontractors noting that 92% of Primes and Subs were from the San Antonio Area. He added that there was an increase in Small, Minority, Women-owned prime participation, as well as African-American Business Enterprise (AABE) prime and subcontractors.

Mayor Nirenberg called upon the citizens registered to speak.

Tony Piazzzi representing Centro San Antonio spoke in support of the recommendations. He commended staff on the mass selection process.

Fernando Camarillo stated that he owned a local Civil Engineering Company and was supportive of the recommendations.

Linn Bobbitt, Executive Director of the Brackenridge Park Conservancy, spoke in support of the recommendations. She stated that the restoration of various historic properties would be transformational.

Jack M. Finger spoke in opposition to the recommendations noting that some of the firms were located in Bandera and Wilson Counties.

Councilmember Viagran thanked the voters for their approval of the Bond Program and asked of the 79 Prime Consultants referenced on Slide 22. Mr. Frisbie replied that the minority participation numbers did not equal to 79 as some were counted in multiple categories. Councilmember Viagran asked if TCI had a part in the safety and inspection of each project. Mr. Frisbie confirmed that they did.

Councilmember Treviño stated that this was a great opportunity to make an incredible impact for the city. He thanked TCI for their innovation in applying different design strategies and noted that he was pleased with the great participation of emerging small businesses. He highlighted the work with the Architecture, Construction, and Engineering (ACE) College Student Mentorship Program.

Councilmember Gonzales asked of the amount of the Bond Program provided by the private sector. Mr. Frisbie replied that 90% of design and construction would be provided by the private sector. Councilmember Gonzales asked if there was still an opportunity for small businesses to participate. Mr. Frisbie replied that there could be an opportunity if a Prime needed to add or replace a subconsultant but there was a formal process for same.

Councilmember Gonzales asked which projects would be implemented first. Mr. Frisbie replied that those that had been designed through previous funds were being implemented but the remainder would move forward due to the mass selection of design consultants.

Councilmember Shaw expressed his support for the great amount of small, minority-owned business participation and thanked staff for keeping the community engaged.

Councilmember Sandoval thanked everyone for their work on the Bond Program and asked of the local businesses versus area businesses. Mr. Frisbie explained that the city's definition of a local business included the San Antonio Metropolitan Statistical Area. He noted that 71% of the recommended consultants were in the City of San Antonio. Councilmember Sandoval asked how staff verified that firms were versed in National Association of City Transportation Officials (NACTO) Guidelines. Mr. Frisbie stated that they utilized a 100-point scale for various elements and looked at their experience with context-sensitive design.

Councilmember Courage thanked staff for their work and expressed support for establishing a Bond Oversight Commission. Mayor Nirenberg stated that he was pleased with the continued investment and improvements in San Antonio.

Councilmember Viagran moved to adopt the Ordinance for Item 4. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Yolanda Garza spoke in support of the amendments to the City Code regarding Animals (Item 14) noting the great concern with stray animals in her neighborhood.

Rita Braeutigam, District 4 Representative and Chair of the Animal Care Services (ACS) Board, spoke in support of the amendments to the City Code regarding Animals (Item 14). She noted that she had co-founded Alamo Rescue Friends.

Susan Beldon, District 9 Representative on the ACS Board, spoke in support of the amendments to the City Code regarding Animals (Item 14). She noted the great amount of input from the community and stakeholders.

Kathy Davis stated that she was the District 6 Representative on the ACS Board and also served as a Board Member for the Texas Humane Legislation Network (THLN). She noted that THLN applauded the amendments to the City Code regarding Animals (Item 14).

Denise Stallcup spoke in support of the amendment of Article 4 of the Unified Development Code relating to penalties for demolition without a permit (Item 15). She stated that the amendments would protect Historic Homes in older neighborhoods.

Leslie Provence, Founding Member and Vice-President of the Food Policy Council of San Antonio, spoke in support of the amendments to the City Code regarding Animals (Item 14).

Rhett Smith spoke in support of the grant funds for education and awareness about traffic safety and Vision Zero (Item 13).

Jack M. Finger spoke in opposition to the settlement of litigation (Item 19) and asked if the employee that committed discrimination would be held responsible for the payment. He stated that he was opposed to the amendments to the Legislative Program (Item 21).

Councilmember Sandoval thanked staff for their work on the amendments to Chapter 5 (Item 14) and stated that the rules were smart and innovative.

Art Reinhardt stated that staff was requesting authorization to accept \$166,400 in grant funds from the Texas Department of Transportation (TxDOT) for training and education to bring awareness for traffic safety and Vision Zero. He noted that the Traffic Training Education Campaign would include Vision Zero and Crash Report Training, Intersection Enforcement, Crash Analysis & Evaluation,

and Educational Brochures. He stated that there was a local match requirement of \$41,600 and that the program would be completed by September 2018. Councilmember Gonzales expressed her support and stated that it was a priority to reduce fatalities and serious injuries.

Councilmember Gonzales moved to adopt the Ordinance for Item 13. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Councilmember Treviño requested a brief presentation. Shanon Miller presented information regarding the penalties for demolition without a permit and protection of properties determined to be eligible for Historic Designation. She stated that a Council Consideration Request (CCR) had been submitted by Councilmember Treviño to review the current penalties and explore additional penalties for demolition without a permit. She noted that the goals were: 1) Disincentives for illegal work; 2) Encourage proper review channels; 3) Eliminate “overnight” demolition; and 4) Protection for significant and eligible properties. She provided an overview of the current demolition review process and penalties. She outlined the proposed Unified Development Code (UDC) amendments to include the reinforcement of Demolition Penalties and closing loopholes for eligible properties. She added that next steps would include developing a “Dismantling” Ordinance for properties over a certain age and that staff recommended approval.

Councilmember Treviño expressed his support and spoke of the importance of the Dismantling Ordinance due to the materials of Historic Homes that are no longer found. He asked how this policy would help Neighborhood Conservation Districts (NCD). Mrs. Miller replied that staff would notify Neighborhood Associations when there was a demolition requested in an NCD.

Councilmember Shaw thanked staff for their work and stated that the two strong Neighborhood Associations in District 2 were in support of the staff recommendations.

Councilmember Gonzales asked of the number of NCDs in the city. Mrs. Miller stated that there were less than 10 NCDs. Councilmember Gonzales asked if individuals purchasing a property in an NCD were notified of same. Mrs. Miller replied that it was reflected within the property's zoning information.

Councilmember Treviño moved to adopt the Ordinance for Item 15. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

25. City Manager's Report

CHARITABLE CAMPAIGN RESULTS

Mrs. Sculley reported that the City of San Antonio Employee Charitable Campaign concluded this week. She stated that every year, the city partners with United Way to give employees an opportunity to pledge a contribution to local, nonprofit organizations performing work in the community. She announced that for the 6th straight year, the City Organization has surpassed \$1 million in Employee Charitable Giving. She mentioned that the amount puts the City of San Antonio in the league of a handful of major private sector employers and remains the only \$1 million-plus campaign for a public sector agency. She stated that this year's campaign kicked off in August with an Employee Pep Rally on Main Plaza in which over 2,000 pounds of nonperishable items for the San Antonio Food Bank was collected. She thanked the employees that pledged a portion of their paycheck to the campaign. She added that a Pacesetter Organization Lunch would be hosted next week by United Way and the City of San Antonio was proud to be represented there once again.

Councilmember Treviño moved to approve Items P-1 and Z-1 with the following conditions: 1) An 8-foot sound wall along property lines adjacent to residential properties; 2) No temporary signage, streamers, or banners; 3) Downward facing lighting; 4) Type B Landscape Buffer along property line facing Fresno Street; 5) Gating to be installed along the egress points of the property and secured when closed; and 6) "One way" and "Left Turn Only" signs to be installed at the egress point along Fresno. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

ZONING CASE # Z2017220 (Council District 3): An Ordinance amending the Zoning District Boundary from "R-4 AHOD" Residential Single-Family Airport Hazard Overlay District to "RM-4 AHOD" Residential Mixed Airport Hazard Overlay District on Lots 4 and 58, Block 46, NCB 11076, located at 650 and 654 West Petaluma Boulevard. Staff and Zoning Commission recommend Approval.

Melissa Ramirez presented Item Z-6 and stated that staff and the Zoning Commission recommended approval. She reported that of 17 notices mailed; two were returned in favor and five in opposition. She added that the case would require nine votes for approval due to the opposition exceeding 20%.

Mayor Nirenberg called upon the citizens registered to speak.

Ernestina Torres stated that she lived across the street from the properties in question and was opposed to the request. She noted that there were already several rental units in the area and was concerned with the quality of tenants.

Yolanda Medina stated that she had lived in the neighborhood for over 40 years and was opposed to the request. She expressed concern with the quality of tenants and noted safety issues.

Councilmember Viagran stated that she had additional questions and moved to continue Item Z-6 until December 7, 2017. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Staff and Zoning Commission recommend Approval with Conditions, pending Plan Amendment. (Associated Plan Amendment 17061)

Melissa Ramirez presented Item P-3 and stated that it would amend the San Antonio International Airport Vicinity Land Use Plan. She reported that staff and the Planning Commission recommended approval. For Item Z-18, she reported that staff and the Zoning Commission recommended approval with the following conditions: 1) Hours of Operation are 10:00 am to 9:00 pm; and 2) Requires an eight-foot solid screen fence adjacent to residential uses. She stated that of 81 notices mailed; six were returned in favor and 18 in opposition.

Mayor Nirenberg called upon Mr. David E. Kehl to speak. David E. Kehl stated that he understood the case would be continued but noted that the property would not bear commercial zoning.

Councilmember Brockhouse moved to continue Items P-3 and Z-18 until November 2,

2017 on behalf of Councilmember Perry. Councilmember Courage seconded the motion. The motion prevailed by the following vote:
