The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

Mrs. Vacek announced that Councilmember Viagran was attending the US/ICOMOS World Heritage Preservation Leadership Forum and Benefit in Washington, D.C.

Mayor Nirenberg congratulated Councilmember Gonzales on the birth of a baby girl. Councilmember Gonzales thanked everyone for their warm wishes and stated that her daughter Celina was healthy and doing well.

1. The Invocation was delivered by Sister Consuelo Tovar, DC, Director, Mission Integration, Daughters of Charity Services, guest of Councilmember Rey Saldaña, District 4.

- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.

Councilmember Saldaña moved to approve the Minutes for the City Council Regular Meetings of October 4 5, 2017. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

#### POINTS OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized Frank Burney who spoke of the US Army All-American Bowl. He introduced Brigadier General Kevin Vereen, Deputy Commanding General Operations, U.S. Army Recruiting Command, who thanked the City Council for their support. He stated that the Army was proud and honored to host the All-American Bowl in San Antonio and thanked all of the individuals that had served in the military. Nate Seamon, Event Director of the All-American Games, thanked the City of San Antonio for their help to make the event a great success year after year. Mayor Nirenberg thanked everyone involved with the event and noted that two San Antonio High School Students would be playing in the game.

Councilmember Perry welcomed four undergraduate students and one faculty member from Kumamoto University in the Sister City of Kumamoto, Japan. He noted that they would be meeting with UTSA regarding graduate programs, as well as learning about U.S. protocol for natural disaster response. Professor Steven Sanyo thanked the City Council for the recognition and stated that they were pleased to be visiting San Antonio. Mayor Nirenberg welcomed them to San Antonio.

Councilmember Courage recognized former Councilmember Robert Marbut and his Honors Government Class from Northwest Vista College. A student addressed the City Council and stated that it was an honor to be present to see the inner workings of the City of San Antonio. Mayor Nirenberg welcomed them to the Council Meeting.

City Clerk Vacek read the caption for Item 14:

Mike Frisbie highlighted the improvements that would be made at Lincoln Park to include a splash pad, walkways, playgrounds, shade canopies, security lighting and Wi-Fi. He stated that \$1 million was funded from the 2017 Bond Program while another \$1 million was donated by Mr. Charles Butt. He noted that Phase I would include construction of a splash pad adjacent to the pool and sidewalks connecting to the neighborhood. He added that staff recommended approval of a construction contract with Davila Construction, Inc. in an amount not to exceed \$635,000.

Councilmember Shaw asked if there had been community input on the project. Xavier Urrutia replied that there had been public engagement to ensure the public had input. Councilmember Shaw asked when Wi-Fi access would be available. Mr. Urrutia replied that would be done during the second phase. Councilmember Shaw thanked all for their work and pleased that Davila Construction was awarded the contract as they were located in District 2.

Councilmember Shaw moved to adopt the Ordinance for Item 14. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

**15A.** An Ordinance authorizing the execution of a reimbursement agreement with Union Pacific Railroad Company to pay to the City fifty percent of the cost, or \$21,945.00, for the City's construction and installation of two roadway clearance height curtains on S. St. Mary's Street between Jacobs Street and W. Whittier Street near the UPRR bridge located at UPRR's Milepost 210.98 (DOT#1 764297T) in Council District 5.

**15B.** An Ordinance authorizing the execution of a reimbursement agreement with Union Pacific Railroad Company to pay to the City fifty percent of the cost, or \$5,906.00, for the City's installation of railroad crossing pavement marking refreshments on E. Mike Frisbie stated that staff was requesting authorization to execute two reimbursement agreements with Union Pacific Railroad Company to accept 50% of the cost for the City's construction and installation of two roadway clearance height curtains and railroad crossing pavement marking refreshments. He noted that the roadway clearance height curtains were needed as there had been 22 oversized vehicle strikes to the S. St. Mary's Street Railroad Bridge from 2015-2017. He provided an overview of the railroad crossing pavement markings that would be refreshed. He outlined the fiscal impact and mentioned that construction was scheduled for completion in March 2018.

Councilmember Shaw thanked everyone for their work on the railroad crossings and stated that he looked forward to additional conversations regarding railroads in the city.

Councilmember Gonzales stated that there had been issues with the St. Mary's Street Bridge for many years and asked why it had taken so long for a solution. Mr. Frisbie replied that they had to follow a design process and agreement with the railroad. Councilmember Gonzales asked if the trucks would be re-routed through the neighborhood if they did not have sufficient clearance. Mr. Frisbie replied that he would follow up. Councilmember Gonzales asked of potential issues with underpasses. Mr. Frisbie replied that they caused challenges during heavy storms as it was difficult to get water drained.

Councilmember Courage stated that he was concerned that the notification may not be loud enough for drivers. Mr. Frisbie replied that they were utilizing a Union Pacific Railroad best practice and had been tested and deployed in multiple states due to its effectiveness. Councilmember Shaw moved to adopt the Ordinances for Items 15A and 15B. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Sandoval commended the Metro Health Department for their work on HIV Prevention and noted that it was a serious concern in Bexar County.

Councilmember Shaw stated that it was important to address the issue and asked the City Councilmembers to help increase the number of individuals getting tested for HIV.

Councilmember Sandoval moved to adopt the Ordinance for Item 17. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 19:

Ordinance Ordinance 2017-05-25-0384 and Ordinance An amending No. 2017-08-17-0571 which authorized the submission of grant applications and acceptance of funds upon award, to the Office of the Governor, Criminal Justice Division, for the Texas Anti-Gang Program and the Rifle-Resistant Body Armor Grant Program. [Erik Walsh, Deputy City Manager; William P. McManus, Chief of Police]

Erik Walsh spoke of the Texas Anti-Gang Program noting that it was a multi-jurisdictional effort made up of local, state, and federal agencies that will operate out of the same facility. He noted that the City of San Antonio had applied to the State for the second year of funding. With regard to the Rifle-Resistant Body Armor Grant Program, Mr. Walsh stated that there was an opportunity for the San Antonio Police Department to receive a significant amount of money from the State to fund the purchase and replacement of body armor. He noted that the grants would be revised to include standard language that was inadvertently left out of both grant applications.

Councilmember Courage asked of the body armor and how many units would be purchased. Deputy Chief Jimmy Reyes replied that any first responder would receive body armor and the amount purchased would depend on the grant awarded.

Councilmember Saldaña spoke of the collaboration at the local, state, and federal levels and noted that problems could not be solved by one department.

Mayor Nirenberg expressed support and stated that he was pleased that the program would be getting underway.

Councilmember Shaw moved to adopt the Ordinance for Item 19. Councilmember Treviño seconded the motion.

City Clerk Vacek read the caption for Item 20:

An Ordinance authorizing the submission of an application to the US Department of Transportation for the Nationally Significant Freight and Highway Projects Infrastructure For Rebuilding America Grant Program in an amount of approximately \$35 million for the construction of the Zarzamora Street at Frio City Road Railroad Overpass Project in Council District 5. [Peter Zanoni, Deputy City Manager; Mike Frisbie, Director, Transportation & Capital Improvements]

Mike Frisbie stated that staff was requesting authorization to submit an application to the US Department of Transportation Infrastructure for Rebuilding America Grant Program for construction of Zarzamora Street at Frio City Road railroad overpass in Council District 5. He reported that the area was utilized by 16,000 vehicles a day with an average 25 trains

daily and average wait time of nearly 7 minutes. He highlighted the project benefits to include increased transit mobility and reliability. He stated that the award announcement would occur in the Spring/Summer 2018.

Mayor Nirenberg called upon the citizens registered to speak.

Allen Townsend, President of the Palm Heights Neighborhood Association, stated that they were supportive of an underpass which would be less disruptive to local businesses and residents in the area.

Diane Lang stated that she also lived in the area and was supportive of an underpass. She asked that there be more citizen input before finalizing the project.

Maria Velasquez stated that she lived very near the railroad tracks and was opposed to an overpass. She expressed concern that the neighborhood had not been included in discussions on the project.

Councilmember Gonzales recognized Roberto Escobedo, Past President of the Collins Garden Neighborhood Association. Mr. Escobedo stated that their association was supportive of an underpass because it would be less obstructive to the horizon and skyline.

Councilmember Gonzales thanked the citizens that spoke and stated that the project would be very impactful to the neighborhood. She noted that any option would be disruptive to the community and asked of the funding. Mr. Frisbie replied that there was a local match of \$10 million approved through the Bond Program, \$8 million from the Metropolitan Planning Organization (MPO), and were requesting a grant in the amount of \$17.5 million. He noted that there would be further opportunities to gather input on the project and design prior to construction.

Councilmember Pelaez asked if compliance review was necessary for the project. Mr. Frisbie replied that there was environmental due diligence that would be required. Councilmember Pelaez stated that he had traveled to Washington, D.C. to advocate for grant funding for this project and commended Councilmember Gonzales for her leadership.

Councilmember Saldaña stated that they had been working on said issue for many years and commended Councilmember Gonzales for her work. He noted that the first step was to identify funding and was pleased to support the grant request.

Mayor Nirenberg asked of the at-grade crossings that conflict with roadways. Mr. Frisbie replied that there were 240 throughout the city. Mayor Nirenberg spoke of the issues associated with same and the need to get freight out of the City of San Antonio. He noted

that this project would improve the quality of life for the community.

Councilmember Gonzales moved to adopt the Ordinance for Item 20. Councilmember Pelaez seconded the motion. The motion prevailed by the following vote:

**21.** An Ordinance amending the City Code regarding residency verification requirements for candidates for municipal election. [Leticia M. Vacek, City Clerk]

Councilmember Courage stated that he had brought the Council Consideration Request (CCR) forward due to a candidate in District 9 who submitted a fraudulent application. He noted that asking for supplemental documents when filing an application would set a higher bar to be able to determine if someone really resides in the district that they are running for.

City Clerk Vacek stated that Councilmember Courage's CCR had been presented before the Governance Council Committee on November 1st. She reported that in accordance with Texas Election Code and case law, as the City Clerk; she does not have the authority to determine residency. She stated that supplemental documentation in support of the sworn attestation of residency may be accepted with a candidate's filing paperwork and included on file with a candidate's application. She reported that the supplemental documentation provided would be subject to inspection or release through the Texas Open Records Act and would be redacted of any personal information as allowed by law. She provided an overview of the current qualification requirements to run for office. She stated that she met with Councilmember Courage and City Attorney Segovia to develop the recommendation to amend the City Code to request candidates filing for office include two of the following supplemental documents showing a current address with their application for candidacy:

- Valid voter registration certificate
- Copy of or original current utility bill
- Copy of or original personal bank statement
- Copy of or original government check
- Copy of or original paycheck

• Copy of or original government document with name and an address (original to be presented if it contains a photograph)

Mrs. Vacek stated that during the Governance Council Committee, it was recommended that changes to the current State Law regarding authority for residency enforcement and consequences be addressed through the next State Legislative Session.

Councilmember Courage thanked Mrs. Vacek and City Attorney Segovia for their work on the recommendations. He stated that producing the supplemental documents would not create a barrier to any legitimate candidate being able to file for any city office.

Councilmember Courage moved to adopt the Ordinance for Item 21. Councilmember Sandoval seconded the motion. The motion prevailed by the following vote:

She stated that Mr. Davis' artwork, titled "Your African and American History," will be used as the official artwork for the 2018 Martin Luther King, Jr. Celebration. She added the for winning the contest, Mr. Davis will receive public recognition as the creator of the 2018 Commemoration Artwork and the piece will be displayed at the Carver Community Cultural Center. She mentioned that the Selection Committee included Councilmember Shaw, MLK Commission Chair Nate Davis, Local Artist John Coleman, and staff from the Eastpoint Office and Department of Arts and Culture. She stated that since 1987, the City of San Antonio has celebrated the life and legacy of Dr. King with a series of annual events leading up to one of the largest marches in She noted that the 2018 March the country, with over 300,000 participants. and Commemorative Program would take place on Monday, January 15th at 10 am beginning in front of the MLK Academy School located at 3501 MLK Drive. She thanked the Eastpoint Office for staffing the MLK Commission and overseeing the March.

#### **ROCK N' ROLL MARATHON**

Mrs. Sculley reported that the 10th Annual Humana Rock 'N' Roll San Antonio Marathon and Half-Marathon would be held this weekend, December 2-3, 2017. She stated that more than 26,000 runners from all 50 states and 21 countries were expected to attend with 60% being females. She noted that 230 "Legacy Runners" were set to complete their 10th straight Humana Rock 'N' Roll San Antonio Marathon and Half-Marathon. She reported that last year, the event helped generate more than \$32 million in economic impact and 20,500 hotel room nights. She stated that in the 10 years of the event, the community has further embraced fitness with approximately 250,000 San Antonians having participated. She thanked the sponsors to include Humana, San Antonio Sports, and The Competitor Group.
