The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

City Clerk Vacek read the caption for Item 20:

Mayor Nirenberg and Councilmember Saldaña recused themselves from voting on Item 20 by exiting the Council Chambers and noting they submitted the recusal forms to the City Clerk.

Councilmember Courage moved to adopt the Ordinance for Item 20. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

INDIVIDUAL ITEMS FOR STAFF BRIEFING

Items 4A and 4B were addressed jointly. City Clerk Vacek read the captions for Item 4A and 4B:

4. Approval of the following items related to the San Antonio Public Safety Radio System: [Erik Walsh, Deputy City Manager; Ben Gorzell, Chief Financial Officer]

4A. Ordinance authorizing a contract with Dailey and Wells Communications, Inc., for the purchase and commissioning of a Phase II Project 25 (P25) public safety radio system for a planned initial capital value of up to \$80,695,423 and ongoing maintenance and support for 15 years following full acceptance for a planned total value of \$27,255,136, to be funded by the City of San Antonio, Bexar County, and CPS Energy.

4B. Ordinance approving an Interlocal Agreement between the City of San Antonio, CPS Energy and Bexar County for Ownership and Management of a Public Safety Radio System.

Erik Walsh provided an overview of the San Antonio Public Safety Radio System. He highlighted the benefits of a Regional System, project timeline, and members of the Executive Evaluation and Technical Advisory Committees. He outlined the Request for Proposals (RFP) Evaluation Criteria and spoke to each of the two vendors' proposed plan, experience, background, & qualifications. He presented the scoring matrix in which Dailey and Wells ranked Number 1. He stated the key contract terms to include a 42-month timeline, pricing, project protections, and Fire Radios. He mentioned the Interlocal Agreement among the City of San Antonio, Bexar County, and CPS Energy. Lastly, he stated that staff recommended approval of the Vendor Contract with Dailey and Wells Communications, Inc. and the Interlocal Agreement with Bexar County and CPS Energy.

Mayor Nirenberg called upon the citizens registered to speak.

Chris Martinez, President of Central Electric, spoke of how his father started the company and thanked First Responders for their work. He noted that he had partnered with Motorola and asked the City Council to support their proposal.

Claudia Rodriguez, Corporate Vice President for Motorola, spoke of their partnership with Central Electric and noted their integrity, work ethic, and technical expertise.

Richard Wells, Owner of Dailey and Wells Communications, Inc., stated that he had established the local business in 1972. He noted that they had grown to be one of the largest public safety integrators for Harris Corporation and asked the City Council to support their proposal.

Nino DiCosmo, President of Harris Corporation, spoke in support of the Dailey and Wells Communications, Inc. proposal. He stated that they were proud to partner with Dailey and Wells and noted their past experiences in working together.

Ernest Martinez of Central Electric spoke in support of their proposal.

Ernest Mora stated that he was pleased to speak in support of Central Electric.

Flavio Vilches stated that he had worked for Central Electric since 2005 as an Assistant Engineer and spoke in support of their proposal.

Arturo Casarez stated that he had worked with Central Electric since 2010 and was supportive of their proposal.

Rod Jones stated that he had been with Central Electric for seven years and was supportive of their proposal.

Danny Ibarra stated that he was supportive of Central Electric.

Ramiro Cavazos, President and CEO of the San Antonio Hispanic Chamber of Commerce, spoke in support of Central Electric noting that they had been members of the Chamber for more than 10 years.

Gabriel Lara stated that he was a Retired Firefighter and asked the City Council to gather feedback from First Responders before making a decision.

Dale Schumaker, Vice-President of Intertech Resources, stated that they were subcontractors for Central Electric and supportive of their proposal.

Roy Terracina spoke of his background with numerous organizations and stated that he had known Chris Martinez for many years. He expressed support for Central Electric's proposal.

Manuel Mora stated that he was a Retired Law Enforcement Officer that had served 34 years at the Local, State, and Federal Levels. He noted that he used Motorola Devices and asked the City Council to gather feedback from those that would use the radios.

Jack Vexler stated that he was part of a family business that had worked with Central Electric for many decades. He expressed support for their proposal.

Ron Willbanks of CPS Energy stated that they were pleased to partner with the City of San Antonio and Bexar County on the Public Safety Radio System. He noted that there had been a fair process and he was supportive of the staff recommendation.

Jack M. Finger spoke in opposition to the staff recommendation and asked how smaller companies could get the experience they needed to be competitive.

Dale Chapman representing Central Electric spoke in support of their proposal and stated that they were the only vendor that had deployed Phase II Project 25 (P25) Technology.

Mayor Nirenberg thanked everyone for their work on this critically important contract. He stated that there were two local success stories but felt the process was sound and would support the staff recommendation.

Councilmember Viagran thanked everyone for their work on the process. She noted that although it had been a long process; she was concerned that the City Council had only received a great amount of information on the selection the previous week. She asked of the original contract terms from 1999. Mr. Walsh replied that he did not have that information but would provide it to the City Council. Councilmember Viagran asked of the guarantee of interoperability for Fire Department Radios. Mr. Walsh responded that they would test various products and all would be required to operate on a P25 System. He added that they would select the device that worked best for them and that the City of San Antonio would still enjoy the guarantees in the contract today.

Councilmember Viagran stated that she still had many questions that needed to be answered and moved to continue Items 4A and 4B until March 1, 2018. Councilmember Gonzales seconded the motion.

Councilmember Shaw spoke of the importance of the contract and stated that the process was fair. He commended Chris Martinez and Central Electric for their work noting that it was a great accomplishment to have gotten this far. He asked if anything had changed during the process. Mr. Walsh replied that they added parallel negotiations prior to scoring but it did not affect the scoring of either of the vendors because the Evaluation Committee did not have access to that information until scoring was complete. Councilmember Shaw asked if the vendors had the ability to ask questions regarding the RFP. Mr. Walsh confirmed that they did. Councilmember Shaw asked if the Fire and Police Department Members of the Executive Committee were comfortable with the recommendation. Deputy Fire Chief Vance Meade and Assistant Police Chief Anthony Treviño each confirmed that they were comfortable with the recommendation.

Councilmember Shaw moved to adopt the Ordinances for Items 4A and 4B. Councilmember Treviño seconded the motion.

Councilmember Perry asked of savings based on the partner entities. Mr. Walsh replied that they estimated savings between \$48-50 million in capital costs among all three entities, with \$5-8 million of that amount being saved by the City of San Antonio. Councilmember Perry asked if the ILA had been signed by Bexar County. Mr. Walsh stated that the Bexar County Commissioners Court had approved the ILA but the document had not yet been signed. Attorney Segovia added that Bexar County was fully committed to sign the ILA if it was approved by the City Council. Councilmember Perry stated that a fair process had been followed and he was supportive of the staff recommendation.

Councilmember Treviño stated that he was pleased that both vendors were local success stories and asked if there had been a fair process. Mr. Walsh replied that there had been a fair process and that staff had the experts necessary to make the best recommendation. Councilmember Treviño stated that part of the goal of the City Council was to encourage more competition on complex projects. He thanked everyone involved and stated that he was supportive of the staff recommendation.

Councilmember Gonzales stated that due to time constraints; she had asked Councilmember Saldaña to ask some technical questions on her behalf. She noted that she had seconded the motion to continue the item if others had questions that still needed to be answered. However, she added that she was inclined to support the staff recommendation because there had been a thorough process.

Councilmember Saldaña called the question regarding the motion for a continuance.

The motion to continue by Councilmember Viagran failed by the following vote:

AYE: 3 - Viagran, Gonzales, and Sandoval

NAY: 8 - Mayor Nirenberg, Treviño, Shaw, Saldaña, Brockhouse, Pelaez, Courage, and Perry

Mayor Nirenberg and Councilmember Gonzales exited the meeting at this time to attend the All Mexico-US Sister Cities Mayors' Summit. Mayor Pro Tem Brockhouse presided over the meeting.

Councilmember Saldaña asked of cyber security threats and risk assessments that have been performed by Dailey and Wells. Mr. Richard Wells replied that the contract was specific to ensure that all of their operating software, patches, updates, and security mechanisms are continually updated. He confirmed that there had not been any security threats on the Harris System. Councilmember Saldaña asked of the supply chain for replacement parts. Mr. Wells stated that the RFP required a guarantee of parts availability after end life over the life of the contract. Councilmember Saldaña stated that he was relying on the expertise of the Technical Advisory Committee and would support the staff recommendation.

Councilmember Courage asked of batteries falling out of Harris Radios that were dropped during testing. Kevin Goodwin stated that the nature of the testing allows multiple samples of the same radio and while there were some cases of the battery coming out of the device; the device was deemed to perform adequately per the specifications. Mr. Wells confirmed that they had identified a fallacy in a clip in the manufacturing process that had been corrected.

Councilmember Courage asked if First Responders could be tracked through the Harris Radio System. Mr. Goodwin confirmed that they could. Councilmember Courage stated that there had been an exhaustive evaluation process and he felt comfortable supporting the staff recommendation.

Councilmember Sandoval thanked everyone involved in the process and both vendors for their responsiveness and investment. She stated that she was comfortable with the process and would support the staff recommendation.

Councilmember Pelaez asked if the vendors were able to see each other's Best and Final Offers. Mr. Walsh confirmed that they could not. Councilmember Pelaez asked if Firefighter Scott Deem had lost his life due to a radio failure. Chief Hood confirmed that was not the case.

Mayor Pro Tem Brockhouse spoke of the importance of protecting First Responders and stated that he hoped to address the issue of Fire Radios sooner than 2019. He noted that he was impressed that Central Electric was one of the top two vendors and commended them for their work. He added that he was pleased with the process and would support the staff recommendation.

Debbie Racca-Sittre presented an overview of the Arts Agency Funding Guidelines. She outlined the Cul-TU-Art Plan, a coordinated planning document that identifies strategies for six focus areas. She noted that the Plan was developed in coordination with the San Antonio Arts Commission, the community, and stakeholders. She mentioned the Hotel Occupancy Tax (HOT) Funding Allocation in which 15% was utilized for the Department Staff & Initiatives (6%) and Arts Agencies (9%). She spoke to the Arts Agency Funding Policy Changes which include Cultural Specific Support to preserve and promote women and

minority cultures. She highlighted the Base Operational change, requirements, and capacity building.

Mayor Pro Tem Brockhouse called upon the citizens registered to speak.

George Cisneros spoke in support of the funding guidelines noting that they were a step in the right direction.

John A. Toohey, Executive Director of Arts San Antonio, expressed support for the funding guidelines. He commended staff for soliciting input from the community and stakeholders.

Graciela Sanchez, Malena Gonzalez, and Susanna Segura representing the Esperanza Center addressed the City Council in support of the funding guidelines. Ms. Sanchez spoke of the many artists that had been nurtured by the Esperanza Center and asked the City Council to recognize the importance of Latino-Focused Cultural Arts Organizations.

Ed Conroy stated that he was speaking on behalf of the Southwest School of Art in support of the funding guidelines.

Elias Flores, III stated that he was a Senior Student at Say Sí and supportive of the funding guidelines.

Councilmember Saldaña thanked everyone for their work and expressed his support for the funding guidelines. He asked of the funding allocated for the Arts. City Manager Sculley stated that it was allocated through Council Policy with 15% of the HOT allocated to staff and agency funding.

Councilmember Pelaez spoke of the need to hold organizations accountable and asked staff to be authentic in the enforcement of the policies.

Councilmember Perry asked of the term "Base Operational." Mrs. Racca-Sittre replied that it meant that an organization's operations would be funded and not a specific program. Councilmember Perry noted concern with the 25% increase in Base Operational funding and that there were no programs funded in District 10.

Councilmember Courage expressed his support but noted the lack of art performances and visual art in the Downtown Area. Councilmember Treviño stated that they would share the schedule of events in the Downtown Area and that staff was working to enhance same. Councilmember Courage recommended that they promote street performers in the Downtown Area and noted that he would work to encourage more cultural art initiatives in District 9.

Councilmember Sandoval thanked everyone for their work and recognized the members of the art community that were present. She asked of the resources available to arts agencies that had been in existence for less than three years. Mrs. Racca-Sittre replied that there were quite a few organizations that did not receive city funding and survived off their own donor base. Councilmember Sandoval stated that she was pleased with the extensive public process. She requested to see the policy for how lease resources are distributed among arts organizations.

Councilmember Treviño spoke of the need for arts throughout the city and thanked everyone for their work.

Councilmember Perry asked if cultural organizations such as the German and French Clubs were funded. Mrs. Racca-Sittre replied that they were not but they were welcome to apply for funding.

Mayor Pro Tem Brockhouse thanked staff for their work.

Councilmember Saldaña moved to adopt the Ordinance for Item 18. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

24. City Manager's Report

SA TO DC TRIP

Mrs. Sculley reported that the 40th Annual SA to DC Trip sponsored by the Chambers of Commerce occurred two weeks ago. She stated that Mayor Nirenberg led the largest delegation from the City of San Antonio. She noted that SA to DC was the city's opportunity to advocate for issues important to San Antonio. She spoke of the various meetings held and mentioned that staff was reviewing the President's Proposed Budget and

Infrastructure Plan to identify potential impacts to the city. She added that it was a busy and productive trip and was grateful for the excellent participation by the City Council.

"CONFLUENCE: ART AT THE CONVENTION CENTER"

Mrs. Sculley reported that on February 1st, the city celebrated the opening of "Confluence: Art at the Convention Center." She stated that the newly-expanded art exhibit at the Convention Center features existing and new artwork that celebrates San Antonio's Artistic and Cultural Heritage in commemoration of the City's Tricentennial. She noted that the permanent exhibit features pieces by 48 Artists, more than half of whom are San Antonio Artists. She mentioned that also on display at the Convention Center was a temporary mini-exhibit of vintage photographs commemorating the 50th Anniversary of Hemisfair '68. She stated that the mini-exhibit was curated by San Antonio Artist and Graphic Designer Rigoberto Luna and developed with guidance from the UTSA Libraries Special Collection and the McNay Art Museum.

FLU REPORT

Mrs. Sculley stated that this had been a particularly tough flu season and that the Metro Health Department had developed a new report to share with the community called "The Bexar Influenza Surveillance Report." She noted that the report provided the current flu statistics and critical information about the flu in San Antonio. She presented a slide showing local flu activity since 2014 which was higher but noted that there were still many more months to the current flu season. She indicated that Metro Health would continue to monitor the flu situation and disseminate the report on a weekly basis.

Mayor Pro Tem Brockhouse recessed the meeting at 1:35 pm to break for lunch. He announced that the meeting would resume at 2:15 pm for Zoning.
